SENATE BILL No. 799

January 30, 2018, Introduced by Senators PROOS, COLBECK, HANSEN, KNEZEK, BOOHER, PAVLOV, BRANDENBURG, GREGORY, SCHUITMAKER, KNOLLENBERG and HILDENBRAND and referred to the Committee on Appropriations.

A bill to amend 1984 PA 431, entitled "The management and budget act,"

by amending section 367b (MCL 18.1367b), as amended by 2011 PA 47.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 367b. (1) A revenue estimating conference shall be held in the second week of January and in the third week in May of each year, and as otherwise provided in this act.
 - (2) The principals of the conference shall be the state budget director or the state treasurer, the director of the senate fiscal agency, and the director of the house fiscal agency, or their respective designees.
 - (3) The conference shall establish an official economic forecast of major variables of the national and state economies.

 The conference shall also establish a forecast of anticipated state

- 3 (b) State sales tax collections.

- 8 (g) Total school aid fund revenues.

- 19 (4) The conference's official forecast of economic and revenue
- 20 variables shall be determined by consensus among the principals.
- 21 (5) The forecasts required by this section shall be for the
- 22 fiscal year in which the conference is being held and the next 2
- 23 ensuing fiscal years. The conference shall also forecast general
- 24 fund/general purpose revenue trend line projections and school aid
- 25 fund revenue trend line projections for the next 2 ensuing fiscal
- 26 years.
- 27 (6) The May revenue estimating conference shall establish

- 1 expenditure forecasts for medicaid expenditures and for human
- 2 services caseloads and expenditures for the fiscal year in which
- 3 the conference is being held and the next 2 ensuing fiscal years.
- 4 (7) The official conference forecasts of revenues and
- 5 expenditures shall be based upon the assumption that the current
- 6 law and current administrative procedures will remain in effect for
- 7 the forecast period.
