- 5 (B) PERFORM SURGICAL PROCEDURES EXCEPT, SUBJECT TO SECTION
- 6 18623(F), MINOR OFFICE PROCEDURES.
- 7 (C) ENGAGE IN THE PRACTICE OF OR CLAIM TO ENGAGE IN THE
- 8 PRACTICE OF ANY OTHER HEALTH PROFESSION, INCLUDING, BUT NOT LIMITED
- 9 TO, PERFORMING CHIROPRACTIC ADJUSTMENTS, UNLESS LICENSED TO ENGAGE
- 10 IN THAT HEALTH PROFESSION UNDER THIS ARTICLE.
- 11 (D) USE GENERAL OR SPINAL ANESTHETICS.
- 12 (E) ADMINISTER IONIZING RADIOACTIVE SUBSTANCES FOR THERAPEUTIC
- 13 PURPOSES.
- 14 (F) PERFORM SURGICAL PROCEDURES USING A LASER DEVICE.
- 15 (G) PERFORM SURGICAL PROCEDURES INVOLVING THE EYE, EAR,
- 16 TENDONS, NERVES, VEINS, OR ARTERIES.
- 17 SEC. 18619. THE DEPARTMENT SHALL ESTABLISH PROCEDURES TO
- 18 GOVERN MATTERS, DIRECTLY OR INDIRECTLY, INVOLVING ANY INDIVIDUAL
- 19 WHO IS RELATED TO AN EMPLOYEE OR AGENT OF THE DEPARTMENT IN ANY WAY

- 20 NATUROPATHIC PHYSICIAN WHO HAS GRADUATED FROM AN APPROVED
- 21 NATUROPATHIC MEDICAL PROGRAM THAT INCLUDED MINOR OFFICE PROCEDURES
- 22 AS PART OF ITS CURRICULUM OR WHO HAS UP-TO-DATE CERTIFICATION OF
- 23 EQUIVALENT TRAINING, AS DETERMINED BY THE BOARD, IF HE OR SHE
- 24 GRADUATED FROM AN APPROVED NATUROPATHIC MEDICAL PROGRAM THAT DID

- 1 NATUROPATHIC MEDICAL PROGRAM THAT INCLUDED PHARMACOLOGY AS PART OF
- 2 ITS CURRICULUM OR WHO HAS UP-TO-DATE CERTIFICATION OF EQUIVALENT
- 3 TRAINING, AS DETERMINED BY THE BOARD, IF HE OR SHE GRADUATED FROM
- 4 AN APPROVED NATUROPATHIC MEDICAL PROGRAM THAT DID NOT INCLUDE
- 5 PHARMACOLOGY AS PART OF THE CURRICULUM.
- 6 SEC. 18625. (1) THE NATUROPATHIC FORMULARY COUNCIL IS CREATED.
- 7 THE FORMULARY COUNCIL IS SEPARATE AND DISTINCT FROM THE BOARD AND
- 8 IS COMPOSED OF 5 MEMBERS, AS FOLLOWS:
- 9 (A) TWO NATUROPATHIC PHYSICIANS APPOINTED BY THE BOARD.
- 10 (B) TWO PHARMACISTS WHO ARE LICENSED UNDER PART 177, APPOINTED
- 11 BY THE BOARD FROM A LIST OF NOMINEES PROVIDED BY THE MICHIGAN BOARD

- 13 (C) ONE PHYSICIAN WHO IS LICENSED UNDER PART 170 OR 175. THE
- 14 MICHIGAN BOARD OF MEDICINE AND THE MICHIGAN BOARD OF OSTEOPATHIC
- 15 MEDICINE AND SURGERY MAY EACH PROVIDE A LIST OF NOMINEES FOR
- 16 PURPOSES OF THIS SUBDIVISION, AND THE BOARD SHALL APPOINT THIS
- 17 MEMBER FROM 1 OF THOSE LISTS.
- 18 (2) THE NATUROPATHIC FORMULARY COUNCIL SHALL ESTABLISH A
- 19 NATUROPATHIC FORMULARY FOR USE BY NATUROPATHIC PHYSICIANS. WHEN IT
- 20 ADOPTS OR REVISES THE FORMULARY, THE FORMULARY COUNCIL SHALL
- 21 IMMEDIATELY TRANSMIT THE FORMULARY TO THE BOARD. THE BOARD SHALL

- 11 REGULATIONS IN REGARD TO THE CONTROL OF CONTAGIOUS AND INFECTIOUS
- 12 DISEASES, THE REPORTING OF BIRTHS AND DEATHS, AND ANY AND ALL OTHER
- 13 MATTERS PERTAINING TO THE PUBLIC HEALTH IN THE SAME MANNER AS IS
- 14 REQUIRED OF OTHER HEALTH PROFESSIONALS UNDER THIS CODE. A VIOLATION
- 15 OF ANY STATE, COUNTY, OR MUNICIPAL RULE, ORDINANCE, OR REGULATION
- 16 DESCRIBED IN THIS SECTION IS CONSIDERED A VIOLATION OF THIS CODE
- 17 SUBJECT TO THE INVESTIGATION AND SANCTION PROVISIONS OF SECTIONS
- 18 16221 AND 16226.
- 19 SEC. 18631. EACH LICENSE GRANTED OR RENEWED UNDER THIS PART
- 20 EXPIRES 4 YEARS FOLLOWING THE DATE IT WAS GRANTED OR LAST RENEWED.
- 21 SEC. 18633. THIS PART DOES NOT REQUIRE NEW OR ADDITIONAL THIRD
- 22 PARTY REIMBURSEMENT OR MANDATED WORKER'S COMPENSATION BENEFITS FOR
- 23 SERVICES RENDERED BY AN INDIVIDUAL WHO IS LICENSED UNDER THIS PART.
- 24 Enacting section 1. This amendatory act takes effect 90 days
- 25 after the date it is enacted into law.
