by amending section 1284b (MCL 380.1284b), as amended by 2006 PA 235.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1284b. (1) Until subsection (2) applies to the school
- 2 district, public school academy, or intermediate school district,
- 3 the board of a school district or intermediate school district or
- 4 board of directors of a public school academy shall ensure that the
- 5 district's or public school academy's schools are not in session on
- 6 the Friday before Labor day.DAY.
- 7 (2) Except as otherwise provided in this section, the board of
 - a school district or intermediate school district or board of

- 3 before Labor day.DAY.
- 4 (3) If a collective bargaining agreement that provides a
- 5 complete school calendar is in effect for employees of a school

- 7 of the effective date of the amendatory act that added subsection
- 8 (2), and if that school calendar is not in compliance with
- 9 subsection (2), then subsection (2) does not apply to that school

- 1 DISTRICT, OR PUBLIC SCHOOL ACADEMY NOTIFIES THE DEPARTMENT, IN A

- 2 (8) As used in this section, "Labor day"DAY" means the first

- 5 after the date it is enacted into law.
