- (B) "ENDOWMENT FUND" MEANS THE MICHIGAN STATE PARKS ENDOWMENT
- FUND ESTABLISHED IN SECTION 35A OF ARTICLE IX OF THE STATE
- CONSTITUTION OF 1963 AND PROVIDED FOR IN SECTION 74119.
- (C) <del>(b)</del> "Improvement program" means the construction,
