

SENATE BILL No. 990

May 10, 2018, Introduced by Senator O'BRIEN and referred to the Committee on Education.

A bill to amend 1976 PA 451, entitled
"The revised school code,"
(MCL 380.1 to 380.1852) by adding section 1264.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 1264. (1) A SCHOOL DISTRICT, INTERMEDIATE SCHOOL
2 DISTRICT, OR PUBLIC SCHOOL ACADEMY SHALL NOT COMMENCE THE
3 CONSTRUCTION OF A NEW SCHOOL BUILDING OR THE MAJOR RENOVATION OF AN
4 EXISTING SCHOOL BUILDING UNLESS BOTH OF THE FOLLOWING ARE MET:

5 (A) THE SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR
6 PUBLIC SCHOOL ACADEMY CONSULTS ON THE PLANS FOR THE CONSTRUCTION OF
7 A NEW SCHOOL BUILDING OR THE MAJOR RENOVATION OF AN EXISTING SCHOOL
8 WITH THE LOCAL LAW ENFORCEMENT AGENCY THAT HAS JURISDICTION OVER
9 THE MUNICIPALITY IN WHICH THE GREATEST NUMBER OF PUPILS ENROLLED IN
10 THE SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL
11 ACADEMY RESIDE.

1 (B) AFTER CONSULTING WITH A LOCAL LAW ENFORCEMENT AGENCY UNDER
2 SUBDIVISION (A), THE BOARD OF THE SCHOOL DISTRICT OR INTERMEDIATE
3 SCHOOL DISTRICT OR THE BOARD OF DIRECTORS OF THE PUBLIC SCHOOL
4 ACADEMY ADOPTS PLANS FOR THE CONSTRUCTION OF A NEW SCHOOL BUILDING
5 OR THE MAJOR RENOVATION OF AN EXISTING SCHOOL BY A MAJORITY VOTE OF
6 THE MEMBERS SERVING ON THE BOARD OR BOARD OF DIRECTORS AT A PUBLIC
7 MEETING OF THE BOARD OR BOARD OF DIRECTORS HELD IN COMPLIANCE WITH
8 THE OPEN MEETINGS ACT, 1976 PA 267, MCL 15.261 TO 15.275.

9 (2) AS USED IN THIS SECTION, "SCHOOL BUILDING" MEANS EITHER OF
10 THE FOLLOWING:

11 (A) A BUILDING INTENDED TO BE USED TO PROVIDE INSTRUCTION FOR
12 PUPILS.

13 (B) A RECREATIONAL OR ATHLETIC STRUCTURE OR FIELD INTENDED TO
14 BE USED BY PUPILS.

15 Enacting section 1. This amendatory act takes effect 90 days
16 after the date it is enacted into law.
