## **SENATE BILL No. 1033**

A bill to amend 1978 PA 368, entitled "Public health code,"

(MCL 333.1101 to 333.25211) by adding section 21517.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 21517. (1) THIS SUBSECTION APPLIES BEGINNING 180 DAYS
- 2 AFTER THE EFFECTIVE DATE OF THE AMENDATORY ACT THAT ADDED THIS
- 3 SECTION. IF A HOSPITAL ACCEPTS PAYMENT OR REIMBURSEMENT FROM A
- 4 HEALTH INSURER AND THE HOSPITAL USES A CHARGE DESCRIPTION MASTER,
- 5 THE HOSPITAL SHALL MAKE ITS CHARGE DESCRIPTION MASTER AVAILABLE BY
  - POSTING AN ELECTRONIC COPY OF THE CHARGE DESCRIPTION MASTER ON THE
- 7 HOSPITAL'S INTERNET WEBSITE. IF THE HOSPITAL HAS NO WEBSITE, IT
  - SHALL MAKE A WRITTEN OR ELECTRONIC COPY OF THE CHARGE DESCRIPTION
- MASTER AVAILABLE AT THE HOSPITAL LOCATION. A HOSPITAL SHALL ALSO
- 10 POST A CLEAR AND CONSPICUOUS NOTICE IN ITS EMERGENCY DEPARTMENT, IF
- 11 ANY, ADMISSIONS OFFICE, AND BILLING OFFICE INFORMING PATIENTS THAT

- 1 THE HOSPITAL'S CHARGE DESCRIPTION MASTER IS AVAILABLE IN THE MANNER

- 3 (2) A HOSPITAL SHALL NOT ENTER INTO A CONTRACT THAT PREVENTS
- 4 IT FROM MAKING ITS CHARGE DESCRIPTION MASTER AVAILABLE AS REQUIRED
- 5 UNDER SUBSECTION (1).
- 6 (3) THE DEPARTMENT OF LICENSING AND REGULATORY AFFAIRS MAY
- 7 IMPOSE AN ADMINISTRATIVE FINE OF UP TO \$1,000.00 PER DAY FOR A
- 8 VIOLATION OF THIS SECTION.
- 9 (4) AS USED IN THIS SECTION, "CHARGE DESCRIPTION MASTER" MEANS
- 10 A UNIFORM SCHEDULE OF CHARGES REPRESENTED BY THE HOSPITAL AS ITS
- 11 GROSS BILLED CHARGE FOR A GIVEN SERVICE OR ITEM, REGARDLESS OF
- 12 PAYER TYPE.
- 13 Enacting section 1. This amendatory act takes effect 90 days
- 14 after the date it is enacted into law.
- 15 Enacting section 2. This amendatory act does not take effect
- 16 unless Senate Bill No. 966.
