## SENATE BILL No. 1044

June 6, 2018, Introduced by Senator JONES and referred to the Committee on Government Operations.

A bill to amend 1927 PA 372, entitled

"An act to regulate and license the selling, purchasing, possessing, and carrying of certain firearms, gas ejecting devices, and electro-muscular disruption devices; to prohibit the buying, selling, or carrying of certain firearms, gas ejecting devices, and electro-muscular disruption devices without a license or other authorization; to provide for the forfeiture of firearms and electro-muscular disruption devices under certain circumstances; to provide for penalties and remedies; to provide immunity from civil liability under certain circumstances; to prescribe the powers and duties of certain state and local agencies; to prohibit certain conduct against individuals who apply for or receive a license to carry a concealed pistol; to make appropriations; to prescribe certain conditions for the appropriations; and to repeal all acts and parts of acts inconsistent with this act,"

(MCL 28.421 to 28.435) by adding section 2c.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

SEC. 2C. (1) EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION (2), A

RECOGNIZED TARGET RANGE OR SHOOTING FACILITY SHALL NOT RENT, LEASE,

- 1 OR LOAN A FIREARM TO AN INDIVIDUAL UNLESS THE TARGET RANGE OR
- 2 SHOOTING FACILITY HAS VERIFIED 1 OF THE FOLLOWING:
- 3 (A) THAT THE INDIVIDUAL IS NOT PROHIBITED UNDER FEDERAL LAW
- 4 FROM POSSESSING A FIREARM BY PERFORMING A BACKGROUND CHECK THROUGH
- 5 THE FEDERAL NATIONAL INSTANT CRIMINAL BACKGROUND CHECK SYSTEM.
- 6 (B) THAT THE INDIVIDUAL IS LICENSED TO CARRY A CONCEALED
- 7 PISTOL UNDER SECTION 5B.
- 8 (C) THAT THE INDIVIDUAL HAS A VALID LICENSE ISSUED UNDER
- 9 SECTION 2.
- 10 (2) A TARGET RANGE OR SHOOTING FACILITY MAY RENT, LEASE, OR
- 11 LOAN A FIREARM TO AN INDIVIDUAL WITHOUT COMPLYING WITH SUBSECTION
- 12 (1) IF EITHER OF THE FOLLOWING APPLY:
- 13 (A) THE INDIVIDUAL POSSESSES THE FIREARM FOR THE PURPOSE OF
- 14 INSTRUCTION IN THE SAFE USE OF A FIREARM DURING A GUN SAFETY OR
- 15 TRAINING CLASS, AND THE INDIVIDUAL IS UNDER THE DIRECT SUPERVISION
- 16 OF THE INSTRUCTOR OF THAT GUN SAFETY OR TRAINING CLASS.
- 17 (B) THE INDIVIDUAL IS UNDER THE DIRECT SUPERVISION OF A RANGE
- 18 MASTER FOR THE DURATION THAT INDIVIDUAL IS RENTING, LEASING, OR
- 19 BORROWING A FIREARM AT THE TARGET RANGE OR SHOOTING FACILITY.
- 20 (3) A RECOGNIZED TARGET RANGE OR SHOOTING FACILITY THAT
- 21 VIOLATES SUBSECTION (1), OR WHOSE EMPLOYEE VIOLATES SUBSECTION (1),
- 22 IS RESPONSIBLE FOR A STATE CIVIL INFRACTION AND MAY BE ORDERED TO
- 23 PAY A CIVIL FINE OF NOT MORE THAN \$500.00.
