A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending section 73110 (MCL 324.73110), as amended by 2013 PA 176.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 73110. (1) Except as provided in subsection (2) or (3), 2 an individual who violates this part is quilty of a misdemeanor 3 punishable by imprisonment for not more than 90 days or a fine of not less than $\frac{100.00}{200.00}$ 200.00 or more than $\frac{500.00}{200.00}$, $\frac{1}{200.00}$, or
 - (2) An individual who kills any protected animal, game, or fish while violating this part is quilty of a misdemeanor punishable by imprisonment for not more than 90 days or a fine of not less than \$250.00 \$500.00 or more than \$750.00, \$1,500.00, or
