- 1 SEC. 31B. (1) WITHIN 24 HOURS AFTER THE ELECTION RESULTS FOR A
- 2 STATEWIDE ELECTION CONDUCTED UNDER THIS ACT HAVE BEEN PROPERLY
- 3 CERTIFIED, THE SECRETARY OF STATE SHALL PROVIDE A DETAILED REPORT
- 4 OF THOSE ELECTION RESULTS ON THE DEPARTMENT OF STATE'S WEBSITE. THE
- 5 DETAILED REPORT MUST INCLUDE ALL OF THE FOLLOWING:
- 6 (A) ELECTION RESULTS FOR THE OFFICES OF GOVERNOR AND
- 7 LIEUTENANT GOVERNOR, SECRETARY OF STATE, ATTORNEY GENERAL, AND
- 8 UNITED STATES SENATOR THAT INCLUDE, BUT ARE NOT LIMITED TO,
- 9 ELECTION RESULTS FOR EACH OF THESE OFFICES FROM EACH ELECTION
- 10 PRECINCT IN THIS STATE.

- 10 PROPOSAL DESCRIBED IN SUBSECTION (1) WITHIN 24 HOURS AFTER THE
- 11 POLLS CLOSE, THE SECRETARY OF STATE SHALL NOTE THAT UNTIMELY
- 12 CERTIFICATION IN THE DETAILED REPORT AND NOTIFY THE CITY OR
- 13 TOWNSHIP CLERK RESPONSIBLE FOR THAT ELECTION PRECINCT OF AN AUDIT
- 14 OF ELECTION RECORDS FOR ALL ELECTION PRECINCTS IN HIS OR HER CITY
- 15 OR TOWNSHIP.
