SUMMARY:

House Bill 5953 would amend several sections in the Michigan Vehicle Code to change penalties and sanctions for various offenses under the code.

Generally, but not in all cases, the bill would change misdemeanor offenses to civil infractions.

The table on pages 2 to 4 of this summary shows the sections that would be amended by the bill, describes the offense or subject matter for which penalties or sanctions are provided, and describes what those penalties or sanctions currently are and what they would be under the bill.

In addition, the bill would repeal section 905 of the code (MCL 257.905).

The bill would take effect 90 days after its enactment.

The bill would have no direct fiscal impact on the Department of State.
