#### Overview

House Bill 5898 contains a supplemental appropriation adjustment for the Department of Treasury for FY 2019-20. In sum, the adjustment would increase Gross and Federal appropriations by \$100.0 million. The bill would have no impact on the state's General Fund.

### **TREASURY**

### 1. Unemployment Insurance Grant Program

Includes \$100.0 million of federal Coronavirus Relief Fund monies for the Department of Treasury to create and operate a grant program for individuals who have applied for unemployment insurance benefits but are experiencing a delay in receiving benefits because of a delay with the Unemployment Insurance Agency determining eligibility and processing claims. The bill would require the Unemployment Insurance Agency to work with the Department of Treasury to assist with implementation of the grant program, including identifying unemployment insurance applicants who are eligible to receive grants under the grant program.

Estimates total state spending from state sources and payments to be made to local units of government.

### **TREASURY**

### Sec. 301. Unemployment Insurance Grant Program

Requires the Department of Treasury to create and operate a grant program for individuals who have applied for unemployment insurance benefits but are experiencing a delay in receiving benefits because of a delay with the Unemployment Insurance Agency determining eligibility and processing claims; requires the Unemployment Insurance Agency to work with the Department of Treasury to assist with implementation of the grant program, including identifying unemployment insurance applicants who are eligible to receive grants under the program; requires grants of \$1,000 to be provided to individuals who have applied for unemployment insurance benefits but are experiencing a delay in receiving benefits because they are waiting for a determination to be made; requires distribution of grants to be prioritized so that applicants who are experiencing the longest delays are the first to receive grants; prohibits grants from being provided to individuals filing fraudulent claims; authorizes the Department of Treasury to retain up to \$1.0 million for administration of the grant program; and requires a biweekly report that provides updates on implementation of the program, and updates on the distribution of payments.
