Sec. 202. The appropriations made and expenditures authorized under this act and the departments, commissions, boards, offices, and programs for which appropriations are made under this act are subject to the management and budget act, 1984 PA 431, MCL 18.1101 to 18.1594.

Sec. 203. If the state administrative board, acting under

1 section 3 of 1921 PA 2, MCL 17.3, transfers funds from an amount
2 appropriated under this act, the legislature may, by a concurrent
3 resolution adopted by a majority of the members elected to and
4 serving in each house, inter-transfer funds within this act for the
5 particular department, board, commission, officer, or institution.

6
7 **DEPARTMENT OF AGRICULTURE AND RURAL DEVELOPMENT**

8 Sec. 301. The funds appropriated in part 1 for environmental
9 stewardship - MAEAP shall be used to support department agriculture
10 pollution prevention programs, including groundwater and freshwater
11 protection programs under part 87 of the natural resources and
12 environmental protection act, 1994 PA 451, MCL 324.8701 to
13 324.8717, and technical assistance in implementing conservation
14 grants available under the federal farm bill of 2014 and the
15 federal farm bill of 2018.

16 Sec. 302. The appropriation in part 1 for the farm stress
17 program shall be used to respond to the mental stress and fatigue
18 of Michigan farmers and agricultural producers and their families
19 through utilizing existing services that offer behavioral health
20 specialists in the agriculture industry.

25 purpose of reimbursing counties for housing in jails certain felons
26 who otherwise would have been sentenced to prison.

27 (2) The county jail reimbursement program shall reimburse
28 counties for convicted felons in the custody of the sheriff if the
29 conviction was for a crime committed on or after January 1, 1999

1 and 1 of the following applies:

2 (a) The felon's sentencing guidelines recommended range upper
3 limit is more than 18 months, the felon's sentencing guidelines
4 recommended range lower limit is 12 months or less, the felon's
5 prior record variable score is 35 or more points, and the felon's
6 sentence is not for commission of a crime in crime class G or crime
7 class H or a nonperson crime in crime class F under chapter XVII of
8 the code of criminal procedure, 1927 PA 175, MCL 777.1 to 777.69.

9 (b) The felon's minimum sentencing guidelines range minimum is
10 more than 12 months under the sentencing guidelines described in
11 subdivision (a).

12 (c) The felon was sentenced to jail for a felony committed
13 while he or she was on parole and under the jurisdiction of the
14 parole board and for which the sentencing guidelines recommended
15 range for the minimum sentence has an upper limit of more than 18
16 months.

17 (3) State reimbursement under this section shall be \$65.00 per
18 diem per diverted offender for offenders with a presumptive prison
19 guideline score, \$55.00 per diem per diverted offender for
20 offenders with a straddle cell guideline for a group 1 crime, and
21 \$40.00 per diem per diverted offender for offenders with a straddle
22 cell guideline for a group 2 crime. Reimbursements shall be paid
23 for sentences up to a 1-year total.

24 (4) As used in this section:

25 (a) "Group 1 crime" means a crime in 1 or more of the
26 following offense categories: arson, assault, assaultive other,
27 burglary, criminal sexual conduct, homicide or resulting in death,
28 other sex offenses, robbery, and weapon possession as determined by
29 the department based on specific crimes for which counties received

1 reimbursement under the county jail reimbursement program in fiscal
2 year 2007 and fiscal year 2008, and listed in the county jail
3 reimbursement program document titled "FY 2007 and FY 2008 Group
4 One Crimes Reimbursed", dated March 31, 2009.

5 (b) "Group 2 crime" means a crime that is not a group 1 crime,
6 including larceny, fraud, forgery, embezzlement, motor vehicle,
7 malicious destruction of property, controlled substance offense,
8 felony drunk driving, and other nonassaultive offenses.

9 (c) "In the custody of the sheriff" means that the convicted
10 felon has been sentenced to the county jail and is either housed in
11 a county jail, is in custody but is being housed at a hospital or
12 medical facility for a medical or mental health purpose, or has
13 been released from jail and is being monitored through the use of
14 the sheriff's electronic monitoring system.

15 (5) County jail reimbursement program expenditures shall not
16 exceed the amount appropriated in part 1 for the county jail
17 reimbursement program. Payments to counties under the county jail
18 reimbursement program shall be made in the order in which properly
19 documented requests for reimbursements are received. A request
20 shall be considered to be properly documented if it meets MDOC
21 requirements for documentation. By October 15, the department shall
22 distribute the documentation requirements to all counties.

23 (6) Any county that receives funding under this section for
24 the purpose of housing in jails certain felons who otherwise would
25 have been sentenced to prison shall, as a condition of receiving
26 the funding, report by September 30 an annual average jail capacity
27 and annual average jail occupancy for the immediately preceding
28 fiscal year.

29 (7) Not later than February 1, the department shall report to

1 the senate and house appropriations subcommittees on corrections
2 all of the following information:

3 (a) The number of inmates sentenced to the custody of the
4 sheriff and eligible for the county jail reimbursement program.

5 (b) The total amount paid to counties under the county jail
6 reimbursement program.

7 (c) The total number of days inmates were in the custody of
8 the sheriff and eligible for the county jail reimbursement program.

9 (d) The number of inmates sentenced to the custody of the
10 sheriff under each of the 3 categories: presumptive prison, group 1
11 crime, and group 2 crime in subsection (3).

12 (e) The total amount paid to counties under each of the 3
13 categories: presumptive prison, group 1 crime, and group 2 crime in
14 subsection (3).

15 (f) The total number of days inmates were in the custody of
16 the sheriff under each of the 3 categories: presumptive prison,
17 group 1 crime, and group 2 crime in subsection (3).

18 (g) The estimated cost of housing inmates sentenced to the
19 custody of the sheriff and eligible for the county jail
20 reimbursement program as inmates of a state prison.

21
22 **DEPARTMENT OF ENVIRONMENT, GREAT LAKES, AND ENERGY**

23 Sec. 401. (1) From the funds appropriated in part 1 for PFAS
24 and emerging contaminants, at least \$4,000,000.00 shall be
25 allocated for a grant program to municipal airports for costs of
26 monitoring and additional testing of wells related to PFAS testing
27 results.

28 (2) On or before April 1, the department shall transmit to the
29 appropriations subcommittees, the fiscal agencies, and the state

1 budget office and post on the department's website a report on the
2 previous calendar year's activities funded with PFAS and emerging
3 contaminants funds. The report shall include a list of all grantees
4 and award amounts.

5
6 **DEPARTMENT OF HEALTH AND HUMAN SERVICES**

7 Sec. 451. (1) From the funds appropriated in part 1 for child
8 care fund - indirect cost allotment, the department shall allocate
9 \$3,500,000.00 to counties and tribal governments that receive
10 reimbursements in part 1 from child care fund.

11 (2) The amount described in subsection (1) shall be
12 distributed to each county or tribal government in the same
13 proportion as indirect cost allotments are provided to counties in
14 the manner described in section 117a of the social welfare act,
15 1939 PA 280, MCL 400.117a.

16 Sec. 452. From the funds appropriated in part 1 for foster
17 care payments, the department shall allocate \$2,000,000.00 to the
18 West Michigan Partnership for Children Consortium for the
19 administrative costs of a prospective payment system as part of a
20 state-administered performance-based child welfare system in a
21 county with a population of not less than 575,000 or more than
22 750,000 according to the most recent federal decennial census, for
23 child welfare case management in accordance with section 503 of
24 article X of 2014 PA 252.

25 Sec. 453. From the funds appropriated in part 1 for community
26 substance use disorder prevention, education, and treatment,
27 \$600,000.00 is allocated as grants to high schools specifically
28 designated for students recovering from a substance use disorder to
29 support the costs of counselors, therapeutic staff, and recovery

1 coaching staff, with a priority placed on the cost of substance use
2 disorder counselors. Each grant shall not exceed \$150,000.00 per
3 high school.

4 Sec. 454. From the funds appropriated in part 1 for community
5 substance use disorder prevention, education, and treatment, the
6 department shall allocate \$600,000.00 to create a competitive grant
7 for recovery community organizations to offer or expand recovery
8 support center services or recovery community center services to
9 individuals seeking long-term recovery from substance use
10 disorders. An organization may not receive a grant in excess of
11 \$150,000.00. In awarding grants, priority shall be placed on
12 recovery community organizations that do the following:

13 (a) Provide recovery support navigation that includes the
14 following:

15 (i) Multiple recovery pathways.

16 (ii) Assistance for individuals navigating recovery resources
17 such as detoxification, treatment, recovery housing, support
18 groups, peer support, and family support.

19 (iii) The promotion of community wellness and engagement.

20 (iv) Recovery advocacy that provides hope and encourages
21 recovery.

22 (v) A peer-led, peer-driven organization that offers recovery
23 to any individual seeking recovery from addiction.

24 (b) Provide recovery outreach education that includes the
25 following:

26 (i) On-site recovery education in the workplace.

27 (ii) All staff employee meetings.

28 (iii) On-site support for employees and family members.

1 (iv) Connections for employees and family members of employees
2 suffering from addiction to local recovery resources such as
3 treatment, recovery housing, and support groups.

4 (v) Connections with employers to provide recovery advocacy.

5 (c) Provide recovery activities and events that include the
6 following:

7 (i) Safe, ongoing recovery activities and events.

8 (ii) Opportunities to volunteer and participate in activities
9 and events.

10 (iii) Opportunities for family members and supporters of
11 recovery to be involved.

12 (iv) Meetings and activities on nutrition, health, and
13 wellness.

14 (v) Meetings and activities on mindfulness, meditation, and
15 yoga.

16 Sec. 455. From the funds appropriated in part 1 for community
17 substance use disorder prevention, education, and treatment,
18 \$500,000.00 is allocated for a specialized substance use disorder
19 detoxification pilot project administered by a 9-1-1 service
20 district in conjunction with a substance use and case management
21 provider and at a hospital in a city with a population between
22 95,000 and 97,000 according to the most recent federal decennial
23 census within a county with a population of at least 1,500,000
24 according to the most recent federal decennial census. The hospital
25 must have a wing with at least 10 beds dedicated to stabilizing
26 patients suffering from addiction by providing a specialized trauma
27 therapist as well as a peer support specialist to assist with
28 treatment and counseling.

29 Sec. 456. From the funds appropriated in part 1 for primary

1 care services, the department shall allocate no less than
2 \$675,000.00 for island primary health care access and services
3 including island clinics, in the following amounts:

4 (a) Beaver Island, \$250,000.00.

5 (b) Mackinac Island, \$250,000.00.

6 (c) Drummond Island, \$150,000.00.

7 (d) Bois Blanc Island, \$25,000.00.

8 Sec. 457. The department shall provide an additional
9 \$5,099,100.00 in general fund/general purpose revenue and any
10 associated federal match and restricted dollars to further increase
11 outpatient Medicaid rates for services performed at critical access
12 hospitals.

13 Sec. 458. The department shall increase the practitioner rates
14 paid for current procedural terminology (CPT) codes in psychiatric
15 diagnostic procedures through Medicaid fee-for-service and through
16 the Medicaid health plans by 15% for psychiatric diagnostic
17 procedure provided for Medicaid beneficiaries under the age of 21.
18 It is the intent of the legislature that the CPT specific rates
19 paid through the Medicaid health plans are not increased by a
20 uniform 15% but reflect the greater of either the actual rates paid
21 during the previous fiscal year or 100% of the Medicare rate
22 received for those services on the date the services are provided.

23 Sec. 459. From the funds appropriated in part 1 for health
24 plan services and physician services, the department shall provide
25 Medicaid reimbursement rates for neonatal services at 95% of the
26 Medicare rate received for those services in effect on the date the
27 services are provided to eligible Medicaid recipients. The current
28 procedural terminology (CPT) codes that are eligible for this
29 reimbursement rate increase are 99468, 99469, 99471, 99472, 99475,

1 99476, 99477, 99478, 99479, and 99480.

2 Sec. 460. From the funds appropriated in part 1 for hospital
3 services and therapy, \$7,995,200.00 in general fund/general purpose
4 revenue shall be provided as lump-sum payments to noncritical
5 access hospitals that qualified for rural hospital access payments
6 in fiscal year 2013-2014 and that provide obstetrical care in the
7 current fiscal year. Payment amounts shall be based on the volume
8 of obstetrical care cases and newborn care cases for all such cases
9 billed by each qualified hospital in the most recent year for which
10 data are available. Payments shall be made by January 1 of the
11 current fiscal year.

12 Sec. 461. From the funds appropriated in part 1 for hospital
13 services and therapy, \$13,904,800.00 in general fund/general
14 purpose revenue and any associated federal match shall be awarded
15 as rural access payments to noncritical access hospitals that meet
16 criteria established by the department for services to low-income
17 rural residents. One of the reimbursement components of the
18 distribution formula shall be assistance with labor and delivery
19 services. The department shall ensure that the rural access
20 payments described in this section shall be distributed in a manner
21 that ensures both of the following:

22 (a) No hospital or hospital system shall receive more than
23 10.0% of the total rural access funding referenced in this section.

24 (b) To allow hospitals to understand their rural payment
25 amounts under this section, the department shall provide hospitals
26 with the methodology for distribution under this section and
27 provide each hospital with its applicable data that are used to
28 determine the payment amounts by August 1 of the current fiscal
29 year. The department shall publish the distribution of payments for

1 the current fiscal year and the immediately preceding fiscal year.

2 Sec. 462. (1) From the funds appropriated in part 1 for
3 hospital services and therapy, the department shall allocate
4 \$3,750,000.00 in general fund/general purpose revenue plus any
5 contributions from public entities, up to \$5,000,000.00, and any
6 associated federal match to the MiDocs consortium to create new
7 primary care residency slots in underserved communities. The new
8 primary care residency slots must be in 1 of the following
9 specialties: family medicine, general internal medicine, general
10 pediatrics, general OB-GYN, psychiatry, or general surgery.

11 (2) The department shall seek any necessary approvals from CMS
12 to allow the department to implement the program described in this
13 section.

14 (3) Assistance with repayment of medical education loans, loan
15 interest payments, or scholarships provided by MiDocs shall be
16 contingent upon a minimum 2-year commitment to practice in an
17 underserved community in this state post-residency and an agreement
18 to forego any subspecialty training for at least 2 years post-
19 residency.

20 (4) The MiDocs shall work with the department to integrate the
21 Michigan inpatient psychiatric admissions discussion (MIPAD)
22 recommendations and, when possible, prioritize training
23 opportunities in state psychiatric hospitals and community mental
24 health organizations.

25 (5) In collaboration with the Michigan Health Council, the
26 MiDocs consortium shall reserve at least 3 residency slots per
27 class to be used for the Michigan early primary care incentive
28 program.

29 (6) The department shall create a MiDocs initiative advisory

1 council to help support implementation of the program described in
2 this section, and provide oversight. The advisory council shall be
3 composed of the MiDocs consortium, the Michigan Area Health
4 Education Centers, the Michigan Primary Care Association, the
5 Michigan Center for Rural Health, the Michigan Academy of Family
6 Physicians, and any other appointees designated by the department.

7 (7) By September 1 of the current fiscal year, MiDocs shall
8 report to the senate and house appropriations subcommittees on the
9 department budget, the senate and house fiscal agencies, the senate
10 and house policy offices, and the state budget office on the
11 following:

12 (a) Audited financial statement of per-resident costs.

13 (b) Education and clinical quality data.

14 (c) Roster of trainees, including areas of specialty and
15 locations of training.

16 (d) Medicaid revenue by training site.

17 (8) Outcomes and performance measures for this program
18 include, but are not limited to, the following:

19 (a) Increasing this state's ability to recruit, train, and
20 retain primary care physicians and other select specialty
21 physicians in underserved communities.

22 (b) Maximizing training opportunities with community health
23 centers, rural critical access hospitals, solo or group private
24 practice physician practices, schools, and other community-based
25 clinics, in addition to required rotations at inpatient hospitals.

26 (c) Increasing the number of residency slots for family
27 medicine, general internal medicine, general pediatrics, general
28 OB-GYN, psychiatry, and general surgery.

29 (9) Unexpended and unencumbered funds up to a maximum

1 \$3,750,000.00 in general fund/general purpose revenue plus any
2 contributions from public entities, up to \$5,000,000.00, and any
3 associated federal match remaining in accounts appropriated in part
4 1 for hospital services and therapy are designated as work project
5 appropriations, and any unencumbered or unallotted funds shall not
6 lapse at the end of the fiscal year and shall be available for
7 expenditures for the MiDocs consortium to create new primary care
8 residency slots in underserved communities under this section until
9 the work project has been completed. All of the following are in
10 compliance with section 451a(1) of the management and budget act,
11 1984 PA 431, MCL 18.1451a:

12 (a) The purpose of the work project is to fund the cost of the
13 MiDocs consortium to create new primary care residency slots in
14 underserved communities.

15 (b) The work project will be accomplished by contracting with
16 the MiDocs consortium to oversee the creation of new primary care
17 residency slots.

18 (c) The total estimated completion cost of the work project is
19 \$17,500,000.00.

20 (d) The tentative completion date is September 30, 2024.

21 Sec. 463. (1) From the funds appropriated in part 1 for autism
22 navigator, the department shall require any contractor receiving
23 funds from this line item to comply with performance-related
24 metrics to maintain eligibility for funding. The organizational
25 metrics shall include, but not be limited to, all of the following:

26 (a) Each contractor shall have accreditations that attest to
27 their competency and effectiveness in providing services.

28 (b) Each contractor shall demonstrate cost-effectiveness.

29 (c) Each contractor shall ensure their ability to leverage

1 private dollars to strengthen and maximize service provision.

2 (d) Each contractor shall provide quarterly reports to the
3 department regarding the number of clients served, units of service
4 provision, and ability to meet their stated goals.

5 (2) The department shall require an annual report from any
6 contractor receiving funding from the autism navigator line item.
7 The annual report, due to the department 60 days following the end
8 of the contract period, shall include specific information on
9 services and programs provided, the client base to which the
10 services and programs were provided, and the expenditures for those
11 services. The department shall provide the annual reports to the
12 senate and house appropriations subcommittees on the department
13 budget, the senate and house fiscal agencies, and the state budget
14 office.

15 Sec. 464. (1) From the funds appropriated in part 1 for autism
16 train the trainer grant, the department shall allocate \$100,000.00
17 to implement a pilot project to train school employees on the
18 principles and practices of applied behavior analysis and research-
19 based intervention strategies. The pilot project must do both of
20 the following:

21 (a) Train paraprofessionals and teachers in a school district
22 with a headquarters located in a city with a population between
23 6,900 and 7,000 according to the most recent federal decennial
24 census in applied behavior analysis skills that match the national
25 standard for behavior technician-level work and research-based
26 intervention strategies.

27 (b) Train teacher consultants, school social workers, school
28 psychologists, and other school personnel responsible for
29 conducting functional behavioral assessments and the development of

1 behavior support plans in a school district with a headquarters
2 located in a city with a population between 6,900 and 7,000
3 according to the most recent federal decennial census on methods
4 for ensuring implementation of a behavior plan with fidelity and
5 strategies for sharing understanding of evidence-based behavioral
6 health approaches with other school-based personnel.

7 (2) Outcomes and performance measures for the pilot project
8 funded under this section shall include, but not be limited to, the
9 following:

10 (a) A decrease in the number of center-program and self-
11 contained-classroom referrals.

12 (b) A decrease in the number of suspensions, removals, and
13 expulsions.

14 (c) A decrease in paraprofessional absences.

15 (d) An increase in teacher retention.

16 (e) An increase in safety.

17 (3) By September 1 of the current fiscal year, the department
18 shall report to the senate and house appropriations subcommittees
19 on the department budget, the senate and house fiscal agencies, the
20 senate and house policy offices, and the state budget office on the
21 information required in subsection (2).

22 Sec. 465. From the funds appropriated in part 1 for healthy
23 communities grant, \$300,000.00 shall be allocated for a 1-time
24 grant to Leaders Advancing and Helping Communities for community
25 healthy living, obesity prevention, and substance abuse prevention
26 programs.

27 Sec. 466. From the funds appropriated in part 1 for opioid
28 transitional housing and services grant, the department shall
29 allocate \$750,000.00 to a nonprofit organization organized under

1 the laws of this state that is exempt from federal income tax under
2 section 501(c)(3) of the internal revenue code of 1986, 26 USC 501,
3 and is located in a county with a population between 160,000 and
4 162,000 according to the most recent federal decennial census for
5 operational use as it relates to the state's mission regarding
6 substance use disorder and opioid abuse. To be eligible to receive
7 funding, the organization must have a stated mission to educate the
8 community on opiate abuse and provide support for families and
9 those suffering addiction.

10 Sec. 467. From the funds appropriated in part 1 for project
11 ECHO opioid intervention, the department shall allocate \$40,000.00
12 to a nonprofit center for rural health housed within a 4-year state
13 university located in a county with a population between 280,000
14 and 285,000 according to the most recent federal decennial census
15 for an opioid response consortium in northern Michigan. To be
16 eligible to receive funding, the consortium must have a stated
17 objective to develop and implement strategies to address the opioid
18 epidemic across the Northern Michigan Opioid Response Consortium
19 14-county region.

20 Sec. 468. From the funds appropriated in part 1 for senior
21 citizen center program grants, the department shall allocate
22 \$500,000.00 for a grant program administered by the aging and adult
23 services agency to support health-related senior programs at
24 multipurpose senior citizen centers. Program goals shall include
25 mental and physical health maintenance and improvement for senior
26 participants. Grant awards shall not exceed \$5,000.00 for a
27 program. Grantees are encouraged to match the funding with
28 participant fees or other nonstate source of funds. A private
29 housing facility with senior activity programs is not eligible for

1 the grant program.

2 Sec. 469. (1) From the funds appropriated in part 1 for senior
3 community services, \$400,000.00 is appropriated for Alzheimer's
4 disease services. The funds shall be remitted to the Alzheimer's
5 Association-Michigan chapter for the purpose of carrying out a
6 dementia care and support program in Allegan, Kent, Lenawee,
7 Macomb, Midland, Monroe, Oakland, St. Clair, St. Joseph, and Wayne
8 Counties. Program services shall be provided to individuals with
9 Alzheimer's disease or dementia and their families in the 10
10 counties, and shall include a 24/7 helpline, continued care
11 consultation, and referrals to support groups and other community-
12 based services. The Alzheimer's Association-Michigan chapter shall
13 also contract for an evaluation of the program. The total cost for
14 program evaluation shall not exceed \$15,000.00.

15 (2) By March 1 of the current fiscal year, the department
16 shall provide a report to the house and senate subcommittees on the
17 department budget, the house and senate fiscal agencies and policy
18 offices, and the state budget office on the status of the program
19 and the evaluation, the number of employees funded by the program,
20 the number of persons served by the program, and the number of
21 persons served by the program who continue to live in their own
22 home as known as of the date of the report. The report shall
23 include an analysis of program data to assess whether providing the
24 in-home support services significantly delays the need for
25 residential long-term care services for individuals with
26 Alzheimer's disease or dementia.

27 Sec. 470. (1) From the funds appropriated in part 1 for the
28 suicide prevention commission, the department of health and human
29 services shall allocate \$250,000.00 in general fund/general purpose

1 revenue to support costs of furnishing clerking services, meeting
2 support, and commissioner reimbursement activities of the suicide
3 prevention commission.

4 (2) Unexpended and unencumbered funds up to a maximum
5 \$250,000.00 in general fund/general purpose revenue remaining in
6 accounts appropriated in part 1 for suicide prevention commission
7 are designated as work project appropriations, and any unencumbered
8 or unallotted funds shall not lapse at the end of the fiscal year
9 and shall be available for expenditure to support department of
10 health and human services costs of furnishing clerking services,
11 meeting support, and commissioner reimbursement activities under
12 this section until the project has been completed. All of the
13 following are in compliance with section 451a(1) of the management
14 and budget act, 1984 PA 431, MCL 18.1451a:

15 (a) The purpose of the project is to fund the department of
16 health and human services costs of furnishing clerking services,
17 meeting support, and commissioner reimbursement activities of the
18 suicide prevention commission.

19 (b) The project will be accomplished by utilizing state
20 employees or contracts with services providers, or both, and
21 according to the approved planning document of the suicide
22 prevention commission.

23 (c) The total estimated completion cost of the project is
24 \$250,000.00.

25 (d) The tentative completion date is September 30, 2024.

26
27 **JUDICIARY**

28 Sec. 501. (1) From the funds appropriated in part 1 for
29 expansion of problem solving courts, the state court administrative

1 office shall create a pilot program in a veteran court within a
2 county with a population between 100,000 and 110,000 according to
3 the most recent federal decennial census. The pilot program will
4 investigate the effectiveness of saliva testing to determine
5 compliance with required mental health medicine prescriptions or
6 requirements.

7 (2) From the funds appropriated in part 1 for expansion of
8 problem solving courts, \$20,000.00 is allocated to cover the costs
9 of saliva testing.

10 11 **LABOR AND ECONOMIC OPPORTUNITY**

12 Sec. 551. (1) From the funds appropriated in part 1 for
13 Michigan special grants, \$1,000,000.00 shall be awarded to a
14 nonprofit civil and human rights organization located in a city
15 with a population of greater than 600,000 according to the most
16 recent federal decennial census that provides programs in early
17 learning, youth development, job training, food assistance,
18 community empowerment, and system change advocacy.

19 (2) From the funds appropriated in part 1 for Michigan special
20 grants, \$500,000.00 shall be awarded for upgrades at a community
21 college located in a county with a population of between 29,000 and
22 30,000 according to the most recent federal decennial census. It is
23 the intent of the legislature that the upgrades include increased
24 classroom space, laboratory upgrades, and technology upgrades to
25 enhance hands-on training for students.

26 (3) From the funds appropriated in part 1 for Michigan special
27 grants, \$250,000.00 shall be awarded to a city with a population of
28 between 3,900 and 4,000 located in a county with a population
29 greater than 1,800,000 according to the most recent federal

decennial census for seawall repairs.

(4) From the funds appropriated in part 1 for Michigan special grants, \$250,000.00 shall be awarded for a community corrections program located in a county with a population of between 200,000 and 201,000 according to the most recent federal decennial census.

Sec. 552. The funds appropriated in part 1 for blight elimination grants shall be awarded to blight elimination projects located in counties with populations under 50,000 with priority given to communities with the greatest population loss since 2000 and cap individual grants at no more than \$50,000.00.

The general fund/general purpose funds appropriated in part 1 for the county veteran service fund shall be deposited in the restricted county veteran service fund created in section 3a of 1953 PA 192, MCL 35.623a.
