SUBSTITUTE FOR HOUSE BILL NO. 4924

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 421d.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 421d. (1) A person shall not do any of the following:

- 2 (a) Knowingly and intentionally import, manufacture, sell,
- 3 offer for sale, distribute, install, or reinstall in a motor
- 4 vehicle a device intended to replace a supplemental restraint
- 5 system component if the device is a counterfeit supplemental
- 6 restraint system component, a nonfunctional airbag, or an object
- 7 that the person knows was not designed to comply with 49 CFR
- 8 571.208 for the make, model, and year of that motor vehicle.
 - (b) Knowingly and intentionally sell, offer for sale, install,

- 1 or reinstall in any motor vehicle a device that the person knows
- 2 will cause a motor vehicle's diagnostic system to inaccurately
- 3 indicate that the motor vehicle is equipped with a properly
- 4 functioning supplemental restraint system.
- 5 (c) Knowingly and intentionally sell, lease, or trade a motor
- 6 vehicle to a consumer if the person has actual knowledge that a
- 7 counterfeit supplemental restraint system component, a
- 8 nonfunctional airbag, or an object that the person has actual
- 9 knowledge was not designed to comply with 49 CFR 571.208 for the
- 10 make, model, and year of the motor vehicle has been installed as
- 11 part of the motor vehicle's inflatable restraint system.
- 12 (2) A person who violates subsection (1) is guilty of a felony
- 13 punishable by imprisonment for not more than 4 years or a fine of
- 14 not more than \$10,000.00, or both.
- 15 (3) This section does not apply to the owner or employee of a
- 16 new or used motor vehicle dealership who does not have actual
- 17 knowledge of the presence of a counterfeit supplemental restraint
- 18 system component or nonfunctional airbag before it is sold.
- 19 (4) This section does not create a duty for or require the
- 20 owner or employee of a new or used motor vehicle dealership to
- 21 inspect any vehicle in the motor vehicle dealership's possession
- 22 for counterfeit supplemental restraint system components or
- 23 nonfunctional airbags before the sale of the vehicle.
- 24 (5) This section does not apply to a person who installs a
- 25 motor vehicle airbag used solely for research and development of
- 26 airbag technology on motor vehicles that will not be driven on
- 27 public roadways.
- 28 (6) As used in this section:
- 29 (a) "Airbag" means a motor vehicle inflatable occupant

- 1 restraint system device that is part of a supplemental restraint 2 system.
- 3 (b) "Counterfeit supplemental restraint system component"
- 4 means a replacement supplemental restraint system component that
- 5 displays a mark that is identical or substantially similar to the
- 6 genuine mark of a manufacturer or a supplier of parts to a
- 7 manufacturer without authorization from the manufacturer or
- 8 supplier.
- 9 (c) "Nonfunctional airbag" means a replacement airbag to which
 10 1 or more of the following applies:
- 11 (i) The airbag was previously deployed or damaged.
- 12 (ii) The airbag has an electric fault that is detected by a
- 13 motor vehicle's diagnostic system when the installation procedure
- 14 is complete and the motor vehicle is returned to the customer who
- 15 requested the work to be performed or when ownership of the vehicle
- 16 is intended to be transferred.
- 17 (iii) The airbag includes a part or object, including, but not
- 18 limited to, a supplemental restraint system component installed in
- 19 a motor vehicle to mislead the owner or operator of the motor
- 20 vehicle into believing that a functional airbag has been installed.
- 21 (iv) The airbag violates 49 USC 30120(j).
- 22 (d) "Supplemental restraint system" means an inflatable
- 23 restraint system as that term is defined in 49 CFR 571.208 that is
- 24 designed for use in conjunction with active restraint systems.
- 25 Supplemental restraint system includes 1 or more airbags and all
- 26 components required to ensure that an airbag functions as designed
- 27 by the manufacturer, including, but not limited to, all of the
- 28 following:
- 29 (i) That the airbag will operate as necessary in the event of a

- 1 crash.
- 2 (ii) That the airbag is designed in accordance with federal
- 3 motor vehicle safety standards for the make, model, and year of the
- 4 motor vehicle in which it is or will be installed.
- 5 Enacting section 1. This amendatory act takes effect 90 days
- 6 after the date it is enacted into law.
