- Sec. 212. Within 14 days after the release of the executive
- 25 budget recommendation, the department shall cooperate with the
- 26 state budget office to provide the senate and house appropriations
- 27 chairs, the chairs of the senate and house appropriations

- 1 subcommittees responsible for the department budget, and the senate
- 2 and house fiscal agencies with an annual report on estimated state
- 3 restricted fund balances, state restricted fund projected revenues,
- 4 and state restricted fund expenditures for the fiscal years ending
- 5 September 30, 2019 and September 30, 2020.
- 6 Sec. 213. The department shall maintain, on a publicly
- 7 accessible website, a department scorecard that identifies, tracks,
- 8 and regularly updates key metrics that are used to monitor and
- 9 improve the department's performance.
- 10 Sec. 214. Total authorized appropriations from all sources
- 11 under part 1 for legacy costs for the fiscal year ending September
- 12 30, 2020 are estimated at \$14,654,400.00. From this amount, total
- 13 agency appropriations for pension-related legacy costs are
- 14 estimated at \$7,123,800.00. Total agency appropriations for retiree
- 15 health care legacy costs are estimated at \$7,530,600.00.
- Sec. 215. The department shall provide through the internet
- 17 the state board of education agenda and all supporting documents,
- 18 and shall notify the state budget director and the senate and house
- 19 fiscal agencies that the agenda and supporting documents are
- 20 available on the internet, at the time the agenda and supporting
- 21 documents are provided to state board of education members.
- 22 Sec. 217. The department may assist the department of health
- 23 and human services, other departments, and local school districts
- 24 to secure reimbursement for eligible services provided in Michigan
- 25 schools from the federal Medicaid program. The department may
- 26 submit reports of direct expenses related to this effort to the
- 27 department of health and human services for reimbursement.

- 1 Sec. 219. From the funds appropriated in part 1, the
- 2 department shall ensure that kindergarten benchmark data include a
- 3 method for information to be provided regarding a child's
- 4 participation in the great start readiness program.
- 5 Sec. 220. The department shall post on its website a link to
- 6 the federal Institute of Education Sciences' What Works
- 7 Clearinghouse. The department also shall work to disseminate
- 8 knowledge about the What Works Clearinghouse to districts and
- 9 intermediate districts so that it may be used to improve reading
- 10 proficiency for pupils in grades K to 3.
- 11 Sec. 222. The department shall not take disciplinary action
- 12 against an employee who communicates truthfully and factually with
- 13 a member of the legislature or his or her staff.
- 14 Sec. 223. The department and agencies receiving appropriations
- 15 in part 1 shall receive and retain copies of all reports funded
- 16 from appropriations in part 1. Federal and state guidelines for
- 17 short-term and long-term retention of records shall be followed.
- 18 The department may electronically retain copies of reports unless
- 19 otherwise required by federal and state guidelines.
- 20 Sec. 225. (1) From the funds appropriated in part 1, the
