SUBSTITUTE FOR HOUSE BILL NO. 4306

A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961,"

by amending section 3212 (MCL 600.3212), as amended by 2011 PA 301.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 3212. Every A notice of foreclosure by advertisement
 shall must include all of the following:
- 3 (a) The names of the mortgagor, the original mortgagee, and4 the foreclosing assignee, if any.
- 5 (b) The date of the mortgage and the date the mortgage was6 recorded.
- 7 (c) The amount claimed to be due on the mortgage on the date
 8 of the notice.
- 9 (d) A description of the mortgaged premises that substantially



- conforms with the description contained in the mortgage. 1
- (e) A description of the property by giving its street 3 address, if any. The validity of the notice and the validity of any 4 eventual sale under this chapter are not affected by the fact that
- 5 the street address in the notice is erroneous or that the street
- 6 address is omitted.

- 7 (f) (e) For a mortgage executed on or after January 1, 1965,
- 8 December 31, 1964, the length of the redemption period as
- 9 determined under section 3240.
- 10 (g) $\frac{f}{h}$ A statement that if the property is sold at a
- 11 foreclosure sale under this chapter, under section 3278 the
- borrower will be held responsible to the person who buys the 12
- 13 property at the mortgage foreclosure sale or to the mortgage holder
- 14 for damaging the property during the redemption period.
- 15 (h) The name, address, and telephone number of the attorney
- 16 for the party foreclosing the mortgage.
- (i) For a residential mortgage, a statement in the following 17
- 18 form: "Attention homeowner: If you are a military service member on
- 19 active duty, if your period of active duty has concluded less than
- 20 90 days ago, or if you have been ordered to active duty, please
- 21 contact the attorney for the party foreclosing the mortgage at the
- 22 telephone number stated in this notice.".
- 23 (j) A statement in the following form: "Notice of foreclosure
- 24 by advertisement. Notice is given under section 3212 of the revised
- 25 judicature act of 1961, 1961 PA 236, MCL 600.3212, that the
- 26 following mortgage will be foreclosed by a sale of the mortgaged
- 27 premises, or some part of them, at a public auction sale to the
- 28 highest bidder for cash or cashier's check at the place of holding
- 29 the circuit court in County, starting promptly at (time),

- 1 on (date). The amount due on the mortgage may be greater on the day
- 2 of the sale. Placing the highest bid at the sale does not
- 3 automatically entitle the purchaser to free and clear ownership of
- 4 the property. A potential purchaser is encouraged to contact the
- 5 county register of deeds office or a title insurance company,
- 6 either of which may charge a fee for this information.".
- 7 Enacting section 1. This amendatory act takes effect 30 days
- 8 after the date it is enacted into law.
