

# HOUSE BILL NO. 4683

May 28, 2019, Introduced by Reps. Howell, Vaupel, Sabo, Calley, Filler and Tate and referred to the Committee on Military, Veterans and Homeland Security.

A bill to amend 1949 PA 300, entitled  
"Michigan vehicle code,"  
by amending section 803j (MCL 257.803j), as amended by 1999 PA 183.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           Sec. 803j. (1) A person who was a member of the ~~armed services~~  
2 **United States Armed Forces** or a person whose spouse was a member of  
3 the ~~armed forces~~ **United States Armed Forces** during the Korean War  
4 may ~~make application~~ **apply** to the secretary of state for a special



1 registration plate ~~, which shall display~~ **that displays** an  
2 appropriate vignette preceding the registration numbers and ~~shall~~  
3 ~~have~~ **has** the word "veteran" inscribed beneath the registration  
4 numbers.

5 (2) Application for a special registration plate ~~shall~~ **must** be  
6 on a form prescribed by the secretary of state, and ~~shall~~ **must** be  
7 accompanied by any proof of the applicant or the applicant's spouse  
8 having been a Korean War veteran that the secretary of state may  
9 require. ~~The application for a special registration plate shall~~  
10 ~~also be accompanied with payment of a \$5.00 service fee.~~

11 (3) Upon proper application, ~~and payment of the \$5.00 service~~  
12 ~~fee,~~ the secretary of state shall issue 1 or more special  
13 registration plates for each applicant for use on a passenger  
14 vehicle. A person who is disabled who ~~makes application~~ **applies** for  
15 a special registration plate under this section ~~and who makes~~  
16 ~~payment of the \$5.00 service fee shall~~ **must** be issued a tab for  
17 persons with disabilities as provided in section 803f for his or  
18 her special registration plate. The secretary of state shall  
19 require the same proof that the applicant is a disabled person as  
20 is required for issuance of a permanent windshield placard under  
21 section 675. A person issued 1 or more special registration plates  
22 under subsection (1) ~~shall~~ **must** be assessed the applicable tax  
23 provided in section 801.

24 (4) The use of a special registration plate on a vehicle other  
25 than the vehicle for which the plate is issued, or by a person who  
26 does not qualify under this section, is a misdemeanor.

27 (5) The special registration plate issued under this section  
28 ~~shall expire~~ **expires** on the birthday of the vehicle owner. ~~When new~~  
29 ~~plates are issued by the secretary of state, application for~~



1 ~~renewal of the special registration plate shall be accompanied by a~~  
2 ~~\$5.00 service fee. The applicant shall is not be required to~~  
3 furnish the proof provided in subsection (2) **for an application for**  
4 **renewal of the special registration plate.**
