- 22 appropriated from the state school aid fund. A university that
- 23 receives money under this subsection shall use that money solely
- 24 for the purpose of offsetting the normal cost contribution rate. As
- 25 used in this subsection, "participating public universities" means
- 26 public universities that are a reporting unit of the Michigan
- 27 public school employees' retirement system under the public school

- 1 employees retirement act of 1979, 1980 PA 300, MCL 38.1301 to
- 2 38.1437, and that pay contributions to the Michigan public school
- 3 employees' retirement system for the state fiscal year.
- 4 Sec. 236a. It is the intent of the legislature to provide
- 5 appropriations for the fiscal year ending on September 30, 2020
- 6 2021 for the items listed in section 236. The fiscal year 2019-2020
- 7 2020-2021 appropriations are anticipated to be the same as those
- 8 for fiscal year 2018-2019, **2019-2020**, except that the amounts will
- 9 be adjusted for changes in caseload and related costs, federal fund
- 10 match rates, economic factors, and available revenue. These
- 11 adjustments will be determined after the January 2019 2020
- 12 consensus revenue estimating conference.
