SENATE SUBSTITUTE FOR HOUSE BILL NO. 6159

A bill to provide immunity for health care providers and health care facilities in the event of a pandemic; and to clarify the time frame for the immunity.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. This act shall be known and may be cited as the
 "pandemic health care immunity act".
- 3 Sec. 3. As used in this act:
- 4 (a) "Gross negligence" means conduct so reckless as to
 5 demonstrate a substantial lack of concern for whether an injury
 6 results.
- 7 (b) "Health care facility" means an entity that is 1 or more 8 of the following:
- $\mathbf{9}$ (i) A health facility or agency as defined in section 20106 of

- 1 the public health code, 1978 PA 368, MCL 333.20106.
- 2 (ii) A state-owned surgical center.
- 3 (iii) A state-operated outpatient facility.
- 4 (iv) A state-operated veterans facility.
- $\mathbf{5}$ (v) A facility used as surge capacity for any of the health
- 6 care facilities described in this subdivision.
- 7 (c) "Health care provider" means an individual that is 1 or
- 8 more of the following:
- 9 (i) An individual licensed under article 15 of the public
- 10 health code, 1978 PA 368, MCL 333.16101 to 333.18838.
- 11 (ii) An individual permitted to engage in the practice of a
- 12 health profession under section 16171(c) of the public health code,
- 13 1978 PA 368, MCL 333.16171.
- 14 (iii) Emergency medical services personnel as defined in section
- 15 20904 of the public health code, 1978 PA 368, MCL 333.20904.
- 16 (iv) A student, volunteer, or any other licensed health care
- 17 professional at a health care facility.
- 18 (d) "Health care services" means services provided to an
- 19 individual by a health care facility or health care provider
- 20 regardless of the location where those services are provided,
- 21 including the provision of health care services via telehealth or
- 22 other remote method.
- (e) "Willful misconduct" means conduct or a failure to act
- 24 that was intended to cause harm.
- 25 Sec. 5. A health care provider or health care facility that
- 26 provides health care services in support of this state's response
- 27 to the COVID-19 pandemic is not liable for an injury, including
- 28 death, sustained by an individual by reason of those services,
- 29 regardless of how, under what circumstances, or by what cause those

- 1 injuries are sustained, unless it is established that the provision
- 2 of the services constituted willful misconduct, gross negligence,
- 3 intentional and willful criminal misconduct, or intentional
- 4 infliction of harm by the health care provider or health care
- 5 facility.
- 6 Sec. 6. This act does not apply to claims covered by the
- 7 worker's disability compensation act of 1969, 1969 PA 317, MCL
- **8** 418.101 to 418.941.
- 9 Sec. 7. The liability protection provided by this act applies
- 10 retroactively, and applies on or after March 29, 2020 and before
- **11** July 14, 2020.
