- 1 Sec. 201. Pursuant to section 30 of article IX of the state
- 2 constitution of 1963, total state spending from state sources under
- 3 part 1 for fiscal year 2019-2020 is \$100,488,900.00 and state
- 4 spending from state sources to be paid to local units of government
- 5 for fiscal year 2019-2020 is \$10,950,000.00. The itemized statement

- 15 Sec. 202. The appropriations authorized under part 1 and this
- 16 part are subject to the management and budget act, 1984 PA 431, MCL
- **17** 18.1101 to 18.1594.
- 18 Sec. 203. As used in part 1 and this part:
- 19 (a) "Department" means the department of agriculture and rural
- 20 development.
- (b) "Director" means the director of the department.
- (c) "EPA" means the United States Environmental Protection
- 23 Agency.
- 24 (d) "FDA" means the United States Food and Drug
- 25 Administration.
- (e) "Fiscal agencies" means the Michigan house fiscal agency
- 27 and the Michigan senate fiscal agency.

- 1 (f) "FTE" means full-time equated.
- 2 (g) "HHS" means the United States Department of Health and
- 3 Human Services.
- 4 (h) "IDG" means interdepartmental grant.
- 5 (i) "LARA" means the Michigan department of licensing and
- 6 regulatory affairs.
- 7 (j) "LCC" means the Michigan liquor control commission.
- 8 (k) "MAEAP" means the Michigan agriculture environmental
- 9 assurance program.
- 10 (1) "MDEQ" means the Michigan department of environmental
- 11 quality.
- 12 (m) "MDNR" means the Michigan department of natural resources.
- (n) "MOU" means memorandum of understanding.
- 14 (o) "Subcommittees" means all members of the subcommittees of
- 15 the house and senate appropriations committees with jurisdiction
- 16 over the budget for the department.
- 17 (p) "TB" means tuberculosis.
- 18 (q) "USDA" means the United States Department of Agriculture.
- 19 Sec. 204. The departments and agencies receiving
- 20 appropriations in part 1 shall use the internet to fulfill the
- 21 reporting requirements of this part. This requirement may include
- 22 transmission of reports via electronic mail to the recipients
- 23 identified for each reporting requirement, or it may include
- 24 placement of reports on an internet or intranet site.
- 25 Sec. 205. Funds appropriated in part 1 shall not be used for
- 26 the purchase of foreign goods or services, or both, if
- 27 competitively priced and of comparable quality American goods or

- 1 services, or both, are available. Preference shall be given to
- 2 goods or services, or both, manufactured or provided by Michigan
- 3 businesses, if they are competitively priced and of comparable
- 4 quality. In addition, preference shall be given to goods or
- 5 services, or both, that are manufactured or provided by Michigan
- 6 businesses owned and operated by veterans, if they are
- 7 competitively priced and of comparable quality.
- 8 Sec. 206. The director shall take all reasonable steps to
- 9 ensure businesses in deprived and depressed communities compete for
- 10 and perform contracts to provide services or supplies, or both.
- 11 Each director shall strongly encourage firms with which the
- 12 department contracts to subcontract with certified businesses in
- 13 depressed and deprived communities for services or supplies, or
- **14** both.
- Sec. 207. The departments and agencies receiving
- 16 appropriations in part 1 shall prepare a report on out-of-state
- 17 travel expenses not later than January 1 of each year. The travel
- 18 report shall be a listing of all travel by classified and
- 19 unclassified employees outside this state in the immediately
- 20 preceding fiscal year that was funded in whole or in part with
- 21 funds appropriated in the department's budget. The report shall be
- 22 submitted to the house and senate appropriations committees, the
- 23 house and senate fiscal agencies, and the state budget director.
- 24 The report shall include the following information:
- 25 (a) The dates of each travel occurrence.
- 26 (b) The transportation and related costs of each travel
- 27 occurrence, including the proportion funded with state general

- 1 fund/general purpose revenues, the proportion funded with state
- 2 restricted revenues, the proportion funded with federal revenues,
- 3 and the proportion funded with other revenues.
- 4 Sec. 208. Funds appropriated in part 1 shall not be used by a
- 5 principal executive department, state agency, or authority to hire
- 6 a person to provide legal services that are the responsibility of
- 7 the attorney general. This prohibition does not apply to legal
- 8 services for bonding activities and for those outside services that
- 9 the attorney general authorizes.
- 10 Sec. 209. Not later than November 30, the state budget office
- 11 shall prepare and transmit a report that provides for estimates of
- 12 the total general fund/general purpose appropriation lapses at the
- 13 close of the prior fiscal year. This report shall summarize the
- 14 projected year-end general fund/general purpose appropriation
- 15 lapses by major departmental program or program areas. The report
- 16 shall be transmitted to the chairpersons of the senate and house of
- 17 representatives standing committees on appropriations and the
- 18 senate and house fiscal agencies.
- 19 Sec. 211. The department shall cooperate with the department
- 20 of technology, management, and budget to maintain a searchable
- 21 website accessible by the public at no cost that includes, but is
- 22 not limited to, all of the following for each department or agency:
- 23 (a) Fiscal year-to-date expenditures by category.
- 24 (b) Fiscal year-to-date expenditures by appropriation unit.
- (c) Fiscal year-to-date payments to a selected vendor,
- 26 including the vendor name, payment date, payment amount, and
- 27 payment description.

- 1 (d) The number of active department employees by job
- 2 classification.
- 3 (e) Job specifications and wage rates.
- 4 Sec. 212. Within 14 days after the release of the executive
- 5 budget recommendation, the department shall cooperate with the
- 6 state budget office to provide the senate and house appropriations
- 7 chairs, the subcommittees, respectively, and the senate and house
- 8 fiscal agencies with an annual report on estimated state restricted
- 9 fund balances, state restricted fund projected revenues, and state
- 10 restricted fund expenditures for the fiscal years ending September
- 11 30, 2019 and September 30, 2020.
- 12 Sec. 213. The department shall maintain, on a publicly
- 13 accessible website, a department scorecard that identifies, tracks,
- 14 and regularly updates key metrics that are used to monitor and
- 15 improve the agency's performance.
- 16 Sec. 214. Total authorized appropriations from all sources
- 17 under part 1 for legacy costs for the fiscal year ending September
- 18 30, 2020 is \$12,028,500.00. From this amount, total agency
- 19 appropriations for pension-related legacy costs are estimated at
- 20 \$5,847,300.00. Total agency appropriations for retiree health care
- 21 legacy costs are estimated at \$6,181,200.00.
- 22 Sec. 215. The department shall not take disciplinary action
- 23 against an employee for communicating with a member of the
- 24 legislature or his or her staff.
- 25 Sec. 234. The department and agencies receiving appropriations
- 26 in part 1 shall receive and retain copies of all reports funded
- 27 from appropriations in part 1. Federal and state guidelines for

- 1 short-term and long-term retention of records shall be followed.
- 2 The department may electronically retain copies of reports unless
- 3 otherwise required by federal and state guidelines.

## 4 DEPARTMENTAL ADMINISTRATION AND SUPPORT

- 5 Sec. 301. (1) The department may establish a fee schedule and
- 6 collect fees for the following work activities and services:
- 7 (a) Pesticide and plant pest management propagation and
- 8 certification of virus-free foundation stock.
- 9 (b) Fruit and vegetable inspection and grading services at
- 10 shipping and termination points and processing plants.
- 11 (c) Laboratory support analyses of food, livestock, and
- 12 agricultural products for disease, foreign products for disease,
- 13 toxic materials, foreign substances, and quality standards.
- 14 (d) Laboratory support test samples for other state and local
- 15 agencies and public or private organizations.
- 16 (2) The department may receive and expend revenue from the
- 17 fees authorized under subsection (1), subject to appropriation, for
- 18 the purpose of recovering expenses associated with the work
- 19 activities and services described in subsection (1). Fee revenue
- 20 collected by the department under subsection (1) shall not lapse to
- 21 the state general fund at the end of the fiscal year but shall
- 22 carry forward for appropriation by the legislature in the
- 23 subsequent fiscal year.
- 24 (3) The department shall notify the subcommittees, the fiscal
- 25 agencies, and the state budget office 30 days prior to proposing
- 26 changes in fees authorized under this section or under section 5 of

- 1 1915 PA 91, MCL 285.35.
- 2 (4) On or before February 1 of each year, the department shall
- 3 provide a report to the subcommittees, the fiscal agencies, and the
- 4 state budget office detailing all the fees charged by the
- 5 department under the authorization provided in this section,
- 6 including, but not limited to, rates, number of individuals paying
- 7 each fee, and the revenue generated by each fee in the previous
- 8 fiscal year.
- 9 Sec. 302. (1) The department may contract with or provide
- 10 grants to local units of government, institutions of higher
- 11 education, or nonprofit organizations to support activities
- 12 authorized by appropriations in part 1. As used in this section,
- 13 contracts and grants include, but are not limited to, contracts for
- 14 delivery of groundwater/freshwater programs, MAEAP technical
- 15 assistance, forest management, invasive species monitoring,
- 16 wildlife risk mitigation, grants promoting proper pesticide
- 17 disposal, and research grants for the purpose of enhancing the
- 18 agricultural industries in this state.
- 19 (2) The department shall provide notice of contracts or grants
- 20 authorized under this section to the subcommittees, the fiscal
- 21 agencies, and the state budget office not later than 7 days before
- 22 the department notifies contract or grant recipients.

## 23 FOOD AND DAIRY

- 24 Sec. 401. (1) The department shall report on the previous
- 25 fiscal year's activities of the food and dairy division. The report
- 26 shall include information on activities and outcomes of the dairy

- 1 safety and inspection program, the food safety inspection program,
- 2 the foodborne illness and emergency response program, and the food
- 3 service program.
- 4 (2) The report shall include information on significant
- 5 foodborne outbreaks and emergencies, including any significant
- 6 enforcement actions taken related to food safety during the prior
- 7 calendar year.
- 8 (3) The report shall be transmitted to the subcommittees, the
- 9 fiscal agencies, and the state budget office and posted to the
- 10 department's website on or before April 1 of each year.

## 11 ANIMAL INDUSTRY

- 12 Sec. 451. From the funds appropriated in part 1 for bovine
- 13 tuberculosis, the department shall pay for all whole herd testing
- 14 costs and individual animal testing costs in the modified
- 15 accredited zone to maintain split-state status requirements. These
- 16 costs include indemnity and compensation for injury causing death
- 17 or downer to animals.
- 18 Sec. 452. (1) The department shall report on the previous
- 19 calendar year's activities of the animal industry division. The
- 20 report shall be transmitted to the subcommittees, the fiscal
- 21 agencies, and the state budget office and posted to the
- 22 department's website on or before April 1 of each year.
- 23 (2) The department shall include in the report all
- 24 indemnification payments for livestock depredation made in the
- 25 previous calendar year and shall include all of the following:
- 26 (a) The reason for the indemnification.

- 1 (b) The amount of the indemnification.
- 2 (c) The person for whom the indemnification was paid.
- 3 Sec. 454. The department shall use its resources to
- 4 collaborate with the USDA to monitor bovine TB, consistent with the
- 5 May 2016 memorandum of understanding between the department and the
- 6 USDA.
- 7 Sec. 457. (1) On or before October 15, 2019, the department
- 8 shall provide to the subcommittees, the fiscal agencies, and the
- 9 state budget office a report on bovine TB status and department
- 10 activities.
- 11 (2) For each fiscal quarter following the report required in
- 12 subsection (1), the department shall provide an update to the
- 13 subcommittees, the fiscal agencies, and the state budget office.
- 14 The quarterly update reports shall identify significant impacts to
- 15 the program, including new incidence of bovine TB in this state,
- 16 department activity associated with specific new incidence of
- 17 bovine TB, any changes in USDA requirements or movement orders, and
- 18 information and data on wildlife risk mitigation plan
- 19 implementation in the modified accredited zone; implementation of a
- 20 movement certificate process; progress toward annual surveillance
- 21 test requirements; efforts to work with slaughter facilities in
- 22 this state, as well as those that slaughter a significant number of
- 23 animals from this state; educational programs and information for
- 24 this state's livestock community; and any other item the
- 25 legislature should be aware of that will promote or hinder efforts
- 26 to achieve bovine TB-free status for this state.

## 1 PESTICIDE AND PLANT PEST MANAGEMENT

- 2 Sec. 501. The department shall report on the previous calendar
- 3 year's activities of the pesticide and plant pest management
- 4 division. The report shall be transmitted to the subcommittees, the
- 5 fiscal agencies, and the state budget office and posted to the
- 6 department's website on or before April 1 of each year.

## ENVIRONMENTAL STEWARDSHIP

- 8 Sec. 601. The funds appropriated in part 1 for environmental
- 9 stewardship/MAEAP shall be used to support department agriculture
- 10 pollution prevention programs, including groundwater and freshwater
- 11 protection programs under part 87 of the Michigan natural resources
- 12 and environmental protection act, 1994 PA 451, MCL 324.8701 to
- 13 324.8717, and technical assistance in implementing conservation
- 14 grants available under the federal farm bill of 2014.
- 15 Sec. 602. The department shall report on the previous calendar
- 16 year's activities of the environmental stewardship division. The
- 17 report shall be transmitted to the subcommittees, the fiscal
- 18 agencies, and the state budget office and posted to the
- 19 department's website on or before April 1 of each year.
- 20 Sec. 608. (1) The appropriations in part 1 for the qualified
- 21 forest affidavit program are for the purpose of increasing the
- 22 knowledge of nonindustrial private forestland owners of sound
- 23 forest management practices and increasing the amount of commercial
- 24 timber production from those lands.
- 25 (2) The department shall work in partnership with stakeholder
- 26 groups and other state and federal agencies to increase the active

- 1 management of nonindustrial private forestland to foster the growth
- 2 of Michigan's timber product industry.

## 3 LABORATORY PROGRAM

- 4 Sec. 651. The department shall report on the previous calendar
- 5 year's activities of the laboratory division. The report shall be
- 6 transmitted to the subcommittees, the fiscal agencies, and the
- 7 state budget office and posted to the department's website on or
- 8 before April 1 of each year.

## AGRICULTURE DEVELOPMENT

- Sec. 701. (1) From the funds appropriated in part 1 for the
- 11 food and agriculture investment program, the department shall
- 12 establish and administer a food and agriculture investment program.
- 13 (2) The food and agriculture investment program shall expand
- 14 the Michigan food and agriculture sector, grow Michigan exports,
- 15 promote the development of value-added agricultural production,
- 16 food hubs, food incubators, and community-based processing
- 17 facilities, and the expansion of farm markets and urban
- 18 agriculture, and increase food processing activities within the
- 19 state by accelerating projects and infrastructure development that
- 20 support growth in the food and agriculture processing industry.
- 21 (3) In addition to the funds appropriated in part 1, the
- 22 department may receive and expend funds received from outside
- 23 sources for the food and agriculture investment program.
- 24 (4) Before the allocation of funding, all projects shall
- 25 receive approval from the Michigan commission of agriculture and

- 1 rural development, except for projects selected through a
- 2 competitive process by a joint evaluation committee selected by the
- 3 director and consisting of representatives that have agriculture,
- 4 business, and economic development expertise. Projects funded
- 5 through the food and agriculture investment program will be
- 6 required to have a grant agreement that outlines milestones and
- 7 activities that must be met in order to receive a disbursement of
- 8 funds. Projects must also identify measurable project outcomes.
- 9 (5) The department shall include in the agriculture
- 10 development annual report a report on the food and agriculture
- 11 investment program for the previous fiscal year that includes a
- 12 listing of the grantees, award amounts, match funding, project
- 13 locations, and project outcomes.
- 14 (6) The food and agriculture investment program shall be
- 15 administered by the department and provide support for food and
- 16 agriculture projects that will enable growth in the industry and
- 17 this state's economy.
- 18 (7) The unexpended funds appropriated in part 1 for the food
- 19 and agriculture investment program are designated as a work project
- 20 appropriation, and any unencumbered or unallotted funds shall not
- 21 lapse at the end of the fiscal year and shall be available for
- 22 expenditures for projects under this section until the projects
- 23 have been completed. The following is in compliance with section
- 24 451a(1) of the management and budget act, 1984 PA 431, MCL
- **25** 18.1451a:
- 26 (a) The purpose of the project is to promote and expand the
- 27 Michigan food and agriculture sector, grow Michigan exports, and

- 1 increase food processing activities within the state.
- 2 (b) The project will be funded in accordance with this section
- 3 and the project guidelines approved by the Michigan agriculture
- 4 commission prior to an award.
- 5 (c) The estimated cost of this project is identified in the
- 6 appropriation line item.
- 7 (d) The tentative completion date for the work project is
- 8 September 30, 2022.
- 9 (8) The department may expend money from the funds
- 10 appropriated in part 1 for the food and agriculture investment
- 11 program, including all of the following activities:
- 12 (a) Grants.
- 13 (b) Loans or loan guarantees.
- 14 (c) Infrastructure development.
- (d) Other economic assistance.
- 16 (e) Program administration.
- 17 (f) Export assistance.
- 18 (9) The department shall expend no more than 10% from the
- 19 funds appropriated in part 1 for the food and agriculture
- 20 investment program for administrative purposes.
- 21 Sec. 706. (1) The department shall report on the previous
- 22 calendar year's activities of the agriculture development division.
- 23 The report shall be transmitted to the subcommittees, the fiscal
- 24 agencies, and the state budget office and posted to the
- 25 department's website on or before April 1 of each year.
- 26 (2) The report shall include the following information on any
- 27 grants awarded during the prior fiscal year:

- 1 (a) The name of the grantee.
- 2 (b) The amount of the grant.
- 3 (c) The purpose of the grant, including measurable outcomes.
- 4 (d) Additional state, federal, private, or local funds
- 5 contributed to the grant project.
- 6 (e) The completion date of grant-funded activities.
- 7 (3) The report shall include the following information on the
- 8 Michigan craft beverage council established under section 303 of
- 9 the Michigan liquor control code of 1998, 1998 PA 58, MCL 436.1303:
- 10 (a) Council activities and accomplishments for the previous
- 11 fiscal year.
- 12 (b) Council expenditures for the previous fiscal year by
- 13 category of administration, industry support, research and
- 14 education grants, and promotion and consumer education.
- 15 (c) Grants awarded during the previous fiscal year and the
- 16 results of research grant projects completed during the previous
- 17 fiscal year.

## 18 FAIRS AND EXPOSITIONS

- 19 Sec. 801. All appropriations from the agriculture equine
- 20 industry development fund shall be spent on equine-related
- 21 purposes. No funds from the agriculture equine industry development
- 22 fund shall be expended for nonequine-related purposes without prior
- 23 approval of the legislature.
- 24 Sec. 802. From the funds appropriated in part 1 from
- 25 agriculture equine industry development funds, available revenue
- 26 shall be allocated in the following priority order:

- 1 (a) To support all administrative, contractual, and regulatory
- 2 costs incurred by the department and the Michigan gaming control
- 3 board.
- 4 (b) Any remaining funds collected through September 30, 2020,
- 5 after the obligations in subdivision (a) have been met, shall be
- 6 prorated equally among the supplements, including the fairs and
- 7 licensed tracks, breeders' awards, and sire stakes awards to
- 8 eligible race meeting licensees in accordance with section 20 of
- 9 the horse racing law of 1995, 1995 PA 279, MCL 431.320.
- 10 Sec. 805. (1) The department shall establish and administer a
- 11 county fairs, shows, and expositions grant program. The program
- 12 shall have the following objectives:
- 13 (a) Assist in the promotion of building improvements or other
- 14 capital improvements at county fairgrounds of the state.
- 15 (b) Provide financial support, promotion, prizes, and premiums
- 16 of equine, livestock, and other agricultural commodity expositions
- 17 in the state.
- 18 (2) The department shall award grants on a competitive basis
- 19 to county fairs or other organizations from the funds appropriated
- 20 in part 1 for county fairs, shows, and expositions grants. Grantees
- 21 will be required to provide a 50% cash match with grant awards and
- 22 identify measurable project outcomes. A county fair organization
- 23 that received a county fair capital improvement grant in the prior
- 24 fiscal year shall not receive a grant from the appropriation in
- **25** part 1.
- 26 (3) From the amount appropriated in part 1 for county fairs,
- 27 shows, and expositions, up to \$25,000.00 shall be expended for the

- 1 purpose of financial support, promotion, prizes, and premiums of
- 2 equine, livestock, and other agricultural commodity expositions in
- 3 this state, and festivals.
- 4 (4) From the amount appropriated in part 1 for county fairs,
- 5 shows, and expositions, \$50,000.00 shall be expended for the
- 6 promotion of festivals in the state.
- 7 (5) All fairs receiving grants under this section shall
- 8 provide a report to the department on the financial impact
- 9 resulting from the capital improvement project on both fair and
- 10 nonfair events. These reports are due for 3 years immediately
- 11 following the completion of the capital improvement project.
- 12 (6) The department shall identify criteria, evaluate
- 13 applications, and provide recommendations to the director for final
- 14 approval of grant awards.
- 15 (7) The department may expend money from the funds
- 16 appropriated in part 1 for the county fairs, shows, and expositions
- 17 grants for administering the program.
- 18 (8) The unexpended portion of the county fairs, shows, and
- 19 expositions grants is considered a work project appropriation in
- 20 accordance with section 451a of the management and budget act, 1984
- 21 PA 431, MCL 18.1451a. The following apply to the project:
- 22 (a) The purpose of the project is to support building
- 23 improvements or other capital improvements at county fairgrounds of
- 24 the state.
- 25 (b) All grants will be distributed in accordance with this
- 26 section and the grant guidelines published prior to the request for
- 27 proposals.

- 1 (c) The estimated cost of the project is identified in the
- 2 appropriation line item.
- 3 (d) The tentative completion date for the work project is
- 4 September 30, 2020.
- 5 (9) The department shall provide a year-end report on the
- 6 county fairs, shows, and expositions grants no later than December
- 7 1, 2020 to the subcommittees, the fiscal agencies, and the state
- 8 budget director that includes a listing of the grantees, award
- 9 amounts, match funding, and project outcomes.

## ONE-TIME APPROPRIATIONS

- 11 Sec. 901. The amount appropriated in part 1 for conservation
- 12 districts pilot project shall be distributed in equal amounts to
- 13 each conservation district in the state, to be used to develop a
- 14 natural resources assessment. The assessment shall describe the
- 15 conservation district and identify, at a minimum, the top 5 natural
- 16 resources needs for each district. The funds shall also be used for
- 17 the development of a business plan on how the conservation district
- 18 will implement the programs and services necessary to meet the top
- 19 5 natural resource needs in the district. Conservation districts
- 20 shall submit their natural resources assessment and business plans
- 21 to the department and subcommittees by September 30, 2020.
