A bill to amend 1978 PA 368, entitled "Public health code,"

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 17744b. (1) Notwithstanding any provision of this act to the contrary, a prescriber may issue a prescription for and a dispensing prescriber or pharmacist may dispense an opioid antagonist to any of the following:
- 5 (a) An individual patient at risk of experiencing an opioid-6 related overdose.
- 7 (b) A family member, friend, or other individual in a position8 to assist an individual at risk of experiencing an opioid-related

- 2 (c) A school board for purposes of section 1179b of the
 3 revised school code, 1976 PA 451, MCL 380.1179b.
- 4 (c) (d) A person other than an individual that meets all of
 5 the following requirements:
- $\mathbf{6}$ (i) Acts at the direction of the prescriber or dispensing $\mathbf{7}$ prescriber.
- $\mathbf{8}$ (ii) Upon receipt of an opioid antagonist, stores the opioid $\mathbf{9}$ antagonist in compliance with this part.
 - (iii) Dispenses or administers an opioid antagonist under a valid prescription issued to an individual or a patient.
- (iv) Performs the requirements under this subsection without charge or compensation.
 - (d) An agency authorized to purchase, possess, and distribute an opioid antagonist under the administration of opioid antagonists act.
 - (2) When issuing a prescription for or dispensing an opioid antagonist as authorized under this section to a school board an agency described in subsection (1)(d) or a person other than a patient, the prescriber, dispensing prescriber, or pharmacist, as appropriate, shall insert the name of the school board agency or the person as the name of the patient.
 - (3) Notwithstanding any provision of this act to the contrary, a person that is acting in good faith and with reasonable care may possess and dispense an opioid antagonist.
 - (4) Notwithstanding any provision of this act to the contrary, a school employee who is a licensed registered professional nurse or who is trained in the administration of an opioid antagonist under section 1179b of the revised school code, 1976 PA 451, MCL

- 1 380.1179b, may possess and administer an opioid antagonist
 2 dispensed to a school board under this section.
- 3 (4) Notwithstanding any provision of this act to the contrary, 4 an employee or agent of an agency described in subsection (1)(d) 5 may, subject to section 105 of the administration of opioid 6 antagonists act, possess and administer an opioid antagonist 7 dispensed to the agency under this section.
- 9 prescriber or pharmacist who dispenses an opioid antagonist as
 10 authorized under this section is not liable in a civil action for a
 11 properly stored and dispensed opioid antagonist that was a
 12 proximate cause of injury or death to an individual due to the
 13 administration of or failure to administer the opioid antagonist.
