## **SENATE BILL NO. 440**

August 20, 2019, Introduced by Senator IRWIN and referred to the Committee on Appropriations.

A bill to amend 1993 PA 23, entitled "Michigan limited liability company act,"

by amending section 1101 (MCL 450.5101), as amended by 2018 PA 380.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1101. (1) The fees to be paid to the administrator when
- 2 the documents described in this subsection are delivered to him or
- 3 her for filing are as follows:
- 4 (a) Certificate of correction, \$25.00.
- 5 (b) Articles of organization, \$50.00.

- 27 (2) In addition to a fee required to file a document, the
- 28 administrator may charge a fee of \$50.00 if the document is filed

- is requested to transmit a document by facsimile or otherelectronic transmission.
- 3 (3) The administrator shall not refund all or any part of a
  4 fee described in this section. The administrator shall deposit all
  5 fees received and collected under this section in the state
  6 treasury to the credit of the administrator, who may only use the
  7 money credited pursuant to legislative appropriation and only in
  8 carrying out those duties of the department required by law.
- 9 (4) A minimum charge of \$1.00 for each certificate and 50 10 cents per folio shall be paid to the administrator for certifying a 11 part of a file or record pertaining to a domestic or foreign 12 limited liability company if a fee is not set forth in subsection (1). The administrator may furnish copies of documents, reports, 13 14 and papers required or permitted by law to be filed with the 15 administrator, and shall charge for those copies pursuant to a 16 schedule of fees that the administrator shall adopt with the 17 approval of the state administrative board. The administrator shall retain the revenue collected under this subsection and use it to 18 19 defray the costs of the department's copying and certifying services. 20
- (5) If a domestic or foreign limited liability company pays fees or penalties by check and the check is dishonored, the fee is considered unpaid and the filing of all related documents will be rescinded.

- (6) The administrator may accept payment by credit card, instead of cash or check, as payment of a fee under this act. The administrator shall determine which credit cards he or she shall accept for payment of a fee.

- 1 under subsection (1) for filing initial articles of organization if
- 2 a majority of the initial membership interests in the domestic
- 3 limited liability company will be held by veterans.
- 4 (8) To request a fee waiver under subsection (7), the person
- 5 that is submitting the initial articles of organization for filing
- 6 shall submit both of the following to the administrator with that
- 7 document:
- 8 (a) A signed affidavit requesting the fee waiver and
- 9 certifying that a majority of the initial membership interests in
- 10 the domestic limited liability company will be held by veterans.
- 11 (b) Copies of form DD214 or form DD215, or any other form that
- 12 is satisfactory to the department, for each veteran who will be an
- 13 initial member of the limited liability company.
- 14 (9) The administrator shall waive any fee otherwise required
- 15 under this section if a majority of the membership interests in the
- 16 domestic or foreign limited liability company responsible for
- 17 paying the fee are, and the domestic or foreign limited liability
- 18 company provides proof satisfactory to the administrator that those
- 19 interests are, held by veterans. This subsection does not apply to
- 20 the fee for filing initial articles of organization.
- 21 (10) As used in this section, "veteran" means that term as
- 22 defined in section 1 of 1965 PA 190, MCL 35.61.
