- 17 (7) An investment adviser representative who is registered as

- 19 registered as a broker-dealer under section 401 and registered as
- 20 an investment adviser under section 403 or required as a federal
- 21 covered investment adviser to make a notice filing under section
- 22 405 is not required to pay an initial or annual registration fee
- 23 for registration as an investment adviser representative.
