December 05, 2019, Introduced by Senators LUCIDO, IRWIN, BAYER, POLEHANKI, ALEXANDER, CHANG, GEISS, BULLOCK, MCMORROW and SANTANA and referred to the Committee on Judiciary and Public Safety.

A bill to amend 1939 PA 288, entitled
"Probate code of 1939,"
by amending section 28 of chapter XIIA (MCL 712A.28), as amended by
1998 PA 478.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 CHAPTER XIIA
2 Sec. 28. (1) Before June 1, 1988, the court shall maintain
3 records of all cases brought before it and as provided in the
4 juvenile diversion act. The records shall be open only by court

1 order to persons having a legitimate interest, except that
 2 diversion records shall be open only as provided in the juvenile
 3 diversion act.

4 (2) Beginning June 1, 1988, the court shall maintain records
 5 of all cases brought before it and as provided in the juvenile
 6 diversion act. Except as otherwise provided in this subsection,
 7 **until December 31, 2020**, records of a case brought before the court
 8 ~~shall be~~**are** open to the general public. Diversion records ~~shall be~~
 9 **are** open only as provided in the juvenile diversion act. Except as
 10 otherwise provided in section 49 of the **William Van Regenmorter**
 11 crime victim's rights act, 1985 PA 87, MCL 780.799, if the hearing
 12 of a case brought before the court is closed under section 17 of
 13 this chapter, the records of that hearing ~~shall be~~**are** open only by
 14 court order to persons having a legitimate interest.

15 (3) **Beginning January 1, 2021, records of a case brought**
 16 **before the court are not open to the general public. Diversion**
 17 **records are open only as provided in the juvenile diversion act.**
 18 **Except as otherwise provided in section 49 of the William Van**
 19 **Regenmorter crime victim's rights act, 1985 PA 87, MCL 780.799, if**
 20 **the hearing of a case brought before the court is closed under**
 21 **section 17 of this chapter, the records of that hearing are open**
 22 **only by court order to persons having a legitimate interest.**

23 (4) ~~(3)~~ If the court issues an order in respect to payments by
 24 a parent under section 18(2) of this chapter, a copy ~~shall~~**must** be
 25 mailed to the department of treasury. Action taken against parents
 26 or adults shall not be released for publicity unless the parents or
 27 adults are found guilty of contempt of court. The court shall
 28 furnish the ~~family independence agency~~**department** and a county
 29 juvenile agency with reports of the administration of the court in

1 a form recommended by the ~~Michigan association of probate and~~
2 ~~juvenile court judges.~~ **Michigan Probate Judges Association.** Copies
3 of these reports shall, upon request, be made available to other

13 **investigation of child neglect or child abuse, law enforcement**
14 **personnel, a prosecutor, and a court of this state.**
