SUBSTITUTE FOR SENATE BILL NO. 970

A bill to amend 1993 PA 327, entitled "Tobacco products tax act,"

by amending sections 2 and 11 (MCL 205.422 and 205.431), section 2 as amended by 2012 PA 188 and section 11 as amended by 2016 PA 86.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2. As used in this act:
 - (a) "Cigar" means any roll of tobacco wrapped in leaf tobacco or in any substance containing tobacco. Cigar does not include a cigarette.
- (b) (a)—"Cigarette" means a roll for smoking made wholly or in part of tobacco, irrespective of size or shape and irrespective of the tobacco being flavored, adulterated, or mixed with any other ingredient, which roll has a wrapper or cover made of paper or any

- 1 other material. Cigarette does not include cigars.
- 2 (c) (b)—"Cigarette making machine" means any machine or other
 3 mechanical device which meets all of the following criteria:
- 4 (i) Is capable of being loaded with loose tobacco, cigarette
 5 tubes or cigarette papers, and any other components related to the
 6 production of cigarettes, including, but not limited to, cigarette
 7 filters.
- 8 (ii) Is designed to automatically or mechanically produce,9 roll, fill, dispense, or otherwise generate cigarettes.
- 10 (iii) Is commercial-grade or otherwise designed or suitable for
 11 commercial use.
- 12 (iv) Is designed to be powered or otherwise operated by a main or primary power source other than human power.
 - (d) (c) "Commissioner" means the state treasurer.
 - (e) "Container" or "shipping case" means an individual receptacle within which a tobacco product or group of tobacco products is placed for shipment, storage, or distribution, such as a box, case, or tote. A container or shipping case does not include any of the following:
- 20 (i) An individual package of cigarettes or cigarette carton 21 containing cigarettes that are not counterfeit cigarettes.
- 22 (ii) Except for counterfeit cigarettes, the package or other 23 article containing the tobacco product that is sold or transferred 24 directly to the ultimate consumer.
- 25 (iii) A bag or similar package containing bulk or loose hookah 26 tobacco, pipe tobacco, or roll-your-own cigarette tobacco that a 27 retailer uses to fill bins, barrels, or tubs located at the 28 retailer's place of business from which either the retailer sells a 29 specified quantity of those tobacco products or a blend or mixture

- of those tobacco products to the consumer, or the consumer removes or draws a specified quantity of those tobacco products or a blend
- 3 or mixture of those tobacco products for purchase at retail from 4 the retailer.
- 5 (iv) A pallet or similar article or device upon which an
 6 individual receptacle or group of receptacles, containing the
 7 tobacco products, is placed for shipment, storage, or distribution.
 - (ν) Property used as a protective covering for, or to keep together during shipment, storage, or distribution, a receptacle or group of receptacles within which the tobacco product is placed for shipment, storage, or distribution including shrink wrap or other wrapping materials, but excluding the protective covering which forms, gives shape to, or otherwise constitutes the receptacle within which the tobacco product is placed for shipment, storage, or distribution.
 - (f) (d)—"Counterfeit cigarette" means a cigarette in an individual package of cigarettes or other container with a false manufacturing label or a cigarette in an individual package of cigarettes or other container with a counterfeit stamp.
 - (g) (e)—"Counterfeit cigarette paper" means a cigarette paper with a false manufacturing label or that has not been printed, manufactured, or made by authority of the trademark owner.
 - (h) (f)—"Counterfeit stamp" means any stamp, label, or print, indicium, or character, that evidences, or purports to evidence, the payment of any tax levied under this act and that has not been printed, manufactured, or made by authority of the department as provided in this act and has not been issued, sold, or circulated by the department.
 - (i) (g) "Department" means the department of treasury.

- 1 (j) (h) "Financially sound" means a determination by the
 2 department that the wholesaler or unclassified acquirer is able to
 3 pay for its stamps the tax due on the tobacco products it sells,
 4 imports, or acquires, as applicable, in the ordinary course of
 5 business based on criteria including, but not limited to, all of
 6 the following:
- 7 (i) Past filing and payment history with the department.
- 8 (ii) Outstanding liabilities.
- 9 (iii) Review of current financial statements including, but not 10 limited to, balance sheets and income statements.
- 11 (iv) Duration that the wholesaler or unclassified acquirer has 12 been licensed under this act.
 - (v) Ability to pay for its stamps, if required under this act.
 - (k) (i)—"Gray market cigarette" means any cigarette the package of which bears any statement, label, stamp, sticker, or notice indicating that the manufacturer did not intend the cigarettes to be sold, distributed, or used in the United States, including, but not limited to, a label stating "For Export Only", "U.S. Tax Exempt", "For Use Outside U.S.", or similar wording.
 - (1) (j)—"Gray market cigarette paper" means any cigarette paper the package of which bears any statement, label, stamp, sticker, or notice indicating that the manufacturer did not intend the cigarette papers to be sold, distributed, or used in the United States, including, but not limited to, a label stating "For Export Only", "U.S. Tax Exempt", "For Use Outside U.S.", "For Use in _____ (another country) Only", or similar wording.
 - (m) "Hookah tobacco" means tobacco that is designed, manufactured, or otherwise intended for consumption by smoking in a hookah and that is flavored with honey, molasses, fruit, or other

- 1 natural or artificial flavors. Hookah tobacco includes those
- 2 products commonly known or referred to as narghile, argileh,
- 3 shisha, hubble-bubble, molasses tobacco, waterpipe tobacco,
- 4 maassel, or goza.
- 5 (n) "Hookah" means a device, including a waterpipe, used for 6 smoking hookah tobacco that consists of a tube connected to a
- 7 chamber where the smoke is cooled passing through water.
- 8 (o) (k)—"Individual package" means an individual packet or
- 9 pack used to contain or to convey cigarettes to the consumer.
- 10 Individual package does not include cartons, cases, or shipping or

 11 tobacco, what is commonly known as a fruit bowl or fruit head for
 12 use in a hookah.
 - (C) Rolls a cigar for his or her own self-consumption.
- (r) (n) "Noncigarette smoking tobacco" means tobacco sold in
 loose or bulk form that is intended for consumption by smoking and
 also includes roll-your-own cigarette tobacco, hookah tobacco, pipe
 tobacco, or a wrap.
- 18 (s) (o) "Person" means an individual, partnership, fiduciary,
 19 association, limited liability company, corporation, or other legal
 20 entity.
- 21 (t) "Pipe tobacco" means any tobacco that, because of its
 22 appearance, type, packaging, or labeling, is suitable for use and
 23 likely to be offered to, or purchased by, consumers as tobacco to
 24 smoke in a pipe.
- 25 (u) (p) "Place of business" means a place where a tobacco
 26 product is sold or where a tobacco product is brought or kept for
 27 the purpose of sale or consumption, including a vessel, airplane,
 28 train, or vending machine.
- 29 (v) $\frac{(q)}{(q)}$ "Retailer" means a person other than a transportation

- 1 company who operates a place of business in this state, or who
- 2 directs, manages, or has control over the day-to-day operations of
- 3 a place of business in this state, for the purpose of making sales
- 4 of a tobacco product at retail. A person described in this
- 5 subdivision qualifies as a retailer regardless of whether that
- 6 person owns the place of business.
- 7 (w) "Roll-your-own cigarette tobacco" means any tobacco which,
- 8 because of its appearance, type, packaging, or labeling, is
- 9 suitable for use and likely to be offered to, or purchased by,
- 10 consumers as tobacco for making cigarettes.
- 11 (x) (r) "Sale" means a transaction by which the ownership of
- 12 tangible personal property is transferred for consideration and
- 13 applies also to use, gifts, exchanges, barter, and theft.
- 14 (y) (s) "Secondary wholesaler" means a person who sells a
- 15 tobacco product for resale, who purchases a tobacco product from a
- 16 wholesaler or unclassified acquirer licensed under this act, and
- 17 who maintains an established place of business in this state where
- 18 a substantial portion of the business is the sale of tobacco
- 19 products and related merchandise at wholesale, and where at all
- 20 times a substantial stock of tobacco products and related
- 21 merchandise is available to retailers for resale.
- 22 (z) (t) "Smokeless tobacco" means snuff, snus, chewing
- 23 tobacco, moist snuff, and any other tobacco that is intended to be
- 24 used or consumed, whether heated, chewed, absorbed, dissolved,
- 25 inhaled, snorted, sniffed, or ingested, by any means other than
- 26 smoking or combustion.
- 27 (aa) (u) "Stamp" means a distinctive character, indication, or
- 28 mark, as determined by the department, attached or affixed to an
- 29 individual package of cigarettes by mechanical device or other

- means authorized by the department to indicate that the tax imposedunder this act has been paid.
- 8 (cc) (w)—"Tobacco product" means a product containing any
 9 amount of tobacco regardless of form including, but not limited to,
 10 cigarettes, cigars, noncigarette smoking tobacco, or smokeless
 11 tobacco. A tobacco product does not include drugs, devices, or
 12 combination products authorized for sale by the United States Food
 13 and Drug Administration, as those terms are defined in the federal
 14 food, drug, and cosmetic act, 21 USC 351 to 360fff-7.
- (dd) (x) "Transportation company" means a person operating, or supplying to common carriers, cars, boats, or other vehicles for the transportation or accommodation of passengers and engaged in the sale of a tobacco product at retail.
 - (ee) (y)—"Transporter" means a person importing or transporting into this state, or transporting in this state, a tobacco product obtained from a source located outside this state, or from any person not duly licensed under this act. Transporter does not include an interstate commerce carrier licensed by the interstate commerce commission, or its successor federal agency, to carry commodities in interstate commerce, or a licensee maintaining a warehouse or place of business outside of this state if the warehouse or place of business is licensed under this act.
- 28 (ff) (z) "Unclassified acquirer" means a person, except a
 29 transportation company or a purchaser at retail from a retailer

- 1 licensed under the general sales tax act, 1933 PA 167, MCL 205.51
- 2 to 205.78, who imports or acquires a tobacco product from a source
- 3 other than a wholesaler or secondary wholesaler licensed under this
- 4 act for use, sale, or distribution in this state. Unclassified
- 5 acquirer also means a person who purchases or receives cigars,
- 6 noncigarette smoking tobacco, or smokeless tobacco products

- 23 reductions.in order to acquire that tobacco product from the
- 24 seller. The wholesale price includes any tax, fee, licensing, or

- 29 wholesaler, secondary wholesaler, or unclassified acquirer other

- 1 than a manufacturer at the time of purchase or acquisition.
- 2 (b) The license described in subdivision (a) was not expired 3 at the time the tobacco product was purchased or otherwise acquired 4 by the retailer.
- 5 (c) The copy of the license is preserved by the retailer in 6 the same manner, for the same period of time, and offered for 7 inspection as required of other statements and records under 8 section 6.
 - (5) Notwithstanding anything in this act to the contrary, a licensee may provide a copy of its license to a retailer for purposes of this section. A retailer that obtains a copy of the license for a particular licensee under this section is not required to obtain another copy of the license for subsequent purchases or acquisitions of tobacco products from that licensee which are made during the active license year and prior to the expiration of that license.
 - (6) (2) All Subject to subsection (1), all sales conducted through the Internet, internet, by telephone, or in a mail-order transaction shall not be completed unless, before each delivery of cigarettes tobacco products is made, whether through the mail, through a transportation company, or through any other delivery system, the seller has obtained from the purchaser an affirmation that includes a copy of a valid government-issued document that confirms the purchaser's name, address, and date of birth showing that the purchaser is at least the legal minimum age to purchase cigarettes; tobacco products; that the cigarettes tobacco products purchased are not intended for consumption by an individual who is younger than the legal minimum age to purchase cigarettes; tobacco products; and a written statement signed by the purchaser that

affirms the purchaser's address and that the purchaser is at least 1 the minimum legal age to purchase cigarettes. tobacco products. The 2 statement shall also confirm that the purchaser understands that 3 signing another person's name to the affirmation is illegal; that 4 5 the sale of cigarettes tobacco products to individuals under the 6 legal minimum purchase age is illegal; and that the purchase of 7 cigarettes tobacco products by individuals under the legal minimum 8 purchase age is illegal under the laws of the state of Michigan. 9 The seller shall verify the information contained in the 10 affirmation provided by the purchaser against a commercially 11 available database of governmental records, or obtain a photocopy, 12 fax copy, or other image of the valid, government-issued identification stating the date of birth or age of the purchaser. 13 14 (7) (3) All Subject to subsection (1), all invoices, bills of 15 lading, sales receipts, or other documents related to cigarette 16 tobacco product sales conducted through the internet, by telephone, 17 or in a mail-order transaction shall contain the current seller's 18 valid Michigan sales tax registration number, license number or use 19 tax registration number, business name and address of the seller, 20 and a statement as to whether all sales taxes or use taxes, as applicable, and taxes levied under this act have been paid. All 21 22 packages of cigarettes tobacco products shipped from a cigarette 23 tobacco product seller to purchasers who reside in Michigan shall 24 clearly print or stamp the package with the word "CIGARETTES" 25 "TOBACCO PRODUCTS" on the outside of all sides of the package so it is clearly visible to the shipper. In addition, the package shall 26 27 contain an externally visible and clearly legible notice located on the same side of the package as the address to which the package is 28

delivered, as follows:

1	"IF THESE CIGARETTES HAVE BEEN SHIPPED TO YOU FROM A SELLER
2	LOCATED OUTSIDE OF THE STATE IN WHICH YOU RESIDE, THE SELLER HAS
3	REPORTED UNDER FEDERAL LAW THE SALE OF THESE CIGARETTES TO OUR
4	STATE TAX COLLECTION AGENCY, INCLUDING YOUR NAME AND ADDRESS. YOU
5	ARE LEGALLY RESPONSIBLE FOR ALL APPLICABLE UNPAID STATE TAXES ON
6	THESE CIGARETTES."

- If an order is made as a result of advertisement over the Internet, internet, the tobacco retailer shall request the electronic mail address of the purchaser and shall receive payment by credit card or check before shipping. completing the sale. This subsection and subsection (2) do does not apply to sales by wholesalers and unclassified acquirers licensed under this act.
- (8) (4)—The deliverer of the cigarettes—tobacco products is required to obtain proof from a valid government—issued document that the person signing for the cigarettes—tobacco products is the purchaser.
- (9) (5)—Beginning November 1, 2012, a retailer that is not licensed as an unclassified acquirer, retail importer of tobacco products other than cigarettes, not otherwise licensed or required to be licensed under this act shall post a sign, visible to the public inside the retail establishment that informs purchasers of cigars through catalog sales, telephone or mail orders, or Internet internet sales of their responsibility to pay all liability for any applicable unpaid state taxes on those cigars and that cigars purchased in violation of this act are contraband.
 - (10) $\frac{(6)}{(6)}$ As used in this section:
- (a) "Computer" means any connected, directly interoperable or
 interactive device, equipment, or facility that uses a computer
 program or other instructions to perform specific operations,

- 20 defined in section 1a of the mortgage brokers, lenders, and
- 21 services licensing act, 1987 PA 173, MCL 445.1651a, under a credit
- 22 card arrangement.
- 23 (f) "Device" includes, but is not limited to, an electronic,
- 24 magnetic, electrochemical, biochemical, hydraulic, optical, or
- 25 organic object that performs input, output, or storage functions by
- 26 the manipulation of electronic, magnetic, or other impulses.
- 27 (g) "Internet" means the connection to the World Wide Web
- 28 through the use of a computer, a computer network, or a computer
- 29 system.

1 (h) "Sale conducted through the Internet" internet" means a
2 sale of, a solicitation to sell, a purchase of, or an offer to
3 purchase eigarettes tobacco products conducted all or in part by
4 accessing an Internet internet website.
5 Enacting section 1. This amendatory act takes effect January
6 1, 2022.
