SUBSTITUTE FOR SENATE BILL NO. 1244

A bill to amend 1964 PA 170, entitled

"An act to make uniform the liability of municipal corporations, political subdivisions, and the state, its agencies and departments, officers, employees, and volunteers thereof, and members of certain boards, councils, and task forces when engaged in the exercise or discharge of a governmental function, for injuries to property and persons; to define and limit this liability; to define and limit the liability of the state when engaged in a proprietary function; to authorize the purchase of liability insurance to protect against loss arising out of this liability; to provide for defending certain claims made against public officers, employees, and volunteers and for paying damages sought or awarded against them; to provide for the legal defense of public officers, employees, and volunteers; to provide for reimbursement of public officers and employees for certain legal expenses; and to repeal acts and parts of acts,"

by amending section 8 (MCL 691.1408), as amended by 2002 PA 400.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 8. (1) Whenever If a claim is made or a civil action is 1 2 commenced against an officer, employee, or volunteer of a 3 governmental agency for injuries to persons or property caused by 4 negligence of the officer, employee, or volunteer while in the 5 course of employment with or actions acting on behalf of the 6 governmental agency and while acting within the scope of his or her 7 authority, the governmental agency may pay for, engage, or furnish the services of an attorney to advise the officer, employee, or 8 9 volunteer as to the claim and to appear for and represent the 10 officer, employee, or volunteer in the action. The governmental 11 agency may compromise, settle, and pay the claim before or after 12 the commencement of a civil action. Whenever If a judgment for 13 damages is awarded against an officer, employee, or volunteer of a 14 governmental agency as a result of a civil action for personal 15 injuries or property damage caused by the officer, employee, or volunteer while in the course of employment and while acting within 16 17 the scope of his or her authority, the governmental agency may 18 indemnify the officer, employee, or volunteer or pay, settle, or 19 compromise the judgment.
- 20 (2) When—If a criminal action is commenced against an officer 21 or employee of a governmental agency based upon on the conduct of 22 the officer or employee in the course of employment, if the 23 employee or officer had a reasonable basis for believing that he or 24 she was acting within the scope of his or her authority at the time 25 of the alleged conduct, the governmental agency may pay for, 26 engage, or furnish the services of an attorney to advise the 27 officer or employee as to the action, and to appear for and 28 represent the officer or employee in the action. An officer or

- 2 for conduct prescribed described in this subsection may obtain
- 3 reimbursement for those expenses under this subsection.
- 4 (3) A governmental agency may pay for, engage, or furnish the
- 5 services of an attorney to advise an officer, employee, or
- 6 volunteer of the governmental agency, and to appear for and
- 7 represent the officer, employee, or volunteer, in connection with
- 8 civil or criminal litigation or an investigation or proceeding if
- 9 the litigation, investigation, or proceeding involves the officer,
- 10 employee, or volunteer as a result of his or her conduct in the
- 11 course of employment with or actions taken on behalf of the
- 12 governmental agency, subject to the following limitations:
- 13 (a) If a claim is made or a civil action is commenced against
- 14 the officer, employee, or volunteer, subsection (1) of this section
- 15 governs the governmental agency's authority to pay for, engage, or
- 16 furnish the services of an attorney to advise the officer,
- 17 employee, or volunteer as to the claim and to appear for and
- 18 represent the officer, employee, or volunteer in the action.
- 19 (b) If a criminal action is commenced against the officer,
- 20 employee, or volunteer, subsection (2) of this section governs the
- 21 governmental agency's authority to pay for, engage, or furnish the
- 22 services of an attorney to advise the officer, employee, or
- 23 volunteer as to the action, and to appear for and represent the
- 24 officer, employee, or volunteer in the action.
- **25** (4) $\frac{(3)}{(3)}$ This section does not impose liability on a
- 26 governmental agency.
- 27 (5) This section is not intended to affect existing
- 28 constitutional, statutory, and common law powers and duties of the
- 29 Attorney General.
