HOUSE BILL NO. 4204

February 19, 2019, Introduced by Reps. Kahle and Afendoulis and referred to the Committee on Tax Policy.

A bill to amend 1937 PA 94, entitled "Use tax act,"

by amending section 2b (MCL 205.92b), as amended by 2017 PA 220.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2b. As used in this act:
- (a) "Alcoholic beverage" means a beverage suitable for humanconsumption that contains 1/2 of 1% or more of alcohol by volume.
- 4 (b) "Computer" means an electronic device that accepts
 5 information in digital or similar form and manipulates it for a
 6 result based on a sequence of instructions.





- (c) "Computer software" means a set of coded instructions
 designed to cause a computer or automatic data processing equipment
 to perform a task.
- 4 (d) "Delivered electronically" means delivered from the seller5 to the purchaser by means other than tangible storage media.
- 6 (e) "Delivery charges" means charges by the seller for 7 preparation and delivery to a location designated by the purchaser 8 of tangible personal property or services. Delivery charges 9 include, but are not limited to, transportation, shipping, postage, 10 handling, crating, and packing. Beginning September 1, 2004, 11 delivery charges do not include the charges for delivery of direct 12 mail if the charges are separately stated on an invoice or similar billing document given to the purchaser. If a shipment includes 13 14 both exempt property and taxable property, the seller shall
- (i) Multiply the delivery price by a fraction, the numerator of which is the total sales prices of the taxable property and the denominator of which is the total sales prices of all property in the shipment.

allocate the delivery charge using 1 of the following methods:

- (ii) Multiply the delivery price by a fraction, the numerator
 of which is the total weight of the taxable property and the
 denominator of which is the total weight of all property in the
 shipment.
 - (f) "Dental prosthesis" means a bridge, crown, denture, or other similar artificial device used to repair or replace intraoral defects such as missing teeth, missing parts of teeth, and missing soft or hard structures of the jaw or palate.
- 28 (g) "Dietary supplement" means any product, other than
 29 tobacco, intended to supplement the diet that is all of the

- 23 the items is not billed directly to the recipients, including
- 24 tangible personal property supplied directly or indirectly by the
- 25 purchaser to the direct mail seller for inclusion in the package
- 26 containing the printed material but not including multiple items of
- 27 printed material delivered to a single address.
- (i) "Drug" means a compound, substance, or preparation, or any
- 29 component of a compound, substance, or preparation, other than food

- 2 intended for human use that is 1 or more of the following:
- 3 (i) Recognized in the official United States Pharmacopoeia,

- 15 (ii) Is primarily and customarily used to serve a medical

- 17 (iii) Is not useful generally to a person in the absence of

- 19 (iv) Is not worn in or on the body.
- (k) "Durable medical equipment repair or replacement parts"
- 21 includes all components or attachments used in conjunction with
- 22 durable medical equipment.
- (1) "Electronic" means relating to technology having
- 24 electrical, digital, magnetic, wireless, optical, electromagnetic,
- 25 or similar capabilities.
- 27 control of tangible personal property for a fixed or indeterminate
- 28 term for consideration and may include future options to purchase
- 29 or extend. This definition applies only to leases and rentals



- 1 entered into after September 1, 2004 and has no retroactive impact
- 2 on leases and rentals that existed on that date. Lease or rental

- (iv) An agreement covering motor vehicles or trailers if the

- 21 to the amount realized upon sale or disposition of the property as
- 22 defined in section 7701(h)(1) of the internal revenue code of 1986,

- 24 (n) "Mobility enhancing equipment" means equipment, other than
- 25 durable medical equipment or a motor vehicle or equipment on a
- 26 motor vehicle normally provided by a motor vehicle manufacturer,
- 27 dispensed pursuant to a prescription, including repair or
- 28 replacement parts for that equipment, that is all of the following:
- 29 (i) Primarily and customarily used to provide or increase the



ability to move from 1 place to another and is appropriate for useat home or on a motor vehicle.

- 3 (ii) Not generally used by a person with normal mobility.
- 4 (o) "Prescription" means an order, formula, or recipe, issued
 5 in any form of oral, written, electronic, or other means of
 6 transmission by a licensed physician or other health professional
 7 as defined in section 3501 of the insurance code of 1956, 1956 PA
 8 218, MCL 500.3501. For a hearing aid, prescription includes an
 9 order, instruction, or direction of a hearing aid dealer or
 10 salesperson licensed under article 13 of the occupational code,
- 12 (p) "Prewritten computer software" means computer software,
 13 including prewritten upgrades, that is delivered by any means and
 14 that is not designed and developed by the author or other creator
 15 to the specifications of a specific purchaser. Prewritten computer
- 16 software includes all of the following:

1980 PA 299, MCL 339.1301 to 339.1309.

- 17 (i) Any combination of 2 or more prewritten computer software18 programs or portions of prewritten computer software programs.
- 19 (ii) Computer software designed and developed by the author or 20 other creator to the specifications of a specific purchaser if it 21 is sold to a person other than that specific purchaser.
 - (iii) The modification or enhancement of prewritten computer software or portions of prewritten computer software where if the modification or enhancement is designed and developed to the specifications of a specific purchaser unless there is a reasonable, separately stated charge or an invoice or other statement of the price is given to the purchaser for the modification or enhancement. If a person other than the original author or creator modifies or enhances prewritten computer

- software, that person is considered to be the author or creator ofonly that person's modifications or enhancements.
- 3 (q) "Prosthetic device" means a replacement, corrective, or
- 4 supportive device, other than contact lenses and dental prosthesis,
- 5 dispensed pursuant to a prescription, including repair or
- 6 replacement parts for that device, worn on or in the body to do 1
- 7 or more of the following:
- 8 (i) Artificially replace a missing portion of the body.
- $\mathbf{9}$ (ii) Prevent or correct a physical deformity or malfunction of $\mathbf{10}$ the body.
- 11 (iii) Support a weak or deformed portion of the body.
- 12 (r) "Tobacco" means cigarettes, cigars, chewing or pipe
- 13 tobacco, or any other item that contains tobacco.
- 14 Enacting section 1. This amendatory act is retroactive and is
- 15 effective beginning July 31, 2018.
