HOUSE BILL NO. 5021

September 25, 2019, Introduced by Rep. Eisen and referred to the Committee on Judiciary.

A bill to amend 1965 PA 213, entitled

"An act to provide for setting aside the conviction in certain criminal cases; to provide for the effect of such action; to provide for the retention of certain nonpublic records and their use; to prescribe the powers and duties of certain public agencies and officers; and to prescribe penalties,"

by amending section 1 (MCL 780.621), as amended by 2016 PA 336.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. (1) Except for an application to set aside a
- 2 nonviolent firearm-related felony that must be made as provided
- 3 under the nonviolent firearm-related felony act and except as





otherwise provided in this section, a person who is convicted of
not more than 1 offense may file an application with the convicting
court for the entry of an order setting aside 1 or more convictions
as follows:

- (a) A person who is convicted of not more than 1 felony
 offense and not more than 2 misdemeanor offenses may petition the
 convicting court to set aside the felony offense.
 - (b) Except as provided in subdivision (c), a person who is convicted of not more than 2 misdemeanor offenses and no other felony or misdemeanor offenses may petition the convicting court or the convicting courts to set aside 1 or both of the misdemeanor convictions.
 - (c) A person who is convicted of a violation or an attempted violation of section 520e of the Michigan penal code, 1931 PA 328, MCL 750.520e, before January 12, 2015 may petition the convicting court to set aside the conviction if the individual has not been convicted of another offense other than not more than 2 minor offenses. As used in this subdivision, "minor offense" means a misdemeanor or ordinance violation to which all of the following apply:
- 21 (i) The maximum permissible term of imprisonment does not 22 exceed 90 days.
 - (ii) The maximum permissible fine is not more than \$1,000.00.
- (iii) The person who committed the offense is not more than 21 years old.
- (2) A conviction that was deferred and dismissed under any of
 the following, whether a misdemeanor or a felony, shall be
 considered a misdemeanor conviction under subsection (1) for
 purposes of determining whether a person is eligible to have any

- **9** 333.7411.
- 10 (e) Section 350a or 430 of the Michigan penal code, 1931 PA
- 11 328, MCL 750.350a and 750.430.
- 12 (f) Any other law or laws of this state or of a political
- 13 subdivision of this state similar in nature and applicability to
- 14 those listed in this subsection that provide for the deferral and
- 15 dismissal of a felony or misdemeanor charge.
- 16 (3) A person shall not apply to have set aside, and a judge
- 17 shall not set aside, a conviction for any of the following:
- 18 (a) A felony for which the maximum punishment is life
- 19 imprisonment or an attempt to commit a felony for which the maximum
- 20 punishment is life imprisonment.
- 21 (b) A violation or attempted violation of section 136b(3),
- 22 136d(1)(b) or (c), 145c, 145d, 520c, 520d, or 520g of the Michigan
- 23 penal code, 1931 PA 328, MCL 750.136b, 750.136d, 750.145c,
- 24 750.145d, 750.520c, 750.520d, and 750.520g.
- 25 (c) A violation or attempted violation of section 520e of the
- 26 Michigan penal code, 1931 PA 328, MCL 750.520e, if the conviction
- 27 occurred on or after January 12, 2015.
- 28 (d) A traffic offense, including, but not limited to, a
- 29 conviction for operating while intoxicated.



- 1 (e) A felony conviction for domestic violence, if the person
- 2 has a previous misdemeanor conviction for domestic violence.
- 3 (f) A violation of former section 462i or 462j or chapter
- 4 LXVIIA or chapter LXXXIII-A of the Michigan penal code, 1938 PA
- 5 321, 1931 PA 328, MCL 750.462a to 750.462h and 750.543a to
- 6 750.543z.
- 7 (4) A person who is convicted of a violation of section 448,
- **8** 449, or 450 of the Michigan penal code, 1931 PA 328, MCL 750.448,
- 9 750.449, and 750.450, or a local ordinance substantially
- 10 corresponding to section 448, 449, or 450 of the Michigan penal
- 11 code, 1931 PA 328, MCL 750.448, 750.449, and 750.450, may apply to
- 12 have that conviction set aside if he or she committed the offense
- 13 as a direct result of his or her being a victim of a human
- 14 trafficking violation.
- 15 (5) An application under subsection (1) shall must only be
- 16 filed 5 or more years after whichever of the following events
- 17 occurs last:
- 18 (a) Imposition of the sentence for the conviction that the
- 19 applicant seeks to set aside.
- 20 (b) Completion of probation imposed for the conviction that
- 21 the applicant seeks to set aside.
- (c) Discharge from parole imposed for the conviction that the
- 23 applicant seeks to set aside.
- 24 (d) Completion of any term of imprisonment imposed for the
- 25 conviction that the applicant seeks to set aside.
- 26 (6) If a petition under this act is denied by the convicting
- 27 court, a person shall not file another petition concerning the same
- 28 conviction or convictions with the convicting court until 3 years
- 29 after the date the convicting court denies the previous petition,



- unless the court specifies an earlier date for filing anotherpetition in the order denying the petition.
- (7) An application under subsection (4) may be filed at any
 time following the date of the conviction to be set aside. A person
 may apply to have more than 1 conviction set aside under subsection
 (4).
 - (8) An application under this section is invalid unless it contains the following information and is signed under oath by the person whose conviction is or convictions are to be set aside:
 - (a) The full name and current address of the applicant.
- 11 (b) A certified record of each conviction that is to be set
 12 aside.
- 13 (c) For an application under subsection (1), a statement that
 14 the applicant has not been convicted of an offense other than the
 15 conviction or convictions sought to be set aside as a result of
 16 this application and any nondisqualifying misdemeanor convictions
 17 described in subsection (1)(a).
- (d) A statement listing all actions enumerated in subsectionthat were initiated against the applicant and have beendismissed.
- (e) A statement as to whether the applicant has previously
 filed an application to set aside this or other conviction and, if
 so, the disposition of the application.
- (f) A statement as to whether the applicant has any othercriminal charge pending against him or her in any court in theUnited States or in any other country.
- 27 (g) If the person is seeking to have 1 or more convictions set
 28 aside under subsection (4), a statement that he or she meets the
 29 criteria set forth in subsection (4), together with a statement of

the facts supporting his or her contention that the conviction wasa direct result of his or her being a victim of human trafficking.

- (h) A consent to the use of the nonpublic record created under section 3 to the extent authorized by section 3.
- 5 (9) The applicant shall submit a copy of the application and 1 6 complete set of fingerprints to the department of state police. The 7 department of state police shall compare those fingerprints with 8 the records of the department, including the nonpublic record 9 created under section 3, and shall forward an electronic copy of a 10 complete set of fingerprints to the Federal Bureau of Investigation 11 for a comparison with the records available to that agency. The 12 department of state police shall report to the court in which the application is filed the information contained in the department's 13 14 records with respect to any pending charges against the applicant, 15 any record of conviction of the applicant, and the setting aside of 16 any conviction of the applicant and shall report to the court any similar information obtained from the Federal Bureau of 17 18 Investigation. The court shall not act upon the application until 19 the department of state police reports the information required by this subsection to the court. 20
 - (10) The copy of the application submitted to the department of state police under subsection (9) shall must be accompanied by a fee of \$50.00 payable to the state of Michigan that shall must be used by the department of state police to defray the expenses incurred in processing the application.
 - (11) A copy of the application shall must be served upon the attorney general and upon the office of each prosecuting attorney who prosecuted the crime or crimes the applicant seeks to set aside, and an opportunity shall must be given to the attorney

- 1 general and to the prosecuting attorney to contest the application.
- 2 If a conviction was for an assaultive crime or a serious
- 3 misdemeanor, the prosecuting attorney shall notify the victim of
- 4 the assaultive crime or serious misdemeanor of the application
- 5 under section 22a or 77a of the William Van Regenmorter crime
- 6 victim's rights act, 1985 PA 87, MCL 780.772a and 780.827a. The
- 7 notice shall must be by first-class mail to the victim's last known
- 8 address. The victim has the right to appear at any proceeding under
- 9 this act concerning that conviction and to make a written or oral
- 10 statement.
- 11 (12) For an application under subsection (1), upon the hearing
 12 of the application the court may require the filing of affidavits
- 13 and the taking of proofs as it considers proper.
- (13) For an application under subsection (4), if the applicant
 proves to the court by a preponderance of the evidence that the
 conviction was a direct result of his or her being a victim of
- human trafficking, the court may, subject to the requirements of subsection (14), enter an order setting aside the conviction.
- 19 (14) If the court determines that the circumstances and
- 20 behavior of an applicant under subsection (1) or (4), from the date
- 21 of the applicant's conviction or convictions to the filing of the
- 22 application warrant setting aside the conviction or convictions,
- 23 and that setting aside the conviction or convictions is consistent
- 24 with the public welfare, the court may enter an order setting aside
- 25 the conviction or convictions.
- 26 (15) The setting aside of a conviction or convictions under
- 27 this act is a privilege and conditional and is not a right.
- 28 (16) As used in this section:
- 29 (a) "Assaultive crime" means that term as defined in section



- 1 9a of chapter X of the code of criminal procedure, 1927 PA 175, MCL
- **2** 770.9a.
- 3 (b) "Domestic violence" means that term as defined in section
- 4 1 of 1978 PA 389, MCL 400.1501.
- 5 (c) "Felony" means either of the following, as applicable:
- 6 (i) For purposes of the offense to be set aside, felony means a
- 7 violation of a penal law of this state that is punishable by
- 8 imprisonment for more than 1 year or that is designated by law to
- 9 be a felony.
- 10 (ii) For purposes of identifying a prior offense, felony means
- 11 a violation of a penal law of this state, of another state, or of
- 12 the United States that is punishable by imprisonment for more than
- 13 1 year or is designated by law to be a felony.
- 14 (d) "Human trafficking violation" means a violation of chapter
- 15 LXVIIA of the Michigan penal code, 1931 PA 328, MCL 750.462a to
- 16 750.462h, or of former sections 462i or 462j of that act.
- 17 (e) "Indian tribe" means an Indian tribe, Indian band, or
- 18 Alaskan native village that is recognized by federal law or
- 19 formally acknowledged by a state.
- 20 (f) "Misdemeanor" means a violation of any of the following:
- 21 (i) A penal law of this state, another state, an Indian tribe,
- 22 or the United States that is not a felony.
- 23 (ii) An order, rule, or regulation of a state agency that is
- 24 punishable by imprisonment for not more than 1 year or a fine that
- 25 is not a civil fine, or both.
- 26 (iii) A local ordinance of a political subdivision of this state
- 27 substantially corresponding to a crime listed in subparagraph (i) or
- 28 (ii) that is not a felony.
- (iv) A violation of the law of another state or political



- 1 subdivision of another state substantially corresponding to a crime
- 2 listed under subparagraph (i) or (ii) that is not a felony.
- $\mathbf{3}$ (v) A violation of the law of the United States substantially
- 4 corresponding to a crime listed under subparagraph (i) or (ii) that
- 5 is not a felony.
- 6 (g) "Operating while intoxicated" means a violation of any of
- 7 the following:
- 8 (i) Section 625 or 625m of the Michigan vehicle code, 1949 PA
- 9 300, MCL 257.625 and 257.625m.
- (ii) A local ordinance substantially corresponding to a
- 11 violation listed in subparagraph (i).
- 12 (iii) A law of an Indian tribe substantially corresponding to a
- 13 violation listed in subparagraph (i).
- 14 (iv) A law of another state substantially corresponding to a
- 15 violation listed in subparagraph (i).
- 16 (v) A law of the United States substantially corresponding to
- 17 a violation listed in subparagraph (i).
- (h) "Serious misdemeanor" means that term as defined in
- 19 section 61 of the William Van Regenmorter crime victim's rights
- 20 act, 1985 PA 87, MCL 780.811.
- 21 (i) "Victim" means that term as defined in sections 2, 31, and
- 22 61 of the William Van Regenmorter crime victim's rights act, 1985
- 23 PA 87, MCL 780.752, 780.781, and 780.811.
- 24 Enacting section 1. This amendatory act takes effect 90 days
- 25 after the date it is enacted into law.
- 26 Enacting section 2. This amendatory act does not take effect
- 27 unless Senate Bill No. or House Bill No. 5020 (request no.
- 28 00179'19) of the 100th Legislature is enacted into law.
