## **HOUSE BILL NO. 5232**

November 07, 2019, Introduced by Reps. A bill to provide for the issuance of a military transportation card to certain veterans and active duty members of the Armed Forces of the United States; to prohibit a public transportation provider from charging a fare, fee, or other charge for use of public transportation to a veteran or active duty member of the Armed Forces of the United States upon presentation of a military transportation card; to provide for the powers and duties of certain state officers and entities; and to authorize the promulgation of rules.





## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. As used in this act:
- 2 (a) "Department" means the department of military and veterans
- 3 affairs.
- 4 (b) "Public transportation provider" means a public or private
- 5 entity that provides public transportation services. Public
- 6 transportation provider includes an authority formed under any of
- 7 the following:
- 8 (i) 1963 PA 55, MCL 124.351 to 124.359.
- 9 (ii) The urban cooperation act of 1967, 1967 (Ex Sess) PA 7,

- 11 (iii) 1967 (Ex Sess) PA 8, MCL 124.531 to 124.536.
- 12 (iv) 1951 PA 35, MCL 124.1 to 124.13.
- 13 (v) The public transportation authority act, 1986 PA 196, MCL

- 17 (c) "Veteran" means 1 of the following:
- 18 (i) An individual who served in the Armed Forces of the United
- 19 States on active military duty and received an honorable discharge
- 20 from active duty, if he or she served on active duty for reasons
- 21 other than training or if, while serving on active duty for
- 22 training, he or she incurred a disability recognized by the United
- 23 States Department of Veterans Affairs or the United States
- 24 Department of Defense as service-connected.
- 25 (ii) An individual who served in the United States Merchant
- 26 Marine who served on active duty for reasons other than training or
- 27 if, while serving on active duty for training, incurred a

- 7 Sec. 3. (1) The department shall issue a military
- 8 transportation card to an applicant who satisfies all of the
- 9 following:
- 10 (a) The applicant submits a written application that states
- 11 that he or she is a veteran or an active duty member of the Armed
- 12 Forces of the United States.
- 13 (b) The applicant submits documentary evidence in a form
- 14 satisfactory to the department that shows that he or she is a
- 15 veteran or an active duty member of the Armed Forces of the United
- 16 States.
- 17 (2) The department shall issue the military transportation
- 18 card described in subsection (1) at no cost to the individual to
- 19 whom it is issued.
- 20 (3) A military transportation card issued to a veteran under
- 21 subsection (1) does not expire. A military transportation card
- 22 issued to an active duty member of the Armed Forces of the United
- 23 States expires on the date that his or her membership is scheduled
- 24 to cease, as shown in the documentary evidence described in
- 25 subsection (1)(b).
- 26 (4) The department may promulgate rules under the
- 27 administrative procedures act of 1969, 1969 PA 306, MCL 24.201 to
- 28 24.328, to implement this act.
- Sec. 5. A public transportation provider shall not charge a

- 1 fee, fare, or other charge of any kind to a veteran or active duty
- 2 member of the Armed Forces of the United States to board or travel
- 3 on a bus operated by that public transportation provider if the
- 4 veteran or active duty member presents a military transportation
- 5 card issued under section 3.
- 6 Enacting section 1. This act takes effect 90 days after the
- 7 date it is enacted into law.
