A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 803f (MCL 257.803f), as amended by 2018 PA 681.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 803f. (1) A person who is a totally disabled veteran with
- 2 an honorable discharge from the armed services may make an
- 3 application to the secretary of state if he or she owns a private
- 4 passenger motor vehicle, and the secretary of state may issue a
- 5 special registration plate inscribed with special identification





- 1 numbers preceded by the letters "DV" and the words "disabled
- 2 veteran" inscribed beneath the registration number. For the
- 3 purposes of As used in this section, "private passenger motor
- 4 vehicle" means a motor vehicle that is personally owned by the a
- 5 disabled veteran and is used for the primary purpose of
- 6 transporting the disabled veteran and his or her family members, of
- 7 the disabled veteran, but does not include a motor home.
- 8 (2) Application An application for the special registration
- 9 plate described in subsection (1) must be on a form prescribed by
- 10 the secretary of state and must be accompanied by a service fee of
- 11 \$5.00 and proof that the applicant was honorably discharged from
- 12 the armed services and either 1 of the following:
- 13 (a) That—If the applicant is a totally disabled veteran, that
- 14 the applicant has been determined by the United States Department
- 15 of Veterans Affairs to have a service-connected total or permanent
- 16 total disability rating for compensation.
- 17 (b) That—If the applicant is a totally disabled veteran, that
- 18 the applicant has been determined to have a service-connected total
- 19 or permanent total disability rating and is receiving disability
- 20 retirement pay from a branch of the uniformed armed services.
- 21 (c) If the applicant is a partially disabled veteran, that the
- 22 applicant has been determined to have a service-connected
- 23 disability rating.
- 24 (3) A special registration issued under this section is exempt
- 25 from payment of the tax provided for in section 801. This
- 26 subsection only applies to a totally disabled veteran described in
- 27 subsection (2)(a) or (b).
- 28 (4) The A special registration plate issued to a totally
- 29 disabled veteran described in subsection (2) (a) or (b) expires on

- 1 the birthday of the totally disabled veteran in a year in which new
- 2 plates are issued by the secretary of state. Application for
- 3 renewal of the special registration plate must be accompanied by a
- 4 \$5.00 service fee. The applicant shall is not be required to
- 5 furnish the proof provided in subsection (2).
- 6 (5) A special registration plate issued to a partially
- 7 disabled veteran described in subsection (2)(c) expires as provided
- 8 in section 226, and a partially disabled veteran shall apply for
- 9 renewal of the special registration plate as provided in section
- 10 226. The applicant is not required to furnish the proof provided in
- 11 subsection (2).
- 12 (6) (5) The surviving spouse of a person who is a totally
- 13 disabled veteran with a service-connected disability rating from
- 14 the United States Department of Veterans Affairs of at least 50%
- 15 and an honorable discharge from the armed services may use a
- 16 special registration plate issued under this section after the
- 17 death of the totally disabled veteran and may renew a special
- 18 registration plate issued under this section after the death of the
- 19 totally disabled veteran in the same manner as provided under this
- 20 section for a totally—disabled veteran with the same service-
- 21 connected disability rating as the deceased disabled veteran. If
- 22 applicable, a surviving spouse shall apply for registration of the
- 23 vehicle upon which he or she wishes to place the disabled veteran
- 24 plate before using or renewing the plate as described in this
- 25 section.
- 26 (7) (6) The If applicable, the secretary of state may issue to
- 27 a disabled person veteran who has been issued a special
- 28 registration plate under this section a tab for persons with
- 29 disabilities. The tab for persons with disabilities must be an

- 2 reasonable facsimile of that symbol. The tab for persons with
- 3 disabilities may be attached only to the special registration plate
- 4 issued to the disabled person veteran under this section.
- 5 (8) $\frac{7}{4}$ An application for a tab for persons with disabilities
- 6 shall be on a form prescribed by the secretary of state. The
- 7 secretary of state shall require the same proof that the applicant
- 8 is a disabled person as is required for issuance of a permanent
- 9 windshield placard under section 675. If the surviving spouse of a
- 10 totally disabled veteran is a disabled person, he or she may apply
- 11 to the secretary of state for a tab for persons with disabilities
- 12 in the same manner as provided for a totally—disabled veteran under
- 13 this subsection.
- 14 (9) (8) The A tab for persons with disabilities issued under
- 15 subsection (7) must be issued free of charge.
- 16 (10) (9) When a disabled person veteran who has been issued a
- 17 tab for persons with disabilities renews his or her special
- 18 registration plate under this section, the secretary of state shall
- 19 issue a new tab for persons with disabilities to the disabled
- 20 person, veteran, free of charge. The disabled person shall veteran
- 21 is not be—required to again furnish the proof required under
- 22 subsection (7). (8).
- 23 (11) (10)—The use of the special registration plate or a tab
- 24 for persons with disabilities on a motor vehicle other than the
- 25 motor vehicle for which the special registration plate is issued,
- 26 or by a person who does not qualify under this section, is a
- 27 misdemeanor.
