

HOUSE BILL NO. 5757

April 30, 2020, Introduced by Rep. Mueller and referred to the Committee on Transportation.

A bill to amend 2008 PA 23, entitled
"Enhanced driver license and enhanced official state personal
identification card act,"

(MCL 28.301 to 28.308) by adding section 5a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 **Sec. 5a. (1) The secretary of state may extend the deadline**
2 **for the renewal of an individual's enhanced driver license or**
3 **enhanced official state personal identification card and may waive**
4 **the penalty for the late renewal of an individual's enhanced driver**

1 license or enhanced official state personal identification card if
2 both of the following apply:

3 (a) The governor issued an executive order declaring a state
4 of disaster or a state of emergency under the emergency management
5 act, 1976 PA 390, MCL 30.401 to 30.421.

6 (b) The individual's enhanced driver license or enhanced
7 official state personal identification card expired during the
8 period of the state of disaster or the state of emergency.

9 (2) If the secretary of state extends the deadline for the
10 renewal of an individual's enhanced driver license or enhanced
11 official state personal identification card under subsection (1),
12 the enhanced driver license or enhanced official state personal
13 identification card is valid for 60 days after the termination of
14 the state of disaster or the state of emergency.

15 (3) The secretary of state may waive the penalty for the late
16 renewal of the enhanced driver license or enhanced official state
17 personal identification card if both of the following apply:

18 (a) An individual's enhanced driver license or enhanced
19 official state personal identification card expired 1 week before
20 the governor declared a state of disaster or a state of emergency
21 under the emergency management act, 1976 PA 390, MCL 30.401 to
22 30.421.

23 (b) The secretary of state closed its branches before the
24 governor declared the state of disaster or state of emergency under
25 the emergency management act, 1976 PA 390, MCL 30.401 to 30.421.

26 (4) This section does not apply if an individual's enhanced
27 driver license or enhanced official state personal identification
28 card was suspended or restricted before the state of disaster or
29 the state of emergency.



1 (5) As used in this section:

2 (a) "State of disaster" means that term as defined in section
3 2 of the emergency management act, 1976 PA 390, MCL 30.402.

4 (b) "State of emergency" means that term as defined in section
5 2 of the emergency management act, 1976 PA 390, MCL 30.402.

6 Enacting section 1. This amendatory act does not take effect
7 unless all of the following bills of the 100th Legislature are
8 enacted into law:
