A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending section 501 (MCL 324.501).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 501. (1) A department of natural resources for this state is created which that shall possess the powers and perform the duties granted and imposed by this act and as otherwise provided by

 - (f) Each member of the commission shall hold office until the appointment and qualification of that member's successor.
 - (g) The commission must have at least 1 member from each district of the court of appeals of this state. If the commission does not have at least 1 member from each district of the court of appeals of this state, any new member of the commission must be selected from a district of the court of appeals of this state that is unrepresented on the commission until the commission has at least 1 member from each district.

- (3) The commission, within 30 days after having qualified and 1 annually after that time, shall meet at its office in Lansing and 2 organize by appointing a secretary, who need not be a member of the 3 4 commission. The governor shall appoint a chairperson of the 5 commission from among its members, who shall serve as chairperson 6 at the pleasure of the governor. Four members of the commission 7 constitute a guorum for the transaction of business. The business 8 which that the commission may perform shall must be conducted at a 9 public meeting of the commission held in compliance with the open 10 meetings act, Act No. 267 of the Public Acts of 1976, being 11 sections 15.261 to 15.275 of the Michigan Compiled Laws. 1976 PA 12 **267, MCL 15.261 to 15.275.** Public notice of the time, date, and 13 place of the meeting shall must be given in the manner required by 14 Act No. 267 of the Public Acts of 1976. the open meetings act, 1976 15 PA 267, MCL 15.261 to 15.275.  - (4) The commission shall appoint and employ a director who shall continue in office serves at the pleasure of the commission.
