HOUSE BILL NO. 5940

July 21, 2020, Introduced by Reps. Wozniak, Vaupel, Frederick, Yaroch and Tyrone Carter and referred to the Committee on Health Policy.

A bill to amend 1978 PA 368, entitled "Public health code,"

(MCL 333.1101 to 333.25211) by adding sections 17748e and 17748f.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 17748e. (1) A manufacturer or wholesale distributor,
- 2 including any employee or agent of the manufacturer or wholesale
- 3 distributor, shall not offer or give a gift to a prescriber when
- 4 engaged in a sales, promotional, or other marketing activity for a





- 1 prescription drug.
- 2 (2) The board may promulgate rules to implement this section.
- 3 (3) As used in this section, "gift" means a payment, advance,
- 4 forbearance, or the rendering or deposit of money, services, or
- 5 anything else of value, the value of which exceeds \$63.00 in any 1-
- 6 month period. However, gift does not include any of the following:
- 7 (a) Providing a sample of a prescription drug to a prescriber
- 8 for distribution to his or her patient.
- 9 (b) One or more items with a total combined retail value, in
- 10 any 1-year period, of not more than \$63.00.
- 11 (c) A publication or educational material.
- 12 (d) A payment to the sponsor of a medical conference,
- 13 professional meeting, or other educational program, if the payment
- 14 is not made directly to a prescriber and is used solely for bona
- 15 fide educational purposes.
- 16 (e) Reasonable compensation and expense reimbursement for the
- 17 professional or consulting service of a prescriber, such as in
- 18 connection with a genuine research project.
- (f) A salary or other benefit paid to an employee.
- 20 (g) Anything of value provided by the manufacturer or
- 21 wholesale distributor to its salaried employees.
- 22 (h) Reasonable compensation and expense reimbursement to a
- 23 prescriber who serves as a speaker or on the faculty at a
- 24 professional or educational conference or meeting, including a
- 25 conference or meeting that is organized or sponsored by the
- 26 manufacturer or wholesale distributor.
- 27 (i) Funding for a continuing medical or pharmacy education
- 28 activity that is consistent with the standards of the Accreditation
- 29 Council for Continuing Medical Education or the Accreditation



- 1 Council for Pharmacy Education including, but not limited to, a 2 scholarship or educational funding for continuing education.
- 3 (j) A modest meal provided in connection with an informational 4 presentation.
- 5 (k) An educational item designed primarily for the education 6 of a patient or prescriber.
 - Sec. 17748f. A manufacturer and wholesale distributor shall provide a list to the board identifying each employee of the manufacturer or wholesale distributor who engages in the sale, promotion, or marketing of a prescription drug to a prescriber and shall ensure that each employee of the manufacturer or wholesale distributor complies with all of the following:
 - (a) That the employee provides to the prescriber, in writing, the current selling price of a prescription drug if the employee provides information concerning the prescription drug to the prescriber.
 - (b) That the employee does not engage in any deceptive or misleading marketing of a prescription drug, including knowingly concealing, suppressing, omitting, or misstating a material fact or knowingly making a misleading representation of a material fact.
- 21 (c) That the employee does not attend a patient examination 22 without first obtaining the consent of the patient.
