HOUSE BILL NO. 6026

July 23, 2020, Introduced by Rep. Sabo and referred to the Committee on Families, Children, and Seniors.

A bill to amend 1994 PA 203, entitled "Foster care and adoption services act,"

by amending section 8b (MCL 722.958b), as added by 2018 PA 489.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 8b. (1) The department shall ensure that the children's assurance of quality foster care policy is developed, implemented by the supervising agency, and made available to the public.
- 4 (2) The department shall promote the participation of current





- and former children in foster care in developing the children'sassurance of quality foster care policy.
- 3 (3) The children's assurance of quality foster care policy
 4 shall ensure that children placed in foster care are provided with
 5 the following:
- 6 (a) Fair, equal, and respectful treatment, including treatment7 that does not violate state and federal law.
 - (b) Placement with relatives and siblings, when appropriate, as provided in section 4a(5).
 - (c) Inventory and security of the child in foster care's personal belongings.
 - (d) (e)—Transition planning, including housing, workforce preparation, financial education, access to personal documents, information regarding secondary education and postsecondary education, and independent living preparation, as age-appropriate.
- (e) (d) Ongoing contact and visits with parents, relatives,
 and friends, if permitted by the court.
- 18 (f) (e) Access to advocacy services for children in foster
 19 care with disabilities.
- 20 (g) (f)—Timely enrollment in school with consistent placement
 21 in the same school, when possible.
 - (h) (g) Participation in extracurricular activities consistent with the child in foster care's age and developmental level, as allowed by the supervising agency's resources, taking into consideration the foster parent's schedule and resources.
- 26 (i) (h) Placement in the least restrictive setting,
 27 appropriate to the child in foster care's needs in accordance with
 28 R 400.12313 of the Michigan Administrative Code. If discipline is
 29 required, and physical restraint has been used by a child caring

- 15 (7) The sole remedy that may be provided under this section is
- 16 limited to injunctive relief.
- 17 (8) The department shall implement the children's assurance of
- 18 quality foster care policy no later than 90 days after the
