THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 21327. (1) Subject to applicable federal and state
- 2 privacy laws, a home for the aged shall provide the following
- 3 notices:

(a) If a resident is relocated within a home for the aged for





- 1 any reason, the home for the aged shall provide notice to a family
- 2 member of the resident or his or her legal guardian as soon as
- 3 reasonably possible, but no later than 12 hours after the resident
- 4 is relocated within the home for the aged.
- 5 (b) If a resident or an employee in a home for the aged has a
- 6 confirmed case of a communicable disease, the home for the aged
- 7 shall provide notice to each resident of the home for the aged and
- 8 a family member of the resident or his or her legal guardian as
- 9 soon as reasonably possible, but no later than 12 hours after the
- 10 case of a communicable disease in the home for the aged is
- 11 confirmed.
- 12 (2) A home for the aged shall provide the notice required
- 13 under subsection (1)(b) each time a resident or employee of the
- 14 home for the aged has a confirmed case of a communicable disease.
- 15 (3) As used in this section, "communicable disease" means that

- 17 Sec. 21727. (1) Subject to applicable federal and state
- 18 privacy laws, a nursing home shall provide the following notices:
- (a) Except as otherwise provided in subsection (3), if a
- 20 resident is relocated within the nursing home for any reason, the
- 21 nursing home shall provide notice to a family member of the
- 22 resident or his or her legal quardian as soon as reasonably
- 23 possible, but no later than 12 hours after the resident is
- 24 relocated within the nursing home.
- 25 (b) If a resident or an employee in a nursing home has a
- 26 confirmed case of a communicable disease, the nursing home shall
- 27 provide notice to each resident and a family member of the resident
- 28 or his or her legal guardian as soon as reasonably possible, but no
- 29 later than 12 hours after the case of a communicable disease in the

- 2 (2) A nursing home shall provide the notice required under 3 subsection (1)(b) each time a resident or employee of the nursing 4 home has a confirmed case of a communicable disease.
 - (3) If a relocation of a resident described in subsection
 (1) (a) is an involuntary transfer, a nursing home shall provide the
 30-day written notice for an involuntary transfer or discharge as
 required by section 21773(2). However, if a relocation of a
 resident described in subsection (1) (a) is an involuntary transfer
 subject to an exception listed under section 21773(2), a nursing
 home shall provide the notice as required by subsection (1) (a).
- 12 (4) As used in this section, "communicable disease" means that 13 term as defined in section 5101.
