THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 402. Notwithstanding any other provision under this
- 2 chapter, beginning after the effective date of the amendatory act
- 3 that added this section each written agreement or amendments to a
- 4 written agreement required for a tax credit under this chapter
- 5 shall include both of the following:
- 6 (a) A penalty provision in the event the taxpayer relocates

- 1 outside of this state during the terms of the written agreement or
- 2 subsequently fails to meet the requirements of the agreement or any
- 3 other conditions included in the agreement. The penalty provision
- 4 shall provide that the taxpayer shall have an amount equal to the
- 5 total amount of the credit received by the taxpayer under the
- 6 agreement added back to the tax liability of the taxpayer in the
- 7 tax year that the taxpayer relocates outside of this state or fails
- 8 to comply with the agreement.
- 9 (b) A provision that the taxpayer consents to the jurisdiction
- 10 of the courts of this state for the collection and enforcement of a
- 11 penalty described in this section.
