## **SENATE BILL NO. 84**

February 05, 2019, Introduced by Senator VANDERWALL and referred to the Committee on Judiciary and Public Safety.

A bill to amend 2013 PA 93, entitled "Michigan indigent defense commission act,"

by amending section 3 (MCL 780.983), as amended by 2018 PA 214.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 3. As used in this act:
- 2 (a) "Adult" means either of the following:
- 3 (i) An individual  $\frac{17}{18}$  years of age or older.
- 4 (ii) An individual less than  $\frac{17}{18}$  years of age at the time of
- 5 the commission of a felony if any of the following conditions

- 2 (A) During consideration of a petition filed under section 4
- 3 of chapter XIIA of the probate code of 1939, 1939 PA 288, MCL
- 4 712A.4, to waive jurisdiction to try the individual as an adult and
- 5 upon granting a waiver of jurisdiction.
- 6 (B) The prosecuting attorney designates the case under section
- 7 2d(1) of chapter XIIA of the probate code of 1939, 1939 PA 288, MCL
- 8 712A.2d, as a case in which the juvenile is to be tried in the same
- 9 manner as an adult.
- 10 (C) During consideration of a request by the prosecuting
- 11 attorney under section 2d(2) of chapter XIIA of the probate code of
- 12 1939, 1939 PA 288, MCL 712A.2d, that the court designate the case
- 13 as a case in which the juvenile is to be tried in the same manner
- 14 as an adult.
- 15 (D) The prosecuting attorney authorizes the filing of a
- 16 complaint and warrant for a specified juvenile violation under
- 17 section 1f of chapter IV of the code of criminal procedure, 1927 PA
- **18** 175, MCL 764.1f.
- 19 (b) "Consumer Price Index" means the annual United States
- 20 Consumer Price Index for all urban consumers as defined and
- 21 reported by the United States Department of Labor, Bureau of Labor
- 22 Statistics.
- (c) "Department" means the department of licensing and
- 24 regulatory affairs.
- 25 (d) "Effective assistance of counsel" or "effective
- 26 representation" means legal representation that is compliant with
- 27 standards established by the appellate courts of this state and the
- 28 United States Supreme Court.
- 29 (e) "Indigent" means meeting 1 or more of the conditions

- 1 described in section 11(3).
- 2 (f) "Indigent criminal defense services" means local legal
- 3 defense services provided to a defendant and to which both of the
- 4 following conditions apply:
- 5 (i) The defendant is being prosecuted or sentenced for a crime
- 6 for which an individual may be imprisoned upon conviction,
- 7 beginning with the defendant's initial appearance in court to
- 8 answer to the criminal charge.
- 9 (ii) The defendant is determined to be indigent under section
- **10** 11 (3).
- 11 (q) Indigent criminal defense services do not include services
- 12 authorized to be provided under the appellate defender act, 1978 PA
- 13 620, MCL 780.711 to 780.719.
- 14 (h) "Indigent criminal defense system" or "system" means
- 15 either of the following:
- 16 (i) The local unit of government that funds a trial court.
- 17 (ii) If a trial court is funded by more than 1 local unit of
- 18 government, those local units of government, collectively.
- 19 (i) "Local share" or "share" means an indigent criminal
- 20 defense system's average annual expenditure for indigent criminal
- 21 defense services in the 3 fiscal years immediately preceding the
- 22 creation of the MIDC under this act, excluding money reimbursed to
- 23 the system by individuals determined to be partially indigent.
- 24 Beginning on November 1, 2018, if the Consumer Price Index has
- 25 increased since November 1 of the prior state fiscal year, the
- 26 local share must be adjusted by that number or by 3%, whichever is
- **27** less.
- 28 (j) "MIDC" or "commission" means the Michigan indigent defense
- 29 commission created under section 5.

- 1 (k) "Partially indigent" means a criminal defendant who is
- 2 unable to afford the complete cost of legal representation, but is
- 3 able to contribute a monetary amount toward his or her
- 4 representation.
- **5** Enacting section 1. This amendatory act takes effect 90 days
- 6 after the date it is enacted into law.
