

SENATE BILL NO. 346

May 24, 2019, Introduced by Senators BARRETT, GEISS, WOJNO and BULLOCK and referred to the Committee on Transportation and Infrastructure.

A bill to amend 1994 PA 451, entitled
"Natural resources and environmental protection act,"
by amending sections 6311 and 6512 (MCL 324.6311 and 324.6512), as
added by 1995 PA 60.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 6311. The following vehicles are exempt from the
- 2 inspection requirements of this part:
- 3 (a) Motor vehicles that are exempted by rules promulgated by
- 4 the department because of prohibitive inspection problems or

1 inappropriateness for inspection.

2 (b) A motor vehicle manufactured before the 1975 model year.

3 (c) Vehicles that are licensed as historic vehicles under

4 section 803a of the Michigan vehicle code, **1949 PA 300, MCL**
