A bill to establish the pediatric congenital heart association fund in the department of treasury; to provide for the distribution of the money from the fund; to prescribe the powers and duties of certain agencies and officials; and to provide for appropriations.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. This act shall be known and may be cited as the "Ruby Jane act".
- 3 Sec. 3. As used in this act:
- 4 (a) "Department" means the department of treasury.
- 5 (b) "Fund" means the pediatric congenital heart association

- 1 fund created in section 5.
- 2 Sec. 5. (1) The pediatric congenital heart association fund is
- 3 created in the department to provide funds for donation to the
- 4 Michigan chapter of the Pediatric Congenital Heart Association. The
- 5 department shall be the administrator of the fund for auditing
- 6 purposes.
- 7 (2) The state treasurer shall credit to the fund all amounts
- 8 appropriated for this purpose under section 435 of the income tax
- **9** act of 1967, 1967 PA 281, MCL 206.435, and money from any other
- 10 source for deposit into the fund.
- 11 (3) The state treasurer shall direct the investment of the
- 12 fund. The fund shall consist of the money credited to the fund
- 13 pursuant to section 435 of the income tax act of 1967, 1967 PA 281,
- 14 MCL 206.435, any interest and earnings accruing from the saving and
- 15 investment of that money, and money from any other source.
- 16 (4) Money in the fund at the close of the year shall remain in
- 17 the fund and shall not lapse to the general fund.
- 18 Sec. 7. The money, interest, and earnings of the fund shall be
- 19 expended solely for donation to the Michigan chapter of the
- 20 Pediatric Congenital Heart Association to support the Michigan
- 21 chapter of the Pediatric Congenital Heart Association in improving
- 22 the lives of those with congenital heart disease and their families
- 23 through direct support, education, research, and awareness.
- Sec. 9. The money in the fund that is available for
- 25 distribution shall be appropriated each year. Money granted or
- 26 received as a gift or donation to the fund is available for
- 27 distribution upon appropriation.
