by amending section 74 (MCL 125.2074), as amended by 2006 PA 616.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 74. (1) The fund may utilize the money held in the

- 2 (2) The present or emerging technologies that are provided
- 3 financial aid should serve as a foundation for future job growth or
- 4 retention in this state, encourage economic stability or

- 7 (3) Financial aid under this act may be provided for the
- 8 purposes of designing and constructing new facilities, designing
- 9 and rehabilitating existing facilities, acquiring an interest in

- 5 from an organization with tax-exempt status under section 501(c)(3)
- 6 of the internal revenue code, 26 USC 501, that received financial
- 7 benefit or support directly or indirectly under this act or section
- 8 117 of 2000 PA 291 is exempt from taxes collected under the general
