PART 2

PROVISIONS CONCERNING APPROPRIATIONS

GENERAL SECTIONS

Sec. 201. In accordance with section 30 of article IX of the state constitution of 1963, total state spending from state sources in this appropriation act for the fiscal year ending September 30, 2020 is \$400,000.00 and state spending from state sources to be paid to local units of government is \$0.00.

Sec. 202. The appropriations made and expenditures authorized under this act and the departments, commissions, boards, offices, and programs for which appropriations are made under this act are subject to the management and budget act, 1984 PA 431, MCL 18.1101 to 18.1594.

DEPARTMENT OF HEALTH AND HUMAN SERVICES

Sec. 301. (1) From the funds appropriated in part 1 for senior community services, \$400,000.00 is appropriated for Alzheimer's disease services. The funds shall be remitted to the Alzheimer's Association-Michigan chapter for the purpose of carrying out a dementia care and support program in Allegan, Kent, Lenawee, Macomb, Midland, Monroe, Oakland, St. Clair, St. Joseph, and Wayne Counties. Program services shall be provided to individuals with Alzheimer's disease or dementia and their families in the 10 counties, and shall include a 24/7 helpline, continued care consultation, and referrals to support groups and other community-

1 based services. The Alzheimer's Association-Michigan chapter shall
2 also contract for an evaluation of the program. The total cost for
3 program evaluation shall not exceed \$15,000.00.

4 (2) By March 1 of the current fiscal year, the department
5 shall provide a report to the house and senate subcommittees on the
6 department budget, the house and senate fiscal agencies and policy
7 offices, and the state budget office on the status of the program
8 and the evaluation, the number of employees funded by the program,
9 the number of persons served by the program, and the number of
10 persons served by the program who continue to live in their own
11 home as known as of the date of the report. The report shall
12 include an analysis of program data to assess whether providing the
13 in-home support services significantly delays the need for
14 residential long-term care services for individuals with
15 Alzheimer's disease or dementia.
