SENATE BILL NO. 595

October 22, 2019, Introduced by Senator SCHMIDT and referred to the Committee on Government Operations.

A bill to authorize the state administrative board to accept and convey real property in Grand Traverse County; to prescribe conditions for the conveyance; and to provide for disposition of the revenue from the conveyance.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 1. (1) The state administrative board, on behalf of this state, subject to and contingent on the conveyance of the property to the Charter Township of Garfield, Grand Traverse County, as provided in subsection (2), may accept from the Charter Township of

Garfield, for consideration of \$1.00, real property that was

- adjustment as the state administrative board or attorney generalconsiders necessary by survey or other legal description.
- **3** (4) Any conveyance of property under subsection (2) must not
- 4 contain any restriction, as required by section 3(10) of 1993 PA
- 5 38, relating to a memorandum of agreement between the department of
- 6 management and budget, now the department of technology,
- 7 management, and budget, and the Grand Traverse Commons
- 8 Redevelopment Corporation. However, the conveyance must contain any
- 9 other restrictions required by 1993 PA 38 and both of the following
- 10 restrictions:
- 11 (a) That the land must be used solely and exclusively for non-12 motorized public purposes.
- 13 (b) That changes to the property must not exacerbate any known or unknown contaminated soils.
- 15 (5) If property conveyed under this act is used in a manner
 16 that violates any of the restrictions imposed under subsection (4),
 17 this state may reenter and take the property, terminating the
 18 grantee's or any successor's estate in the property. An action to
- 19 regain possession of the property may be brought and maintained by
- ${f 20}$ the attorney general on behalf of this state.
- 21 (6) If this state reenters and repossesses property under 22 subsection (5), this state is not liable to reimburse any person 23 for any improvements made on the property or to compensate any 24 person for any part of an unfulfilled contract or license issued to 25 provide goods or services on or for the property.
- (7) The state administrative board shall make the conveyance
 authorized by subsection (2) by quitclaim deed or other instrument
 approved by the attorney general.
