SENATE BILL NO. 886

April 24, 2020, Introduced by Senator HORN and referred to the Committee on Government Operations.

A bill to amend 1936 (Ex Sess) PA 1, entitled "Michigan employment security act,"

by amending sections 17, 27, 28, 28c, 29, and 48 (MCL 421.17, 421.27, 421.28, 421.28c, 421.29, and 421.48), sections 17 and 48 as amended by 2011 PA 269, section 27 as amended by 2016 PA 522, section 28 as amended by 2020 PA 83, section 28c as amended by 2012 PA 579, and section 29 as amended by 2013 PA 146.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 17. (1) The unemployment agency shall maintain in the
 unemployment compensation fund a nonchargeable benefits account and

- 1 a separate experience account for each employer as provided in this
- 2 section. This act does not give an employer or individuals in the
- 3 employer's service prior claims or rights to the amount paid by the
- 4 employer to the unemployment compensation fund. All contributions
- 5 to that fund shall be pooled and available to pay benefits to any
- 6 individual entitled to the benefits under this act, irrespective of
- 7 the source of the contributions.
- 8 (2) The nonchargeable benefits account shall be credited with
- 9 the following:
- 10 (a) All net earnings received on money, property, or
- 11 securities in the fund.
- 12 (b) Any positive balance remaining in the employer's
- 13 experience account as of the second June 30 computation date
- 14 occurring after the employer has ceased to be subject to this act
- 15 or after the employer has elected to change from a contributing
- 16 employer to a reimbursing employer.
- 17 (c) The proceeds of the nonchargeable benefits component of
- 18 employers' contribution rates determined as provided in section
- **19** (a) (5).
- 20 (d) All reimbursements received under section 11(c).
- (e) All amounts that may be paid or advanced by the federal
- 22 government under section 903 or section 1201 of the social security
- 23 act, 42 USC 1103 and 1321, to the account of the state in the
- 24 federal unemployment trust fund.
- 25 (f) All benefits improperly paid to claimants that have been
- 26 recovered and that were previously charged to an employer's
- 27 account.
- 28 (g) Any benefits forfeited by an individual by application of
- 29 section 62(b).

- (h) The amount of any benefit check, any employer refund
 check, any claimant restitution refund check, or other payment duly
 issued that has not been presented for payment within 1 year after
 the date of issue.
- 5 (i) Any other unemployment fund income not creditable to the6 experience account of any employer.
- 7 (j) Any negative balance transferred to an employer's new8 experience account pursuant to this section.
- 9 (k) Amounts transferred from the contingent fund under section 10.
- 11 (3) The nonchargeable benefits account shall be charged with
 12 the following:
- (a) Any negative balance remaining in an employer's experience
 account as of the second June 30 computation date occurring after
 the employer has ceased to be subject to this act or has elected to
 change from a contributing employer to a reimbursing employer.
- 17 (b) Refunds of amounts erroneously collected due to the 18 nonchargeable benefits component of an employer's contribution 19 rate.
- (c) All training benefits paid under section 27(g) not
 reimbursable by the federal government and based on service with a
 contributing employer.
- (d) Any positive balance credited or transferred to anemployer's new experience account under this subsection.
- 26 (e) Repayments to the federal government of amounts advanced 26 by it under section 1201 of the social security act, 42 USC 1321, 27 to the unemployment compensation fund established by this act.
- (f) The amounts received by the unemployment compensation fund under section 903 of the social security act, 42 USC 1103, that may

- be appropriated to the unemployment agency in accordance with
 subsection (8).
- 3 (g) All benefits determined to have been improperly paid to
 4 claimants that have been credited to employers' accounts in
 5 accordance with section 20(a).
- (h) The amount of any substitute check or other payment issued
 to replace an uncashed benefit check, employer refund check,
 claimant restitution refund check, or other payment previously
 credited to this account.
- 10 (i) The amount of any benefit check or other payment issued
 11 that would be chargeable to the experience account of an employer
 12 who has ceased to be subject to this act, and who has had a balance
 13 transferred from the employer's experience account to the solvency
 14 or nonchargeable benefits account.
- 15 (j) All benefits that become nonchargeable to an employer under section 19(b) or (c), 29(1)(a)(ii) or (iii) or (3), or 42a.
- 17 (k) For benefit years beginning before October 1, 2000, with 18 benefits allocated under section 20(e)(2) for a week of 19 unemployment in which a claimant earns remuneration with a 20 contributing employer that equals or exceeds the amount of benefits 21 allocated to that contributing employer, and for benefit years 22 beginning on or after October 1, 2000, with benefits allocated 23 under section 20(f) for a week of unemployment in which a claimant 24 earns remuneration with a contributing employer that equals or 25 exceeds the amount of benefits allocated to that contributing 26 employer.
- 27 (l) Benefits that are nonchargeable to an employer's account in accordance with section 20(i) or (j).
- 29 (m) Benefits otherwise chargeable to the account of an

- employer when the benefits are payable solely on the basis ofcombining wages paid by a Michigan employer with wages paid by a
- ${f 3}$ non-Michigan employer under the interstate arrangement for
- 4 combining employment and wages under 20 CFR 616.1 to 616.11.
- 5 (4) All contributions paid by an employer shall be credited to6 the unemployment compensation fund, and, except as otherwise
- 7 provided with respect to the proceeds of the nonchargeable benefits
- 8 component of employers' contribution rates by section 19(a)(5), to
- 9 the employer's experience account, as of the date when paid.
- 10 However, those contributions paid during any July shall be credited
- 11 as of the immediately preceding June 30. Additional contributions
- 12 paid by an employer as the result of a retroactive contribution
- 13 rate adjustment, solely for the purpose of this subsection, shall
- 14 be credited to the employer's experience account as if paid when
- 15 due, if the payment is received within 30 days after the issuance
- 16 of the initial assessment that results from the contribution rate
- 17 adjustment and a written request for the application is filed by
- 18 the employer during this period.
- 19 (5) If an employer who has ceased to be subject to this act,
- 20 and who has had a positive or negative balance transferred as
- 21 provided in subsection (2) or (3) from the employer's experience
- 22 account to the solvency or nonchargeable benefits account as of the
- 23 second computation date after the employer has ceased to be subject
- 24 to this act, becomes subject to this act again within 6 years after
- 25 that computation date, the unemployment agency shall transfer the
- 26 positive or negative balance, adjusted by the debits and credits
- 27 that are made after the date of transfer, to the employer's new
- 28 experience account.
- 29 (6) If an employer's status as a reimbursing employer is

- 1 terminated within 6 years after the date the employer's experience
- 2 account as a prior contributing employer was transferred to the
- 3 solvency or nonchargeable benefits account as provided in
- 4 subsection (2) or (3) and the employer continues to be subject to
- 5 this act as a contributing employer, any positive or negative
- 6 balance in the employer's experience account as a prior
- 7 contributing employer, which was transferred to the solvency or
- 8 nonchargeable benefits account, shall be transferred to the
- 9 employer's new experience account. However, an employer who is
- 10 delinquent with respect to any reimbursement payments in lieu of
- 11 contributions for which the employer may be liable shall not have a
- 12 positive balance transferred during the delinquency.
- 13 (7) If a balance is transferred to an employer's new account
- 14 under subsection (5) or (6), the employer shall not be considered a
- 15 "qualified employer" until the employer has again been subject to
- 16 this act for the period set forth in section 19(a)(1).
- 17 (8) All money credited under section 903 of the social
- 18 security act, 42 USC 1103, to the account of the state in the
- 19 federal unemployment trust fund shall immediately be credited by
- 20 the unemployment agency to the fund's nonchargeable benefits
- 21 account. There is authorized to be appropriated to the unemployment
- 22 agency from the money credited to the nonchargeable benefits
- 23 account under this subsection, an amount determined to be necessary
- 24 for the proper and efficient administration by the unemployment
- 25 agency of this act for purposes for which federal grants under
- 26 title 3 of the social security act, 42 USC 501 to 504, and the
- 27 Wagner-Peyser act, 29 USC 49 to 49l-2, are not available or are
- 28 insufficient. The appropriation shall expire not more than 2 years
- 29 after the date of enactment and shall provide that any unexpended

- 1 balance shall then be credited to the nonchargeable benefits
- 2 account. An appropriation shall not be made under this subsection
- 3 for an amount that exceeds the "adjusted balance" of the
- 4 nonchargeable benefits account on the most recent computation date.
- 5 Appropriations made under this subsection shall limit the total
- 6 amount that may be obligated by the unemployment agency during a
- 7 fiscal year to an amount that does not exceed the amount by which
- 8 the aggregate of the amounts credited to the nonchargeable benefits
- 9 account under this subsection during the fiscal year and the 24
- 10 preceding fiscal years, exceeds the aggregate of the amounts
- 11 obligated by the unemployment agency by appropriation under this
- 12 subsection and charged against the amounts thus credited to the
- 13 nonchargeable benefits account during any of the 25 fiscal years
- 14 and any amounts credited to the nonchargeable benefits account that
- 15 have been used for the payment of benefits.
- 16 (9) Notwithstanding any other provision of this act, any
- 17 benefit paid to a claimant that is laid off or placed on a leave of
- 18 absence because of COVID-19 must not be charged to the account of
- 19 the employer who otherwise would have been charged but instead must
- 20 be charged to the nonchargeable benefits account. This subsection
- 21 does not apply to an employer determined to have misclassified a
- 22 worker.
- 23 Sec. 27. (a) (1) When a determination, redetermination, or
- 24 decision is made that benefits are due an unemployed individual,
- 25 the benefits become payable from the fund and continue to be
- 26 payable to the unemployed individual, subject to the limitations
- 27 imposed by the individual's monetary entitlement, if the individual
- 28 continues to be unemployed and to file claims for benefits, until
- 29 the determination, redetermination, or decision is reversed, a

- 1 determination, redetermination, or decision on a new issue holding
- 2 the individual disqualified or ineligible is made, or, for benefit
- 3 years beginning before October 1, 2000, a new separation issue
- 4 arises resulting from subsequent work.
- 5 (2) Benefits are payable in person or by mail through
- 6 employment security offices in accordance with rules promulgated by
- 7 the unemployment agency.
- 8 (b) (1) Subject to subsection (f), the weekly benefit rate for
- 9 an individual, with respect to benefit years beginning before
- 10 October 1, 2000, is 67% of the individual's average after tax
- 11 weekly wage, except that the individual's maximum weekly benefit
- 12 rate must not exceed \$300.00. However, with respect to benefit
- 13 years beginning on or after October 1, 2000, the individual's
- 14 weekly benefit rate is 4.1% of the individual's wages paid in the
- 15 calendar quarter of the base period in which the individual was
- 16 paid the highest total wages, plus \$6.00 for each dependent as
- 17 defined in subdivision (4), up to a maximum of 5 dependents,
- 18 claimed by the individual at the time the individual files a new
- 19 claim for benefits, except that the individual's maximum weekly
- 20 benefit rate must not exceed \$300.00 before April 26, 2002 and
- 21 \$362.00 for claims filed on and after April 26, 2002. The weekly
- 22 benefit rate for an individual claiming benefits on and after April
- 23 26, 2002 must be recalculated subject to the \$362.00 maximum weekly
- 24 benefit rate. The unemployment agency shall establish the
- 25 procedures necessary to verify the number of dependents claimed. If
- 26 a person fraudulently claims a dependent, that person is subject to
- 27 the penalties set forth in sections 54 and 54c. For benefit years
- 28 beginning on or after October 2, 1983, the weekly benefit rate must
- 29 be adjusted to the next lower multiple of \$1.00.

- 1 (2) For benefit years beginning before October 1, 2000, the 2 state average weekly wage for a calendar year is computed on the 3 basis of the 12 months ending the June 30 immediately before that 4 calendar year.
- 5 (3) For benefit years beginning before October 1, 2000, a 6 dependent means any of the following persons who are receiving and 7 for at least 90 consecutive days immediately before the week for 8 which benefits are claimed, or, in the case of a dependent husband, wife, or child, for the duration of the marital or parental 9 10 relationship, if the relationship has existed less than 90 days, has received more than 1/2 the cost of his or her support from the 11 12 individual claiming benefits:
- (a) A child, including stepchild, adopted child, or grandchild of the individual who is under 18 years of age, or 18 years of age or over if, because of physical or mental infirmity, the child is unable to engage in a gainful occupation, or is a full-time student as defined by the particular educational institution, at a high school, vocational school, community or junior college, or college or university and has not attained the age of 22.
 - (b) The husband or wife of the individual.

- (c) The legal father or mother of the individual if that

 - (d) A brother or sister of the individual if the brother or sister is orphaned or the living parents are dependent parents of an individual, and the brother or sister is under 18 years of age, or 18 years of age or over if, because of physical or mental infirmity, the brother or sister is unable to engage in a gainful occupation, or is a full-time student as defined by the particular

- 3 (5) The number of dependents established for an individual at
 4 the beginning of the benefit year shall remain in effect during the

 7 established or fixed in favor of a person is not transferable to or
 8 usable by another person with respect to the same week.

Failure on the part of an individual, due to misinformation or lack of information, to furnish all information material for determination of the number of the individual's dependents is good cause to issue a redetermination as to the amount of benefits based on the number of the individual's dependents as of the beginning of the benefit year.

- (1) Each eligible individual must be paid a weekly benefit rate with respect to the week for which the individual earns or receives no remuneration. Notwithstanding the definition of week in section 50, if within 2 consecutive weeks in which an individual was not unemployed within the meaning of section 48 there was a period of 7 or more consecutive days for which the individual did not earn or receive remuneration, that period is considered a week for benefit purposes under this act if a claim for benefits for that period is filed not later than 30 days after the end of the period.
- (2) The weekly benefit rate is reduced with respect to each
 week in which the eligible individual earns or receives
 remuneration at the rate of 40 cents for each whole \$1.00 of

- 1 remuneration earned or received during that week. Beginning October
- 2 1, 2015, an eligible individual's weekly benefit rate is reduced at
- 3 the rate of 50 cents for each whole \$1.00 of remuneration in which
- 4 the eligible individual earns or receives remuneration in that

- (b) The number of individuals who received or earned partial remuneration at or exceeding the applicable limit of 1-1/2 or 1-3/5 times their weekly benefit amount prescribed in subdivision (3) for any 1 or more weeks during the immediately preceding calendar year.
 - (7) The unemployment agency shall not use prorated quarterly wages to establish a reduction in benefits under this subsection.
- (d) Subject to subsection (f) and this subsection, the maximum benefit amount payable to an individual in a benefit year for purposes of this section and section 20(d) is the number of weeks of benefits payable to an individual during the benefit year, multiplied by the individual's weekly benefit rate. The number of weeks of benefits payable to an individual shall be calculated by taking 43% of the individual's base period wages and dividing the result by the individual's weekly benefit rate. If the quotient is not a whole or half number, the result is rounded down to the nearest half number. - (d) If the unemployment benefit payable under this act is computed on the basis of multiemployer credit weeks and a portion of the benefit is allocable under section 20(e) to an employer who has contributed to the financing of a retirement plan under which the claimant is receiving or will receive a retirement benefit, the adjustments required by subparagraph (a) or (b) apply only to that portion of the weekly benefit rate that would otherwise be allocable and chargeable to the employer.
- 29 (2) If an individual's weekly benefit rate under this act was

- 1 established before the period for which the individual first

- 2 (i) Less than 1/2 of the cost of the benefit, then only 1/2 of3 the benefit is treated as a retirement benefit.
- 4 (ii) One-half or more of the cost of the benefit, then none of5 the benefit is treated as a retirement benefit.
- (c) The burden of establishing the extent of an individual's
 contribution to the cost of his or her retirement benefit for the
 purpose of subparagraph (b) is upon the employer who has
 contributed to the plan under which a benefit is provided.
 - (5) Notwithstanding any other provision of this subsection, for any week that begins after March 31, 1980, and with respect to which an individual is receiving a governmental or other pension and claiming unemployment compensation, the weekly benefit amount payable to the individual for those weeks is reduced, but not below zero, by the entire prorated weekly amount of any governmental or other pension, retirement or retired pay, annuity, or any other similar payment that is based on any previous work of the individual. However, an 26 individual's extended benefit account and an individual's weekly 27 extended benefit rate under section 64 is established without 28 reduction under this subsection, unless subdivision (5) is in 29 effect. Except as otherwise provided in this subsection, all the

- 1 other provisions of this act apply to the benefit claims of those
- 2 retired persons. However, if the reduction would impair the full
- 3 tax credit against the tax imposed by the federal unemployment tax

- 7 or other similar payment that was not includable in the gross
- 8 income of the individual for the taxable year in which it was
- 9 received because it was a part of a rollover distribution.
- 10 (a) If any base period or chargeable employer has contributed
- 11 to the financing of a retirement plan under which the claimant is
- 12 receiving or will receive a retirement benefit yielding a pro rata
- 13 weekly amount equal to or larger than the claimant's weekly benefit
- 14 rate as otherwise established under this act, the claimant is not
- 15 eligible to receive unemployment benefits.
- 16 (b) If any base period employer or chargeable employer has
- 17 contributed to the financing of a retirement plan under which the
- 18 claimant is receiving or will receive a retirement benefit yielding
- 19 a pro rata weekly amount less than the claimant's weekly benefit
- 20 rate as otherwise established under this act, then the weekly
- 21 benefit rate otherwise payable to the claimant is reduced by an
- 22 amount equal to the pro rata weekly amount, adjusted to the next
- 23 lower multiple of \$1.00, which the claimant is receiving or will
- 24 receive as a retirement benefit.
- (c) If no base period or separating employer has contributed
- 26 to the financing of a retirement plan under which the claimant is
- 27 receiving or will receive a retirement benefit, then the weekly
- 28 benefit rate of the claimant as otherwise established under this
- 29 act shall not be reduced due to receipt of a retirement benefit.

- 1 (q) Notwithstanding any other provision of this act, an
- 2 individual pursuing vocational training or retraining pursuant to
- 3 section 28(2) who has exhausted all benefits available under
- 4 subsection (d) may be paid for each week of approved vocational
- 5 training pursued beyond the date of exhaustion a benefit amount in
- 6 accordance with subsection (c), but not in excess of the
- 7 individual's most recent weekly benefit rate. However, an
- 8 individual must not be paid training benefits totaling more than 18
- 9 times the individual's most recent weekly benefit rate. The
- 10 expiration or termination of a benefit year does not stop or
- 11 interrupt payment of training benefits if the training for which
- 12 the benefits were granted began before expiration or termination of
- 13 the benefit year.
- 14 (h) A payment of accrued unemployment benefits is not payable
- 15 to an eliqible individual or in behalf of that individual as
- 16 provided in subsection (e) more than 6 years after the ending date
- 17 of the benefit year covering the payment or 2 calendar years after
- 18 the calendar year in which there is final disposition of a
- 19 contested case, whichever is later.
- 20 (i) Benefits based on service in employment described in
- 21 section 42(8), (9), and (10) are payable in the same amount, on the
- 22 same terms, and subject to the same conditions as compensation
- 23 payable on the basis of other service subject to this act, except
- **24** that:
- 25 (1) With respect to service performed in an instructional,
- 26 research, or principal administrative capacity for an institution
- 27 of higher education as defined in section 53(2), or for an
- 28 educational institution other than an institution of higher
- 29 education as defined in section 53(3), benefits are not payable to

- 1 an individual based on those services for any week of unemployment
- 2 beginning after December 31, 1977 that commences during the period
- 3 between 2 successive academic years or during a similar period
- 4 between 2 regular terms, whether or not successive, or during a
- 5 period of paid sabbatical leave provided for in the individual's
- 6 contract, to an individual if the individual performs the service
- 7 in the first of the academic years or terms and if there is a
- 8 contract or a reasonable assurance that the individual will perform
- 9 service in an instructional, research, or principal administrative
- 10 capacity for an institution of higher education or an educational
- 11 institution other than an institution of higher education in the
- 12 second of the academic years or terms, whether or not the terms are
- 13 successive.
- 14 (2) With respect to service performed in other than an
- 15 instructional, research, or principal administrative capacity for
- 16 an institution of higher education as defined in section 53(2) or
- 17 for an educational institution other than an institution of higher
- 18 education as defined in section 53(3), benefits are not payable
- 19 based on those services for any week of unemployment beginning
- 20 after December 31, 1977 that commences during the period between 2
- 21 successive academic years or terms to any individual if that
- 22 individual performs the service in the first of the academic years
- 23 or terms and if there is a reasonable assurance that the individual
- 24 will perform the service for an institution of higher education or
- 25 an educational institution other than an institution of higher
- 26 education in the second of the academic years or terms.
- 27 (3) With respect to any service described in subdivision (1)
- 28 or (2), benefits are not payable to an individual based upon
- 29 service for any week of unemployment that commences during an

- 1 established and customary vacation period or holiday recess if the
- 2 individual performs the service in the period immediately before
- 3 the vacation period or holiday recess and there is a contract or
- 4 reasonable assurance that the individual will perform the service
- 5 in the period immediately following the vacation period or holiday
- 6 recess.
- 7 (4) If benefits are denied to an individual for any week
- 8 solely as a result of subdivision (2) and the individual was not
- 9 offered an opportunity to perform in the second academic year or
- 10 term the service for which reasonable assurance had been given, the
- 11 individual is entitled to a retroactive payment of benefits for
- 12 each week for which the individual had previously filed a timely
- 13 claim for benefits. An individual entitled to benefits under this

- 5 service with an employer other than an educational institution for
- 6 any week of unemployment occurring between academic years or terms,
- 7 whether or not successive, or during an established and customary
- 8 vacation period or holiday recess, even though the employer is not
- 9 the most recent chargeable employer in the individual's base
- 10 period. However, in that case section 20(b) applies to the sequence
- 11 of benefit charging, except for the employment with the educational
- 12 institution, and section 50(b) applies to the calculation of credit
- 13 weeks. When a denial of benefits under subdivision (1) no longer

- 16 (7) For benefit years beginning on or after October 1, 2000,
- 17 and notwithstanding subdivisions (1), (2), and (3), the denial of
- 18 benefits does not prevent an individual from completing
- 19 requalifying weeks in accordance with section 29(3) and does not
- 20 prevent an individual from receiving benefits based on service with
- 21 another base period employer other than an educational institution
- 22 for any week of unemployment occurring between academic years or
- 23 terms, whether or not successive, or during an established and
- 24 customary vacation period or holiday recess. However, if benefits
- 25 are paid based on service with 1 or more base period employers
- 26 other than an educational institution, the individual's weekly
- 27 benefit rate is calculated in accordance with subsection (b)(1) but
- 28 during the denial period the individual's weekly benefit payment is
- 29 reduced by the portion of the payment attributable to base period

- 1 wages paid by an educational institution and the account or
- 2 experience account of the educational institution is not charged
- 3 for benefits payable to the individual. When a denial of benefits
- 4 under subdivision (1) is no longer applicable, benefits are paid
- 5 and charged on the basis of base period wages with each of the base
- 6 period employers including the educational institution.
- 7 (8) For the purposes of this subsection, "academic year" means
- 8 that period, as defined by the educational institution, when
- 9 classes are in session for that length of time required for
- 10 students to receive sufficient instruction or earn sufficient
- 11 credit to complete academic requirements for a particular grade
- 12 level or to complete instruction in a noncredit course.
- 13 (9) In accordance with subdivisions (1), (2), and (3),
- 14 benefits for any week of unemployment are denied to an individual
- 15 who performed services described in subdivision (1), (2), or (3) in
- 16 an educational institution while in the employ of an educational
- 17 service agency. For the purpose of this subdivision, "educational
- 18 service agency" means a governmental agency or governmental entity
- 19 that is established and operated exclusively for the purpose of
- 20 providing the services to 1 or more educational institutions.
- 21 (j) Benefits are not payable to an individual on the basis of
- 22 any base period services, substantially all of which consist of
- 23 participating in sports or athletic events or training or preparing
- 24 to participate, for a week that commences during the period between
- 25 2 successive sport seasons or similar periods if the individual
- 26 performed the services in the first of the seasons or similar
- 27 periods and there is a reasonable assurance that the individual
- 28 will perform the services in the later of the seasons or similar
- 29 periods.

- (k)(1) Benefits are not payable on the basis of services 1 performed by an alien unless the alien is an individual who was 2 lawfully admitted for permanent residence at the time the services 3 were performed, was lawfully present for the purpose of performing 4 5 the services, or was permanently residing in the United States 6 under color of law at the time the services were performed, 7 including an alien who was lawfully present in the United States under section 212(d)(5) of the immigration and nationality act, 8 8 9 USC 1182.
- 10 (2) Any data or information required of individuals applying 11 for benefits to determine whether benefits are payable because of 12 their alien status are uniformly required from all applicants for 13 benefits.

- (3) If an individual's application for benefits would otherwise be approved, a determination that benefits to that individual are not payable because of the individual's alien status must not be made except upon a preponderance of the evidence.
- (m) (1) An individual filing a new claim for unemployment compensation under this act, at the time of filing the claim, shall disclose whether the individual owes child support obligations as defined in this subsection. If an individual discloses that he or she owes child support obligations and is determined to be eligible for unemployment compensation, the unemployment agency shall notify the state or local child support enforcement agency enforcing the obligation that the individual has been determined to be eligible for unemployment compensation.
- (2) Notwithstanding section 30, the unemployment agency shall
 deduct and withhold from any unemployment compensation payable to
 an individual who owes child support obligations by using whichever

- (a) The amount, if any, specified by the individual to bededucted and withheld under this subdivision.
- 4 (b) The amount, if any, determined pursuant to an agreement 5 submitted to the commission under 42 USC 654(19)(B)(i), by the 6 state or local child support enforcement agency.
- 7 (c) Any amount otherwise required to be deducted and withheld 8 from unemployment compensation by legal process, as that term is 9 defined in 42 USC 659(i)(5), properly served upon the commission.
 - (3) The amount of unemployment compensation subject to deduction under subdivision (2) is that portion that remains payable to the individual after application of the recoupment provisions of section 62(a) and the reduction provisions of subsections (c) and (f).

- 24 classification system United States Office of Management and
- 25 Budget, 1997 edition.
- (b) "Normal seasonal work period" means that period or those
- 27 periods of time determined under rules promulgated by the
- 28 unemployment agency during which an individual is employed in
- 29 seasonal employment.

- 1 (c) "Seasonal employment" means the employment of 1 or more 2 individuals primarily hired to perform services during regularly 3 recurring periods of 26 weeks or less in any 52-week period other 4 than services in the construction industry.
- 5 (d) "Seasonal employer" means an employer, other than an 6 employer in the construction industry, who applies to the 7 unemployment agency for designation as a seasonal employer and who 8 the unemployment agency determines is an employer whose operations 9 and business require employees engaged in seasonal employment. A 10 seasonal employer designation under this act need not correspond to 11 a category assigned under the North American classification system 12 - United States Office of Management and Budget.
- (e) "Seasonal worker" means a worker who has been paid wages
 by a seasonal employer for work performed only during the normal
 seasonal work period.
- (10) This subsection does not apply if the United States 16 17 Department of Labor finds it to be contrary to the federal 18 unemployment tax act, 26 USC 3301 to 3311, or the social security 19 act, chapter 531, 49 Stat 620, and if conformity with the federal 20 law is required as a condition for full tax credit against the tax imposed under the federal unemployment tax act, 26 USC 3301 to 21 3311, or as a condition for receipt by the commission of federal 22 23 administrative grant funds under the social security act, chapter 24 531, 49 Stat 620.
- 25 (p) Benefits are not payable to an individual based upon his
 26 or her services as a school crossing guard for any week of
 27 unemployment that begins between 2 successive academic years or
 28 terms, if that individual performs the services of a school
 29 crossing guard in the first of the academic years or terms and has

- a reasonable assurance that he or she will perform those servicesin the second of the academic years or terms.
- 3 Sec. 28. (1) An unemployed individual is eligible to receive 4 benefits with respect to any week only if the unemployment agency 5 finds all of the following:
- 6 (a) The individual has registered for work and has continued 7 to report pursuant to unemployment agency rules and is actively 8 engaged in seeking work.  10 retraining only if the unemployment agency finds all of the
 11 following:
- (a) Reasonable opportunities for employment in occupations for which the individual is fitted by training and experience do not exist in the locality in which the individual is claiming benefits.
- (b) The vocational training course relates to an occupation or skill for which there are, or are expected to be in the immediate future, reasonable employment opportunities.
- (c) The training course has been approved by a local advisory council on which both management and labor are represented, or, if there is no local advisory council, by the unemployment agency.
 - (d) The individual has the required qualifications and aptitudes to complete the course successfully.

- (e) The vocational training course has been approved by the
 state board of education and is maintained by a public or private
 school or by the unemployment agency.
- (3) Notwithstanding any other provision of this act, an
 otherwise eligible individual is not ineligible for benefits
 because he or she is participating in training with the approval of
 the unemployment agency. For each week that the unemployment agency

- 1 finds that an individual who is claiming benefits under this act
- 2 and who is participating in training with the approval of the
- 3 unemployment agency is satisfactorily pursuing an approved course

- 19 individual be denied benefits by reason of leaving work to enter
- 20 such training if the work left is not suitable employment.
- 21 Furthermore, an otherwise eligible individual must not be denied

- 6 January 1, 2013, to be actively engaged in seeking work, an
- 7 individual must conduct a systematic and sustained search for work
- 8 in each week the individual is claiming benefits, using any of the
- 9 following methods to report the details of the work search:
- 10 (a) Reporting at monthly intervals on the unemployment
- 11 agency's online reporting system the name of each employer and
- 12 physical or online location of each employer where work was sought
- 13 and the date and method by which work was sought with each

- (c) Appearing at least monthly in person at a Michigan works
- 23 agency office to report the name and physical or online location of
- 24 each employer where the individual sought work during the previous
- 25 month and the date and method by which work was sought with each
- 26 employer.
- 27 (7) For purposes of this section, beginning on the effective
- 28 date of the amendatory act that added this subsection, April 2,
- 29 2020, to be actively engaged in seeking work, an individual must

- 1 conduct a systematic and sustained search for work in each week the
- 2 individual is claiming benefits and must report to the unemployment
- 3 agency the details of the work search at least once every 2 weeks
- 4 or, if the unemployment agency prescribes a shorter reporting

- 21 or using an online career tool. Creating duplicate user profiles or
- 22 resubmitting or reuploading the same resume to the same
- 23 professional networking site does not satisfy the requirements of
- 24 this subdivision.
- 25 (d) Applying for an available position with, submitting a
- 26 resume to, or interviewing with employers. Applying for the same
- 27 position within a 4-week period or contacting an employer to
- 28 determine whether a position is available does not satisfy the
- 29 requirements of this subdivision, unless the individual uses his or

- 1 her union hiring hall to conduct a search for work.
- 2 (e) Registering for work with a private employment agency or,
- 3 if it is available to the individual in his or her occupation or
- 4 profession, the placement facility of a school, college, or
- 5 university.
- **6** (f) Taking an examination that is required for a position in
- 7 the state civil service.
- 8 (8) The work search conducted by the claimant is subject to
- 9 audit by the unemployment agency.
- 10 (9) The unemployment agency shall request but shall not
- 11 require an individual who is applying for benefits to submit his or
- 12 her base period employer's unemployment agency account number and
- 13 federal employer identification number.
- 14 (10) The unemployment agency shall use all of the
- 15 documentation and information provided by an individual applying
- 16 for benefits to verify the identity of the individual before making
- 17 an initial payment on the individual's claim.
- 18 Sec. 28c. (1) An employer that meets all of the following
- 19 requirements may apply to the unemployment agency for approval of a
- 20 shared-work plan:
- 21 (a) The employer has filed all quarterly reports and other
- 22 reports required under this act and has paid all obligation
- 23 assessments, contributions, reimbursements in lieu of
- 24 contributions, interest, and penalties due through the date of the

- (c) The employer's assurance that it will not lay off participating employees during the effective period of the shared-work plan, or reduce participating employees' hours of work by more than the reduction percentage during the effective period of the shared-work plan, except in cases of holidays, designated vacation periods, equipment maintenance, or similar circumstances.
 - (d) The employer's certification that it has obtained the approval of any applicable collective bargaining unit representative and has notified all affected employees who are not in a collective bargaining unit of the proposed shared-work plan.
- (e) A list of the week or weeks within the requested effective period of the plan during which participating employees are anticipated to work fewer hours than the number of hours determined under section 28d(1)(e) due to circumstances listed in subdivision (c).

- 29 (b) Was suspended or discharged for misconduct connected with

1 the individual's work or for intoxication while at work.

- (c) Failed without good cause to apply diligently for available suitable work after receiving notice from the unemployment agency of the availability of that work or failed to apply for work with employers that could reasonably be expected to have suitable work available.
- (d) Failed without good cause while unemployed to report to the individual's former employer or employing unit within a reasonable time after that employer or employing unit provided notice of the availability of an interview concerning available suitable work with the former employer or employing unit.
- (e) Failed without good cause to accept suitable work offered to the individual or to return to the individual's customary selfemployment, if any, when directed by the employment office or the unemployment agency. An employer that receives a monetary determination under section 32 may notify the unemployment agency regarding the availability of suitable work with the employer on the monetary determination or other form provided by the unemployment agency. Upon receipt of the notice of the availability of suitable work, the unemployment agency shall notify the claimant of the availability of suitable work. Until 1 year after the effective date of the amendatory act that added this sentence, an individual is considered to have refused an offer of suitable work if the prospective employer requires as a condition of the offer a drug test that is subject to the same terms and conditions as a drug test administered under subdivision (m), and the employer withdraws the conditional offer after either of the following:
- (i) The individual tests positive for a controlled substance and lacks a valid, documented prescription, as defined in section

- 5 (d) For benefit years beginning on or after October 1, 2000,
- 6 after the week in which the disqualifying act or discharge
- 7 occurred, an individual shall complete 13 requalifying weeks if he
- 8 or she was disqualified under subsection (1)(c), (d), (e), (f),
- **9** (g), or (l), or 26 regularitying weeks if he or she was disqualified
- 10 under subsection (1)(h), (i), (j), (k), (m), or (n). A requalifying
- 11 week required under this subdivision is each week in which the
- 12 individual does any of the following:
- 13 (i) Earns or receives remuneration in an amount equal to at
- 14 least 1/13 of the minimum amount needed in a calendar quarter of
- 15 the base period for an individual to qualify for benefits, rounded
- 16 down to the nearest whole dollar.
- (ii) Otherwise meets all of the requirements of this act to
- 18 receive a benefit payment if the individual was not disqualified
- 19 under subsection (1).
- 20 (e) For benefit years beginning on or after October 1, 2000
- 21 and beginning before April 26, 2002, if the individual is
- 22 disqualified under subsection (1)(a) or (b), he or she shall
- 23 regualify, after the week in which the disgualifying act or
- 24 discharge occurred by earning in employment for an employer liable
- 25 under this act or the unemployment compensation law of another
- 26 state at least the lesser of the following:
- 27 (i) Seven times the individual's weekly benefit rate.
- 28 (ii) Forty times the state minimum hourly wage times 7.
- (f) For benefit years beginning on or after April 26, 2002, if

- 1 the individual is disqualified under subsection (1)(a), he or she
- 2 shall requalify, after the week in which the disqualifying act or
- 3 discharge occurred by earning in employment for an employer liable
- 4 under this act or the unemployment compensation law of another
- 5 state at least 12 times the individual's weekly benefit rate.
- 6 (g) For benefit years beginning on or after April 26, 2002, if
- 7 the individual is disqualified under subsection (1)(b), he or she
- 8 shall requalify, after the week in which the disqualifying act or
- 9 discharge occurred by earning in employment for an employer liable
- 10 under this act or the unemployment compensation law of another
- 11 state at least 17 times the individual's weekly benefit rate.
- 12 (h) A benefit payable to the individual disqualified or
- 13 separated under disqualifying circumstances under subsection (1)(a)
- 14 or (b) —shall be charged to the nonchargeable benefits account,
- 15 and not to the account of the employer with whom the individual was
- 16 involved in the separation. Benefits payable to an individual
- 17 determined by the unemployment agency to be separated under
- 18 disqualifying circumstances shall not be charged to the account of
- 19 the employer involved in the disqualification for any period after
- 20 the employer notifies the unemployment agency of the claimant's
- 21 possible ineligibility or disqualification. However, an individual

- (c) For benefit years established before October 1, 2000, an individual disqualified under subsection (1)(h), (i), (j), (k), or (m) is not entitled to benefits based on wages and credit weeks earned before the disqualifying act or discharge with the employer involved in the disqualification.

- 5 (f) For benefit years established on or after October 1, 2000,
- 6 if the individual is disqualified under subsection (1)(c), (d),
- 7 (e), (f), (g), or (l), the maximum number of weeks otherwise
- 8 applicable in calculating benefits for the individual under section
- 9 27(d) shall be reduced by the lesser of the following:
- 10 (i) The number of requalifying weeks required of the individual
- 11 under this section.
- 12 (ii) The number of weeks of benefit entitlement remaining on
- 13 the claim.
- 14 (g) For benefit years beginning on or after October 1, 2000,
- 15 the benefits of an individual disqualified under subsection (1)(h),
- 16 (i), (\dot{j}), (\dot{k}), (\dot{m}), or (\dot{n}) shall be reduced by 13 weeks and any
- 17 weekly benefit payments made to the claimant thereafter shall be
- 18 reduced by the portion of the payment attributable to base period

- 22 (5) If an individual leaves work to accept permanent full-time
- 23 work with another employer or to accept a referral to another

- 26 accept a recall from a former employer, all of the following apply:
- 27 (a) Subsection (1) does not apply.
- 28 (b) Wages earned with the employer whom the individual last
- 29 left, including wages previously transferred under this subsection

- 1 to the last employer, for the purpose of computing and charging
- 2 benefits, are wages earned from the employer with whom the

- 8 (a) If the position offered is vacant due directly to a
- 9 strike, lockout, or other labor dispute.
- 10 (b) If the remuneration, hours, or other conditions of the
- 11 work offered are substantially less favorable to the individual
- 12 than those prevailing for similar work in the locality.
- 13 (c) If as a condition of being employed, the individual would
- 14 be required to join a company union or to resign from or refrain
- 15 from joining a bona fide labor organization.
- 16 (8) All of the following apply to an individual who seeks
- 17 benefits under this act:
- 18 (a) An individual is disqualified from receiving benefits for
- 19 a week in which the individual's total or partial unemployment is
- 20 due to either of the following:
- 21 (i) A labor dispute in active progress at the place at which
- 22 the individual is or was last employed, or a shutdown or start-up
- 23 operation caused by that labor dispute.
- 24 (ii) A labor dispute, other than a lockout, in active progress
- 25 or a shutdown or start-up operation caused by that labor dispute in
- 26 any other establishment within the United States that is both
- 27 functionally integrated with the establishment described in
- 28 subparagraph (i) and operated by the same employing unit.
- 29 (b) An individual's disqualification imposed or imposable

- 1 under this subsection is terminated if the individual performs
- 2 services in employment with an employer in at least 2 consecutive
- 3 weeks falling wholly within the period of the individual's total or
- 4 partial unemployment due to the labor dispute, and in addition

- 24 the individual voluntarily stops working, other than at the
- 25 direction of the individual's employing unit, in sympathy with
- 26 employees in some other establishment or department in which a
- 27 labor dispute is in progress.
- 28 (iv) The individual's total or partial unemployment is due to a
- 29 labor dispute that was or is in progress in a department, unit, or

- 1 group of workers in the same establishment.
- 2 (d) As used in this subsection, "directly interested" shall be
- 3 construed and applied so as not to disqualify individuals
- 4 unemployed as a result of a labor dispute the resolution of which
- 5 may not reasonably be expected to affect their wages, hours, or
- 6 other conditions of employment, and to disqualify individuals whose
- 7 wages, hours, or conditions of employment may reasonably be
- 8 expected to be affected by the resolution of the labor dispute. A
- 9 "reasonable expectation" of an effect on an individual's wages,
- 10 hours, or other conditions of employment exists, in the absence of
- 11 a substantial preponderance of evidence to the contrary, in any of
- 12 the following situations:
- 13 (i) If it is established that there is in the particular
- 14 establishment or employing unit a practice, custom, or contractual
- 15 obligation to extend within a reasonable period to members of the
- 16 individual's grade or class of workers in the establishment in
- 17 which the individual is or was last employed changes in terms and
- 18 conditions of employment that are substantially similar or related
- 19 to some or all of the changes in terms and conditions of employment
- 20 that are made for the workers among whom there exists the labor
- 21 dispute that has caused the individual's total or partial
- 22 unemployment.
- (ii) If it is established that 1 of the issues in or purposes
- 24 of the labor dispute is to obtain a change in the terms and
- 25 conditions of employment for members of the individual's grade or
- 26 class of workers in the establishment in which the individual is or
- 27 was last employed.
- 28 (iii) If a collective bargaining agreement covers both the
- 29 individual's grade or class of workers in the establishment in

- 1 which the individual is or was last employed and the workers in
- 2 another establishment of the same employing unit who are actively
- 3 participating in the labor dispute, and that collective bargaining
- 4 agreement is subject by its terms to modification, supplementation,
- 5 or replacement, or has expired or been opened by mutual consent at
- 6 the time of the labor dispute.
- 7 (e) In determining the scope of the grade or class of workers,
- 8 evidence of the following is relevant:
- 9 (i) Representation of the workers by the same national or
- 10 international organization or by local affiliates of that national
- 11 or international organization.
- (ii) Whether the workers are included in a single, legally
- 13 designated, or negotiated bargaining unit.
- 14 (iii) Whether the workers are or within the past 6 months have
- 15 been covered by a common master collective bargaining agreement
- 16 that sets forth all or any part of the terms and conditions of the
- 17 workers' employment, or by separate agreements that are or have
- 18 been bargained as a part of the same negotiations.
- 19 (iv) Any functional integration of the work performed by those
- 20 workers.
- 21 (v) Whether the resolution of those issues involved in the
- 22 labor dispute as to some of the workers could directly or
- 23 indirectly affect the advancement, negotiation, or settlement of
- 24 the same or similar issues in respect to the remaining workers.
- 25 (vi) Whether the workers are currently or have been covered by
- 26 the same or similar demands by their recognized or certified
- 27 bargaining agent or agents for changes in their wages, hours, or
- 28 other conditions of employment.
- (vii) Whether issues on the same subject matter as those

- involved in the labor dispute have been the subject of proposals ordemands made upon the employing unit that would by their terms have
- 3 applied to those workers.
- 4 (9) Notwithstanding subsections (1) to (8), if the employing
- 5 unit submits notice to the unemployment agency of possible
- 6 ineligibility or disqualification beyond the time limits prescribed
- 7 by unemployment agency rule and the unemployment agency concludes
- 8 that benefits should not have been paid, the claimant shall repay
- 9 the benefits paid during the entire period of ineligibility or

- 20 Sec. 48. (1) An individual shall be considered unemployed for
- 21 any week during which he or she performs no services and for which
- 22 remuneration is not payable to the individual, or for any week of
- 23 less than full-time work if the remuneration payable to the

- 11 immunocompromised, displayed the symptoms of COVID-19, had contact
- 12 in the last 14 days with an individual with a confirmed diagnosis
- 13 of COVID-19, needed to care for an individual with a confirmed
- 14 diagnosis of COVID-19, or had a family care responsibility that was
- 15 the result of a government directive regarding COVID-19, must be
- 16 considered to be unemployed unless the individual is already on
- 17 sick leave or receives a disability benefit.
