A bill to amend 1978 PA 368, entitled "Public health code,"

(MCL 333.1101 to 333.25211) by adding section 20955.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 20955. (1) An individual who is retired from practicing
- 2 as a medical first responder, emergency medical technician,
- 3 emergency medical technician specialist, paramedic, or emergency
- 4 medical services instructor-coordinator and wishes to donate his or

- 1 her expertise for the patient care of indigent and needy
- 2 individuals in this state or for the patient care of individuals in
- 3 medically underserved areas of this state may obtain a special
- 4 retiree license to practice as a medical first responder, emergency
- 5 medical technician, emergency medical technician specialist,
- 6 paramedic, or emergency medical services instructor-coordinator
- 7 from which he or she is retired by submitting an application to the
- 8 department under this section. An applicant shall submit an
- 9 application for a special retiree license on a form provided by the
- 10 department and shall include each of the following:
- 11 (a) Documentation that the individual has been previously
- 12 licensed to practice as a medical first responder, emergency
- 13 medical technician, emergency medical technician specialist,
- 14 paramedic, or emergency medical services instructor-coordinator in
- 15 this state and that his or her license was in good standing at the
- 16 time his or her license expired.
- 17 (b) Acknowledgment and documentation that the applicant will
- 18 not receive any payment or compensation, either direct or indirect,
- 19 or have the expectation of any payment or compensation, for any

- 22 years, documentation that, during the 3 years immediately preceding

- 8 (3) Except as otherwise provided in this subsection, an
- 9 individual who is granted a special retiree license under this
- 10 section and who accepts the privilege of practicing as a medical

- 12 technician specialist, paramedic, or emergency medical services
- 13 instructor-coordinator in this state is subject to all the

- 17 instructor-coordinator, including those provisions concerning
- 18 continuing education and disciplinary action.
- 19 (4) For purposes of this section, an individual is considered
- 20 retired from practicing as a medical first responder, emergency
- 21 medical technician, emergency medical technician specialist,
- 22 paramedic, or emergency medical services instructor-coordinator if
- 23 the individual's license has expired with the individual's
- 24 intention of ceasing to engage, for remuneration, in practicing as
- 25 a medical first responder, emergency medical technician, emergency
- 26 medical technician specialist, paramedic, or emergency medical
- 27 services instructor-coordinator.
- 28 (5) An individual who is granted a special retiree license
- 29 under this section shall only perform activities in a manner that

- 1 is consistent with his or her education, licensure, and approved
- 2 medical control authority protocols as a medical first responder,
- 3 emergency medical technician, emergency medical technician
- 4 specialist, paramedic, or emergency medical services instructor-
- 5 coordinator for which he or she was licensed before his or her
- 6 retirement.
