by amending section 10b (MCL 400.10b), as amended by 2017 PA 13, and by adding section 14m.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 10b. (1) Subject to subsection (3) and except as provided
- 2 in subsection (5), the department shall not grant cash assistance
- 3 under this act to an individual if the department receives

- 8 (a) "Abscond" and "actively seeking" mean those terms as
- 9 defined in section 84 of the corrections code of 1953, 1953 PA 232,

- 11 (b) "Cash assistance" means cash benefits provided under the
- 12 family independence program, the refugee assistance program, or
- 13 state disability assistance.
- 14 (c) "Food assistance" means the food benefits provided under
- 15 the food assistance program administered under this act.
- 16 Sec. 14m. A felony conviction for a violation of part 74 of
- 17 the public health code, 1978 PA 368, MCL 333.7401 to 333.7461, does
- 18 not automatically make an individual ineligible to receive food
- 19 assistance benefits.
