         Whereas, On May 15, 2019, Representative Larry Inman was

    charged by a federal grand jury with attempted extortion under

- 1 color of official right, solicitation of a bribe, and false
- 2 statement to the Federal Bureau of Investigation (FBI). The charges
- 3 stem from a series of text messages in which he allegedly solicited
- 4 money in exchange for his vote against legislation repealing
- 5 Michigan's prevailing wage; and
- 6 Whereas, Representative Larry Inman subsequently made
- 7 statements to numerous press outlets that seem to acknowledge the
- 8 authenticity of the text messages underlying the criminal charges
- 9 against him, including by positing, "Text messages can be taken out
- 10 of context," and inexcusably declaring, "I think that's the lesson
- 11 learned: If you're going to have a communication with a lobbyist,
- 12 have it one-on-one rather than by text"; and
- Whereas, Representative Larry Inman's pattern of conduct,
- 14 including both the actions alleged in the indictment and numerous
- 15 public statements made afterward, has drawn ridicule and disgrace
- 16 to the state of Michigan and the Michigan House of Representatives,
- 17 shaking the public trust and confidence in this legislative body,
- 18 staining the honor, dignity, and integrity of the House, and
- 19 distracting from the serious policy issues and debates before this
- 20 body; and
- 21 Whereas, Public trust and confidence in government are
- 22 prerequisites to the functioning of a democratic society; now,
- 23 therefore, be it
- Resolved by the House of Representatives, That it is in the
- 25 best interest of the state and this institution that Representative
- 26 Larry Inman resign from his position as representative of the One
- 27 Hundred-fourth House District, state of Michigan; and be it further
- 28 Resolved, That the House of Representatives hereby urges
- 29 Representative Larry Inman to resign from his position as



- 1 representative of the One Hundred-fourth House District, state of
- 2 Michigan, effective immediately; and be it further
- 3 Resolved, That the House of Representatives reserves the right
- 4 to take further disciplinary action permitted by Article IV,
- 5 Section 16 of the Constitution of the State of Michigan of 1963 and
- 6 the Standing Rules of the House of Representatives in the event
- 7 that Representative Larry Inman does not immediately resign from
- 8 his position as representative of the One Hundred-fourth House
- 9 District, state of Michigan; and be it further
- 10 Resolved, That copies of this resolution be delivered to
- 11 Representative Larry Inman.
