A resolution to declare October 15, 2020, as Pregnancy and 1 Infant Loss Remembrance Day in the state of Michigan. 2 3 Whereas, Each year, approximately one million pregnancies in the United States end in miscarriage, stillbirth, or the death of a 4 5 newborn baby. It is a great tragedy to lose the life of a child. 6 Babies sometimes live within or outside their mothers' wombs for 7 only a short period of time. Even the shortest lives are still 8 valuable and the grief of those who mourn the loss of these lives 9 should not be trivialized; and 10 Whereas, The observance of Pregnancy and Infant Loss 11 Remembrance Day may provide validation to those who have lost a baby through miscarriage, stillbirth, or infant death; and 12 Whereas, A public that is informed and educated about 13 14 miscarriage, stillbirth, and infant loss can better learn how to 15 respond with compassion to affected families. Professionals who come in contact with families who have suffered such losses, such 16 as physicians, clergy, emergency medical technicians, funeral 17 18 directors, police officers, public health nurses, educators, and 19 employers, can better serve families if they have better knowledge 20 of pregnancy and infant loss; and 21 Whereas, Recognizing Pregnancy and Infant Loss Remembrance Day 22 will provide the people of the state of Michigan with an 23 opportunity to increase their understanding of the great tragedy 24 involved in the deaths of unborn and newborn babies; and 25 Whereas, Pregnancy and Infant Loss Remembrance Day will 26 enable the people of Michigan to consider how, as individuals and 27 communities, they can meet the needs of bereaved mothers, fathers,

and family members, and work to prevent the causes of these deaths,
