 Align Land and Water Conservation Fund Authority with Projected Federal Revenues. The Governor and Senate included aligning Federal authority for Land and Water Conservation Fund grants with forecasted revenue. The increased spending ensures Michigan can fully use the Federal apportionment received as well as be competitive for grants. 	7,000,000	0
 Capital Outlay - Fish Hatchery Energy Efficiencies. The Governor and Senate included this initiative for capital outlay projects that incorporate renewable energy in the project. Priority projects include the installation of solar arrays and battery storage at State fish hatcheries. 	1,995,800	1,995,800
3. Improve State Park Experiences and Employee Recruitment and Retention. Governor recommended increase in 8.8 FTEs positions, hours, and wages to assist with employee recruitment and retention. A part of this goes to support a new sanitation contract for Interlochen State Park in order to comply with EGLE regulations. The Senate included the recommendation for increased funding, but not the increased FTEs.	1,486,400	0
4. CSB Technical. The Governor and Senate included a minimum wage increase, increases to the State Park and Recreation Authority for CAMIS Costs, increased State Park and Recreation Authority for Utility Costs, and State Park Improvement Bond Debt Servicing.	1,194,800	0

5.	Align Off-Road Vehicle Trail Improvement Fund Authority with Available Revenue. The Governor and Senate included increasing Off-Road Vehicle (ORV) Trail Improvement Fund spending authority to match available revenue. Under MCL 324.81119, available revenue would be distributed as follows: ORV trail maintenance and development grants (50%), ORV regulation enforcement (31.25%), grants to public agencies and nonprofits for ORV damage restoration (12.5%), additional regulation enforcement (3.125%), and administration (3.125%).	1,000,000	0
6.	Recreational Search Software. The Governor and Senate included one-time upgrades and ongoing maintenance costs for the Department's recreational search software.	320,000	0
7.	Shift Spending Authority for IT Positions and Align Minerals Management Appropriation with Organizational Structure. The Governor and Senate included this net-to-zero adjustment.	0	0
8.	Consolidate Michigan Wildlife Council Appropriations. The Governor recommended a net-to-zero adjustment combining the four existing Michigan Wildlife Council (MWC) lines into one line-item. The Senate did not include this recommendation.	0	0

Annual Restricted fund adjustments for this program are based on projected revenue estimates. The Governor and Senate included removing the FY 2020-21 capital outlay appropriations that were needed on a one-time basis for specific projects and other FY 2021-22 capital outlay appropriations not requested based on Department's projections. Boilerplate Changes from FY 2020-21 Year-to-Date:

- 1. **Reinstated Communication with the Legislature.** Governor removed a prohibition against taking disciplinary action against Department employees who communicate with the Legislature. The Senate retained this section. (Sec. 206)
- 2. **New GF/GP Lapses Report.** The Governor and Senate extended the reporting deadline, for the State Budget Office to deliver its report on GF/GP lapses in the previous year, to December 31. (Sec. 209)
- 3. **Deleted Contingency Funds Limits.** Governor added contingency funding limits to Federal Funds limited, Private Funds, and State Restricted Funds. The Senate removed this section. (Sec. 210)
- 4. **Deleted/Relocated Deprived and Depressed Communities.** Governor relocated existing language to Sec. 206. The Senate removed this section. (Sec. 215)
- Reinstated Quarterly Reporting on FTE and Remote Work Status. Governor removed language requiring the Department to provide the Senate and House quarterly reports on the FTE pay status and remote work levels. The Senate retained this section and updated the dates. (Sec. 216)
- 6. **Reinstated Expending on Work Projects.** Governor removed language that encouraged the Department to spend all existing work project authorization before using funding from part 1. The Senate retained this section. (Sec. 217)
- 7. **Reinstated** Interdepartmental Transfers. Governor removed language that allowed for a concurrent resolution, that if passed by the Legislature, would allow for intertransfer of funds from the Department. The Senate retained this section. (Sec. 218)
- 8. **Reinstated Report Retention.** Governor removed language requiring the Department to retain copies of all reports funded by the appropriation, and to comply with laws. The Senate retained this section. (Sec. 219)
- 9. **Deleted Annual Policy Change Report.** Governor removed the requirement that the Department make an annual report of all policy in the prior year. The Senate included the recommendation. (Sec. 220)
- 10. New State Restricted Funds Appropriated to Other Departments. The Governor and Senate added State Restricted Fund sources for each existing department receiving funds from the Department rather than a summarized total per department; the language also added funding for the Civil Service Commission. (Sec. 221)
- 11. **Reinstated Land Transactions Report.** Governor removed language requiring the Department to submit a report of all land transactions approved by the Natural Resources Commission in the previous fiscal year. The Senate retained this section. (Sec. 408)
- 12. **Deleted Portage Restaurant Report.** The Governor and Senate removed language requiring the Department to provide a report on the current and future use of the Portage Restaurant at Presque Isle State Harbor. (Sec. 409)
- 13. Reinstated Land Acquisition Report. Governor removed language requiring the Department to provide a comprehensive report on all lands acquired or in the process of being acquired since January 1, 2019. The Senate retained this section. (Sec 410)

- 14. Reinstated United States Department of Agriculture Wildlife Services. Governor removed a section encouraging the United States Department of Agriculture Wildlife Services to harvest all deer during targeted removal required under the Enhanced Wildlife Biosecurity Program. The Senate retained this section. (Sec. 506)
- 15. Reinstated Antlerless Deer License Fees and Discount. Governor added language that allows the Department to control the discount period for antlerless deer licenses, and to control the allocation of the remaining funds towards costs associated with testing deer for chronic wasting disease. The Senate retained the original language. (Sec. 507)
- 16. **Reinstated Stream Habitat Improvement Grants.** Governor removed a requirement directing Stream Habitat Improvement Grants allocations. The Senate retained this section. (Sec. 601)
- 17. **Reinstated** Non-water Quality Studies. Governor removed a requirement that the Department not impede the certification process for water control structures on Michigan waterways. The Senate retained this section. (Sec. 602)
- 18. **Reinstated** Fish Hatcheries Report. Governor removed language requiring the Department to produce an annual report detailing fish hatcheries performance. The Senate retained this section. (Sec. 603)
- 19. **New Expanded Reporting for Timber Harvesting.** The Senate included additional quarterly reporting requirements to the existing report on timber harvesting on public lands. (Sec. 802)
- 20. Reinstated Grants to County Law Enforcement Agencies. Governor removed a section directing the Department to provide snowmobile law enforcement grants to counties from appropriations for that purpose. The Senate retained this section. (Sec. 901)
- 21. **Reinstated** Marine Safety Grant Program Report. Governor removed a reporting requirement for watercraft registration revenues, expenditures, and grant distribution. The Senate retained this section. (Sec. 902)
- 22. **Deleted Deer Habitat Improvement Grants.** The Governor and Senate removed a section directing the Department to make grants available through the northern Lower Peninsula deer private land assistance network. (Sec. 902)
- 23. **Deleted Local Marine Patrol Grants.** The Governor and Senate removed a section directing the Department to make grants available to local sheriffs to enforce no-wake zones. (Sec. 1003)
