## FY 2022-23 Boilerplate Changes from FY 2021-22 Year-to-Date:

- 1. **Definitions**. The Governor removed the definition for "CRRSSA" and added a definition for "IIJA". (Infrastructure Investment and Jobs Act, 2021, Public Law 117-58.) The Senate kept the section as is. (Sec. 203)
- 2. **Outside Legal Services**. The Senate amended a section to allow for outside legal counsel in place of Attorney General representation. (Sec. 208)
- 3. **GF Fund Lapses**. The Governor amended a section moving the reporting date for GF/GP lapses by program from November 30 to December 31. The Senate concurred. (Sec. 209)
- 4. Removed Contingency Fund Authorization. The Governor amended a section by increasing Federal contingency fund authorization from \$40.0 million to \$200.0 million and State restricted fund contingency authorization from \$5.0 million to \$40.0 million. The Senate removed the section. (Sec. 210)
- 5. **Legacy Costs**. The Governor amended a section updating pension-related and health care legacy costs. The Senate concurred. (Sec. 214)
- 6. **Disciplinary Action**. The Governor removed a section prohibiting disciplinary action against employees that communicate with members of the Legislature. The Senate retained the section. (Sec. 215)
- 7. **FTE Reporting**. The Governor removed a section requiring a report on FTEs employed and working remotely. The Senate retained. (Sec. 216)
- 8. Exhausting Work Project Funding. The Governor removed a section requiring MDOT to exhaust work project authorization before spending appropriations. The Senate retained. (Sec. 217)
- 9. Intertransfer of Funds Following Administrative Board Action. The Governor removed a section allowing the Legislature to transfer funds by concurrent resolution in response to a transfer by the Administrative Board. The Senate retained. (Sec. 218)
- 10. **Record Retention**. The Governor removed a section requiring MDOT to retain copies of all reports funded from appropriations. The Senate retained. (Sec. 219)
- 11. **Policy** Reporting. The Governor removed a section requiring MDOT to report on all policy changes made to implement public acts. The Senate retained. (Sec. 220)
- 12. **Severance Pay Reporting**. The Governor removed a section requiring reporting on severance pay. The Senate retained. (Sec. 221)
- 13. Vaccine Status/Passports. The Governor removed a section prohibiting vaccine passports or vaccine requirements for employment. The Senate retained. (Sec. 222)
- 14. Use of Remanufactured Parts. The Governor removed a section requiring MDOT use remanufactured parts for its vehicle fleet. The Senate retained the section and amended to allow for the use of recycled parts. (Sec. 270)
- 15. **Debt Service Reporting**. The Governor removed a section estimating current year debt service and requiring reporting on debt service. The Senate retained and updated the section. (Sec. 302)
- 16. **Bond-Financed Project Signage**. The Governor removed a section requiring signage for bond-financed trunkline construction projects. The Senate retained. (Sec. 303)

- 17. **MDOT Property Leasing**. The Governor removed a section allowing for the leasing of space on public passenger transportation properties and direction for leasing revenue. The Senate retained. (Sec. 305)
- 18. Winter Maintenance Pilot Program. The Governor removed a section requiring MDOT to initiate a winter maintenance pilot program using agricultural additives. The Senate retained. (Sec. 308)
- 19. Local Bridge Bundling Initiative Report. The Governor removed a section requiring MDOT report on the use of CRRSSA funds for the local bridge bundling initiative. The Senate retained. (Sec. 311)
- 20. **State Infrastructure Bank Report**. The Governor removed a subsection requiring a report on the State infrastructure bank program. The Senate retained the subsection. (Sec. 313)
- 21. **Rest Area Signage**. The Governor removed a section requiring MDOT post signs at rest areas. The Senate retained. (Sec. 319)
- 22. Prompt Payment of Contractors and Subcontractors. The Governor removed a section requiring review of the payment process for contractors and requiring prompt payment of contractors and subcontractors. The Senate retained. (Sec. 353)
- 23. **Local Federal Aid Projects**. The Governor removed a section requiring MDOT review all local Federal aid project submittals within 120 days of receipt. The Senate retained. (Sec. 357)
- 24. **Groundbreaking Ceremonies**. The Governor removed a section prohibiting payments for groundbreaking ceremonies. The Senate retained. (Sec. 375)
- 25. Signage Study Ban. The Governor removed a section prohibiting MDOT from studying the relationship between signage and highway safety. The Senate retained. (Sec. 376)
- 26. Final Cost-Sharing. The Governor removed a section requiring MDOT submit final cost-sharing bills to local governments within two years of contract payment. The Senate retained. (Sec. 382)
- 27. Toll Credit Reporting. The Governor removed a section requiring MDOT report on the toll credit program. The Senate retained. (Sec. 386)
- 28. **Traffic Study Reporting**. The Governor removed a section requiring MDOT report on traffic studies. The Senate retained. (Sec. 387)
- 29. Long-Term Contract Reporting. The Governor removed a section requiring MDOT report on any contractor agreements over five years or \$5.0 million. The Senate retained. (Sec. 389)
- 30. Best Transit Practices. The Governor removed a section requiring MDOT employ best practices related to transit services. The Senate retained. (Sec. 393)
- 31. **Preserving Existing Roadways**. The Governor removed a section requiring MDOT and local agencies prioritize existing roadways. The Senate retained. (Sec. 394)
- 32. Not Included Permissive use of Road and Bridge Construction Funds for Highway Maintenance. The Governor added a new section allowing MDOT to use up to \$10.0 million of restricted funds appropriated for trunkline road and bridge construction on highway maintenance, as needed. The Senate did not include. (Sec. 395)
- 33. **Preventative Maintenance Prioritization**. The Governor removed a section requiring MDOT prioritize capital preventative maintenance. The Senate retained. (Sec. 399)
- 34. Local Bridge Fund Carry Forward. The Governor amended a section to allow lapsed local bridge funds to carry forward at the end of the fiscal year. The Senate retained the section as is. (Sec. 503)
- 35. **Warranties**. The Governor removed a section requiring MDOT evaluate and update existing warranty policies. The Senate retained. (Sec. 601)
- 36. **NEW Electric Vehicle Study**. The Senate added a section requiring the Department to study the impact on revenue resulting from the integration of electric vehicles on Michigan roadways. (Sec. 602)
- 37. Contract Incentives & Disincentives. The Governor removed a section requiring MDOT establish and report on contract incentives and disincentives for trunkline projects. The Senate retained. (Sec. 612)

- 38. Examination of Alternative Road Surface Materials. The Governor removed a section encouraging the Department to examine alternative road surface materials. The Senate retained. (Sec. 660)
- 39. **Rail Line Abandonment**. The Governor removed a section requiring MDOT report to the Legislature when a railroad company has filed to abandon a line. The Senate retained. (Sec. 703)
- 40. **NEW Freight Railroad and Development Grant Program**. The Senate added a section detailing the new freight rail grant program funded in part 1. (Sec. 710)
- 41. Farebox Goal. The Governor removed a section encouraging transit agencies achieve a farebox recovery rate of 6.0%. The Senate retained the section. (Sec. 720)
- 42. Prohibition on Rail Freight Development as Alternative to Energy Pipeline. The Governor removed a section prohibiting MDOT from developing a rail project that would support the cessation of pipeline operations across the Straits of Mackinac. The Senate retained. (Sec. 736)
- 43. **Meeting with Rail**. The Governor removed a section encouraging MDOT meet with the rail industry to provide information and funding opportunities. The Senate retained. (Sec. 752)
- 44. Marine Passenger Spending. The Governor removed a section directing the expenditure of the Marine Passenger appropriation. The Senate retained. (Sec. 753)
- 45. **NEW Public Transportation Spending Report.** The Senate added a section requiring the Department to report on prior fiscal year and current fiscal year spending and obligations on public transportation. (Sec. 754)
- 46. NEW Ann Arbor to Traverse City Passenger Rail. The Senate added a section with work project language for a passenger rail line between Ann Arbor and Traverse City. (Sec. 1001)
- 47. NEW Basic Marine Dock. The Senate added a section detailing one-time CTF spending on a marine dock. (Sec. 1002)
- 48. **NEW Local Rail Grade Separation Program**. The Senate added a section with work project language for local rail grade separation projects. (Sec. 1003)
- 49. **NEW Maritime and Port Facility Improvement Office**. The Senate added a section requiring the Department to establish a new office to provide grades for port facilities. (Sec. 1004)
- NEW Passenger Ferry. The Senate added a section identifying the recipient of a grant to purchase a new passenger ferry. (Sec. 1005)
