## SENATE SUBSTITUTE FOR HOUSE BILL NO. 4455

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending sections 11504, 11505, 11506, 11507, 11507a, and 11508 (MCL 324.11504, 324.11505, 324.11506, 324.11507, 324.11507a, and 324.11508), section 11504 as amended by 2020 PA 85, section 11505 as amended by 2018 PA 640, section 11506 as amended by 2018 PA 615, and section 11507a as amended by 2004 PA 39.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 11504. (1) "Health officer" means a full-time
- 2 administrative officer of a certified health department."Hauler"
- 3 means a person who owns or operates a managed materials
- 4 transporting unit.
- 5 (2) "Host community approval" means an agreement, resolution,

- 1 letter, or other document indicating that the governing body of the
- 2 municipality where the materials management facility is proposed to
- 3 be located has reviewed and approved the development of that
- 4 specific facility.
- 5 (3) "Household waste" means solid waste that is generated from
- 6 single-family dwellings. Household waste does not include
- 7 commercial waste, industrial waste, hazardous waste, or
- 8 construction and demolition waste.
- 9 (4) "Hydrogenation" means the chemical reaction between
- 10 molecular hydrogen and an element or compound, ordinarily in the
- 11 presence of a catalyst.
- 12 (5) (2) "Industrial waste" means solid waste that is generated
- 13 by manufacturing or industrial processes at an industrial site and
- 14 that is not a hazardous waste regulated under part 111.
- (6) (3) "Industrial waste landfill" means a landfill that is
- 16 used for the disposal of any of the following, as applicable:
- 17 (a) Industrial waste that has been characterized for hazard
- 18 and that has been determined to be nonhazardous under part 111.
- 19 (b) If the landfill is an existing disposal area, nonhazardous
- 20 solid waste that originates from an industrial site.
- 21 (7) (4) "Inert material" means any of the following:
- 22 (a) Rock.
- 23 (b) Trees, stumps, and other similar land-clearing debris, if
- 24 all of the following conditions are met:
- 25 (i) The debris is buried on the site of origin or another site,
- 26 with the approval of the owner of the site.
- 27 (ii) The debris is not buried in a wetland or floodplain.
- 28 (iii) The debris is placed at least 3 feet above the groundwater
- 29 table as observed at the time of placement.

- (iv) The placement of the debris does not violate federal,
   state, or local law or create a nuisance.
- 3 (c) Uncontaminated excavated soil or dredged sediment.
- 4 Excavated soil or dredged sediment is considered uncontaminated if
- 5 it does not contain more than de minimis amounts of solid waste and
- 6 1—any of the following applies:apply:
- 7 (i) The soil or sediment is not contaminated by a hazardous
- 8 substance as a result of human activity. Soil or sediment that
- 9 naturally contains elevated levels of hazardous substances above
- 10 unrestricted residential or any other part 201 generic soil cleanup
- 11 criteria is not considered contaminated for purposes of this
- 12 subdivision. A soil or sediment analysis is not required under this
- 13 subparagraph if, based on past land use, there is no reason to
- 14 believe that the soil or sediment is contaminated.
- 15 (ii) For any hazardous substance that could reasonably be
- 16 expected to be present as a result of past land use and human
- 17 activity, the soil or sediment does not exceed the background
- 18 concentration, as that term is defined in part 201.section 20101.
- 19 (iii) For any hazardous substance that could reasonably be
- 20 expected to be present as a result of past land use and human
- 21 activity, the soil or sediment falls below part 201 generic
- 22 residential soil direct contact cleanup criteria and hazardous
- 23 substances in leachate from the soil or sediment, using, at the
- 24 option of the generator, EPA method 1311, "Toxicity Characteristic
- 25 Leaching Procedure", EPA method 1312, "Synthetic Precipitation
- 26 Leaching Procedure", or any other leaching protocol approved by the
- 27 department, fall below part 201 generic residential health based
- 28 groundwater drinking water values or criteria, and the soil or
- 29 sediment would not cause a violation of any surface water quality

- 1 standard established under part 31 at the area of placement,
- 2 disposal, or use.
- 3 (d) Excavated soil from a site of environmental contamination,
- 4 corrective action, or response activity if the soil is not a listed
- 5 hazardous waste under part 111 and if hazardous substances in the
- 6 soil do not exceed generic soil cleanup criteria for unrestricted
- 7 residential use as defined in part 201 section 20101 or background
- 8 concentration as defined in part 201, section 20101, as applicable.
- 9 (e) Construction brick, masonry, pavement, or broken concrete
- 10 that is reused for fill, rip rap, slope stabilization, or other
- 11 construction, if all of the following conditions are met:
- 12 (i) The use of the material does not violate section 3108, part
- **13** 301, or part 303.
- 14 (ii) The material is not materially contaminated. Typical
- 15 surface oil staining on pavement and or concrete from driveways,
- 16 roadways, and or parking lots is not material contamination.
- 17 Material covered in whole or in part with <del>lead-based</del> paint that
- 18 contains more than 0.5% lead is materially contaminated.
- 19 (iii) The material does not include exposed reinforcing bars.
- 20 (f) Portland cement clinker produced by a cement kiln using
- 21 wood, fossil fuels, or solid waste as a fuel or feedstock, but not
- 22 including cement kiln dust generated in the process.
- 23 (g) Asphalt pavement or concrete pavement that meets all of
- 24 the following requirements:
- 25 (i) Has been removed from a public right-of-way.
- 26 (ii) Has been stockpiled or crushed for reuse as aggregate
- 27 material.
- 28 (iii) Does not include exposed reinforcement bars.
- 29 (h) Cuttings, drilling materials, and fluids used to drill or

- 1 complete a well installed pursuant to part 127 of the public health
- 2 code, 1978 PA 368, MCL 333.12701 to 333.12771, if the location of
- 3 the well is not a facility under part 201.
- 4 (i) Any material determined by the department under section
- 5 11553(5) or (6) to be an inert material, either for general use or
- 6 for a particular use.
- 7 (8) "Innovative technology facility" means a materials
- 8 management facility that converts solid waste into energy or a
- 9 usable product and that is not a materials recovery facility, a
- 10 composting facility, or an anaerobic digester.
- 11 (9) (5) "Insurance" means insurance that conforms to the
- 12 requirements of 40 CFR 258.74(d) and is provided by an insurer who
- 13 that has a certificate of authority from the director of insurance
- 14 and financial services to sell this line of coverage. An applicant
- 15 for an operating license or general permit shall submit evidence of
- 16 the required coverage by submitting both of the following to the
- 17 department:
- 18 (a) A certificate of insurance that uses wording approved by
- 19 the department.
- 20 (b) A certified true and complete copy of the insurance
- 21 policy.
- 22 (10) (6) "Landfill" means a disposal area that is a sanitary
- 23 landfill.type II landfill or type III landfill.
- 24 (11) "Landfill care fund" means a landfill care fund required
- 25 by section 11525d(2).
- 26 (12) "Landfill care fund bond" means a surety bond, an
- 27 irrevocable letter of credit, or a combination of these instruments
- 28 in favor of the department used to establish a landfill care fund.
- 29 (13) "Large", in reference to a composting facility, means a

- 1 composting facility to which both of the following apply:
- 2 (a) The site at any time contains more than 500 cubic yards of 3 compostable material.
- 4 (b) The site does not qualify as a small or medium composting 5 facility.
- 6 (14) (7)—"Lateral expansion" means a horizontal expansion of 7 the solid waste boundary of any of the following:
- 8 (a) A landfill, other than a coal ash landfill, if the
  9 expansion is beyond the limit established in a construction permit
  10 or engineering plans approved by the solid waste control agency
  11 department or a certified health department before January 11,
  12 1979.
- 13 (b) A coal ash landfill, if either of the following applies:
- (i) The expansion is beyond the limit established in aconstruction permit issued after December 28, 2018.
- 16 (ii) The expansion is made after October 19, 2015, and is a 17 horizontal expansion of the outermost boundary, as defined by a 18 construction certification or operating license, of an existing 19 coal ash landfill.
- (c) A coal ash impoundment, if the expansion is beyond the
  limit established in a construction permit or the horizontal limits
  of coal ash in place on or before October 14, 2015.
- 23 (15) (8)—"Letter of credit" means an irrevocable letter of
  24 credit that complies with 40 CFR 258.74(c).
- 25 (16) "License" means an operating license.
- (17) (9)—"Lime kiln dust" means particulate matter collected
   in air emission control devices serving lime kilns.
- 28 (18) "Local health officer" means a local health officer as 29 defined in section 1105 of the public health code, 1978 PA 368, MCL

- 1 333.1105, to which the department delegates certain duties under
- 2 part 115.
- 3 (19) (10) "Low-hazard industrial waste" means industrial
- 4 material that has a low potential for groundwater contamination
- 5 when managed in accordance compliance with this part 115. The All
- 6 of the following materials are low-hazard industrial wastes:
- 7 (a) Coal ash and wood ash.
- 8 (b) Cement kiln dust.
- 9 (c) Pulp and paper mill material.
- 10 (d) Scrap wood.
- 11 (e) Sludge from the treatment and conditioning of water for
- 12 domestic use.
- 13 (f) Residue from the thermal treatment of petroleum
- 14 contaminated soil, media, or debris.
- 15 (g) Sludge from the treatment and conditioning of water from a
- 16 community water supply.
- 17 (h) Foundry sand.
- 18 (i) Mixed wood ash, scrap wood ash, and pulp and paper mill
- **19** ash.
- 20 (j) Street cleanings.
- 21 (k) Asphalt shingles.
- 22 (1) New construction or production scrap drywall.
- 23 (m) Chipped or shredded tires.
- (n) Copper slag.
- 25 (o) Copper stamp sands.
- 26 (p) Dredge material from nonremedial activities.
- 27 (q) Flue gas desulfurization material.
- (r) Dewatered grinding slurry generated from public
- 29 transportation agency road projects.

- 1 (s) Any material determined by the department under section
- 2 11553(7) to be a low-hazard industrial waste.
- 3 (20) (11)—"Low-hazard-potential coal ash impoundment" means a
- 4 coal ash impoundment that is a diked surface impoundment, the
- 5 failure or misoperation mis-operation of which is expected to
- 6 result in no loss of human life and low economic or environmental
- 7 losses principally limited to the impoundment owner's property.
- 8 (21) "MAC" means the Michigan Administrative Code.
- 9 (22) "Managed material" means solid waste, diverted waste, or
- 10 recyclable material. Managed material does not include a material
- 11 or product that contains iron, steel, or nonferrous metals and that
- 12 is directed to or received by a scrap processor as defined in
- 13 section 3 of the scrap metal regulatory act, 2008 PA 429, MCL
- 14 445.423, or by a reuser of these metals.
- 15 (23) "Managed materials transporting unit" means a container,
- 16 which may be an integral part of a truck or other piece of
- 17 equipment, used for the transportation of managed materials.
- 18 (24) "Materials management facility" or, unless the context
- 19 implies a different meaning, "facility" means any of the following,
- 20 subject to subsection (25):
- 21 (a) A disposal area.
- 22 (b) A materials utilization facility.
- 23 (c) A waste diversion center.
- 24 (25) Materials management facility or facility does not
- 25 include a person, utilizing machinery and equipment and operating
- 26 from a fixed location, whose principal business is the processing
- 27 and manufacturing of iron, steel, or nonferrous metals into
- 28 prepared grades of products suitable for consumption, reuse, or
- 29 additional processing.

- 1 (26) "Materials management goals" means goals identified in
- 2 the MMP pursuant to section 11578(1)(a).
- 3 (27) "Materials management plan" or "MMP" means a plan
- 4 required under section 11571.
- 5 (28) "Materials recovery facility", subject to subsection
- 6 (29), means a facility that meets both of the following
- 7 requirements:
- 8 (a) Receives primarily source separated material and sorts,
- 9 bales, or processes the source separated material for reuse,
- 10 recycling, or utilization as a raw material or new product.
- 11 (b) On an annual basis, does not receive an amount of solid
- 12 waste equal to or more than 15% of the total weight of material
- 13 received by the facility unless the materials recovery facility is
- 14 making reasonable effort and has an education program to reduce the
- 15 amount of solid waste. Material disposed of as a result of
- 16 recycling market fluctuations is not included in the 15%
- 17 calculation.
- 18 (29) Materials recovery facility does not include any of the
- 19 following:
- 20 (a) A retail, commercial, or industrial establishment that
- 21 bales for off-site shipment managed material that it generates.
- 22 (b) A retail establishment that collects returnable beverage
- 23 containers under 1976 IL 1, MCL 445.571 to 445.576.
- 24 (c) A beverage distributor, or its agent, that manages
- 25 returnable beverage containers under 1976 IL 1, MCL 445.571 to
- 26 445.576.
- 27 (d) A facility or area used for reuse, recycling, or storage
- 28 of recyclable materials solely generated by an industrial facility.
- 29 (e) A facility that is an end user or secondary processor and

- 1 that uses as fuel or otherwise, processes, or stores material
- 2 generated by industrial facilities.
- 3 (f) A facility that primarily manages material that was
- 4 previously sorted or processed.
- 5 (g) An anaerobic digester.
- 6 (30) "Materials utilization" means recycling, composting, or
- 7 converting material into energy rather than disposing of the
- 8 material.
- 9 (31) "Materials utilization facility" means a facility that is
- 10 any of the following:
- 11 (a) A materials recovery facility.
- 12 (b) A composting facility.
- 13 (c) An anaerobic digester, except at a manufacturing facility
- 14 that generates its own feedstock.
- 15 (d) An innovative technology facility.
- 16 (32) (12) "Medical waste" means that term as it is defined in
- 17 section 13805 of the public health code, 1978 PA 368, MCL
- **18** 333.13805.
- 19 (33) "Medium", in reference to a composting facility, means a
- 20 composting facility to which all of the following apply:
- 21 (a) The site at any time contains more than 500 cubic yards of
- 22 compostable material.
- 23 (b) The site does not qualify as a small composting facility.
- 24 (c) The site does not at any time contain more than 10,000
- 25 cubic yards of compostable material.
- 26 (d) The site does not at any time contain more than 10% by
- 27 volume of class 1 compostable material other than yard waste.
- (e) Unless approved by the department, the site does not at
- 29 any time on any acre contain more than 5,000 cubic yards of

- compostable material, finished product, compost additives, or
  screening rejects.
- 3 (34) (13) "Mixed wood ash" means the material recovered from
  4 air pollution control systems for, or the noncombusted residue
  5 remaining after, the combustion of any combination of wood, scrap
  6 wood, railroad ties, or tires, if railroad ties composed less than
  7 35% by weight of the total combusted material and tires composed
  8 less than 10% by weight of the total combusted material.
- 9 (35) "Municipal solid waste" means household waste, commercial
  10 waste, waste generated by other nonindustrial locations, waste that
  11 has characteristics similar to that generated at a household or
  12 commercial business, or any combination thereof. Municipal solid
  13 waste does not include municipal wastewater treatment sludges,
  14 industrial process wastes, automobile bodies, combustion ash, or
  15 construction and demolition debris.
- 16 (36) (14) "Municipal solid waste incinerator" means an
  17 incinerator that is owned or operated by any person, and that meets
  18 all of the following requirements:
  - (a) The incinerator receives solid waste from off site and burns only household—waste from single—single-family and multiple multifamily dwellings, hotels, motels, and other residential sources, or such household—waste together with solid waste from commercial, institutional, municipal, county, or industrial sources that, if disposed of, would not be required to be placed in a disposal facility licensed under part 111.
- (b) The incinerator has established contractual requirements or other notification or inspection procedures sufficient to ensure that the incinerator receives and burns only waste referred to in subdivision (a).

- (c) The incinerator meets the requirements of this part and
   the rules promulgated under this part 115.
- 3 (d) The incinerator is not an industrial furnace as defined in 40 CFR 260.10.
- (e) The incinerator is not an incinerator that receives andburns only medical waste or only waste produced at 1 or morehospitals.
- 8 (37) (15) "Municipal solid waste incinerator ash" means the
  9 substances remaining after combustion in a municipal solid waste
  10 incinerator.
- 11 (38) "Municipal solid waste recycling rate" means the amount
  12 of municipal solid waste recycled or composted, divided by the
  13 amount of municipal solid waste recycled, composted, landfilled, or
  14 incinerated.
- 15 (39) (16)—"New coal ash impoundment" means a coal ash
  16 impoundment that first receives coal ash after the effective date
  17 of the amendatory act that added this subsection.December 28, 2018.
- 18 (40) (17)—"New disposal area" means a disposal area that
  19 requires a construction permit under this part and includes all of
  20 the following:
- (a) A disposal area, other than an existing disposal area,that is proposed for construction.
- (b) For a landfill, a lateral expansion, vertical expansion,
  or other expansion that results in an increase in the landfill's
  design capacity.
- (c) A new coal ash impoundment, or a lateral expansion of a
  coal ash impoundment beyond the placement of waste as of October
  14, 2015.
- 29 (d) For a disposal area other than <del>landfills</del> a landfill or

- 1 coal ash impoundments, impoundment, an enlargement in capacity
- 2 beyond that indicated in the construction permit or in engineering
- 3 plans approved before January 11, 1979.
- 4 (e) For any existing disposal area, an alteration of the
- 5 disposal area to a different disposal area type than had been was
- 6 specified in the previous construction permit application or in
- 7 engineering plans that were approved by the director or his or her
- 8 designee before January 11, 1979.
- 9 (41) (18) "Nonresidential property" means property not used or
- intended to be used for any of the following:
- 11 (a) A child day care center.
- 12 (b) An elementary school.
- 13 (c) An elder care and assisted living center.
- 14 (d) A nursing home.
- 15 (e) A single-family or multifamily dwelling unless the
- 16 dwelling is part of a mixed use development and all dwelling units
- 17 and associated outdoor residential use areas are located above the
- 18 ground floor.
- 19 (19) "Part 115 rules" means R 299.4101 to R 299.4922 of the
- 20 Michigan Administrative Code including any amendments to or
- 21 replacements of those rules.
- 22 (42) "Operate" includes, but is not limited to, conducting,
- 23 managing, and maintaining.
- 24 (43) "Part 115" means this part and rules promulgated under
- 25 this part.
- 26 (44) (20) "Perpetual care fund" means a trust or fund, escrow
- 27 account, or perpetual care fund bond provided for in section
- 28  $\frac{11525}{11525}$ . required by section 11525(2).
- 29 (45) (21) "Perpetual care fund bond" means a surety bond, an

- 1 irrevocable letter of credit, or a combination of these instruments
- 2 in favor of and on a form approved by the department by which used
- 3 to establish a perpetual care fund. is established.
- 4 (46) "Planning area" means the geographic area to which a 5 materials management plan applies.
- 6 (47) "Planning committee" means a committee appointed under 7 section 11572.
- 8 (48) "Post-use polymer" means a plastic to which all of the 9 following apply:
- 10 (a) It has been source separated.
- 11 (b) It has been sorted from solid waste and other regulated 12 waste but may contain residual amounts of solid waste.
- 13 (c) It is not mixed with solid waste or hazardous waste on-14 site or during conversion at a chemical recycling facility.
- 15 (d) It is converted at a chemical recycling facility or,
  16 subject to applicable speculative accumulation time frames, stored
  17 at a chemical recycling facility before conversion.
- 18 (49) "Preexisting unit" means a landfill unit that is or was
  19 licensed under part 115 but has not received waste after October 9,
  20 1993.
- (50) (22)—"Pulp and paper mill ash" means the material recovered from air pollution control systems for, or the noncombusted residue remaining after, the combustion of any combination of coal, wood, pulp and paper mill material, wood or biomass fuel pellets, scrap wood, railroad ties, or tires, from in a boiler, power plant, or furnace at a pulp and paper mill, if railroad ties composed less than 35% by weight of the total

combusted material and tires composed less than 10% by weight of

29 the total combusted material.

- (51) (23)—"Pulp and paper mill material" means all of the
   following materials if generated at a facility that produces pulp
- 3 or paper:
- 4 (a) Wastewater treatment sludge, including wood fibers,
- 5 minerals, and microbial biomass.
- 6 (b) Rejects from screens, cleaners, and mills.
- 7 (c) Bark, wood fiber, and chips.
- 8 (d) Scrap paper.
- 9 (e) Causticizing residues, including lime mud and grit and10 green liquor dregs.
- (f) Any material that the department determines has
  characteristics that are similar to any of the materials listed in
  subdivisions (a) to (e).
- 14 (52) "Pyrolysis" means a manufacturing process in which post15 use polymers are heated in the absence of oxygen until melted and
  16 thermally decomposed, and then are cooled, condensed, and converted
  17 into valuable raw materials and intermediate and final products,
  18 including, but not limited to, plastic monomers, chemicals, waxes,
  19 lubricants, and plastic and chemical feedstocks that have economic
  20 utility as raw materials and products.
- Sec. 11505. (1) "RDDP" means a research, development, and demonstration project for a new or existing type II landfill unit or for a lateral expansion of a type II landfill unit.
- 24 (2) (1)—"Recyclable materials" means source separated
  25 materials, site separated materials, high grade paper, glass,
  26 metal, plastic, aluminum, newspaper, corrugated plastics, paper
  27 products, wood, rubber, textiles, food waste, yard clippings, and
  28 other materials that may be recycled or composted.
  - (3) "Recycling" means any process applied to materials that

- are no longer being used and that would have otherwise been disposed as waste, for the purpose of converting the materials into raw materials or intermediate or new products.
- 4 (4) (2)—"Regional solid waste management—planning agency"
  5 means the regional solid waste planning agency designated by the
  6 governor pursuant to section 4006 of subtitle D of the solid waste
  7 disposal act, 42 USC 6946.
  - (5) (3)—"Resource recovery facility" means machinery, equipment, structures, or any parts or accessories of machinery, equipment, or structures, installed or acquired for the primary purpose of recovering materials or energy from the waste stream.
- 12 (6) (4)—"Response activity" means an activity that is
  13 necessary to protect the environment, natural resources, or the
  14 public health, safety, or welfare, or the environment, and
  15 includes, but is not limited to, evaluation, cleanup, removal,
  16 containment, isolation, treatment, monitoring, maintenance,
  17 replacement of water supplies, and temporary relocation of people.
  - (7) "Restricted use compost" means compost that is produced from class 2 compostable material, including any combination of class 1 compostable material and class 2 compostable material, that is not approved as inert under section 11553(5).
- 22 (8) "Reuse" means to remanufacture, use again, use in a 23 different manner, or use after reclamation.
- 24 (9) (5)—"Rubbish" means nonputrescible solid waste, excluding
  25 ashes, consisting of both combustible and noncombustible waste,
  26 including paper, cardboard, metal containers, yard elippings,
  27 waste, wood, glass, bedding, crockery, demolished building
  28 materials, or litter of any kind that may be a detriment to the
  29 environment, natural resources, or the public health, and safety,

- 2 (10) (6) "Salvaging" means the lawful and controlled removal
- **3** of reusable materials from solid waste.
- 4 (7) "Sanitary landfill" means a type of disposal area
- 5 consisting of 1 or more landfill units and the active work areas

- (7) "Stamp sands" means finely grained crushed rock resultingfrom mining, milling, or smelting of copper ore and includes native

- 15 supply" mean those terms, respectively, as described in R 325.10502

- 17 (11) "Type II landfill" means a landfill that receives

The department may rescind certification upon request of the certified health department or after reasonable notice and hearing if the department finds that a certified health department is not performing the program as required. A person shall not operate a materials management facility unless all of the following requirements are met:
  - (a) The owner or operator has complied with any applicable requirement of part 115 to notify the department, register with the department, obtain an approval from the department under a general permit, or obtain a construction permit and operating license from the department.
