## **HOUSE BILL NO. 6109**

May 18, 2022, Introduced by Rep. Brann and referred to the Committee on Regulatory Reform.

A bill to amend 1978 PA 368, entitled "Public health code,"

by amending section 12606a (MCL 333.12606a), as added by 2009 PA 188.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 12606a. (1) A cigar bar in existence on the effective
 date of this section May 1, 2010 that meets all of the requirements

 $oldsymbol{3}$  of this section is exempt from the smoking prohibition of section

 $oldsymbol{4}$  12603 and may allow smoking on its premises. To qualify for the

 ${f 5}$  exemption under this section, the person  ${f who}$  that owns or operates

- 1 a cigar bar shall file an affidavit with the department on or
- 2 before the expiration of 30 days after the effective date of this
- 3 section May 1, 2010 and on January 31 of each year after the
- 4 effective date of this section. May 1, 2010. The affidavit shall
- 5 must be signed by the owner or operator of the cigar bar and shall
- 6 must certify that the cigar bar was in existence on the effective

- 14 the first affidavit is filed under this subsection, the cigar bar
- 15 generates 10% or more of its total gross annual income from the on-
- 16 site sale of cigars and the rental of on-site humidors.
- 17 (c) The cigar bar is located on premises that are physically
- 18 separated from any areas of the same or adjacent establishment in
- 19 which smoking is prohibited under this part or part 129 and where
- 20 smoke does not infiltrate into those nonsmoking areas. As used in
- 21 this subdivision, "physically separated" means an area that is
- 22 enclosed on all sides by any combination of solid walls, windows,
- 23 or doors that extend from the floor to ceiling.
- 24 (d) The cigar bar has installed on its premises an on-site
- 25 humidor.
- (e) The cigar bar prohibits entry to a person under the age of
- 27 18—21 during the time the cigar bar is open for business.
- 28 (f) The cigar bar allows only the smoking of cigars on the
- 29 premises that retail for over \$1.00 per cigar.

- (g) The cigar bar prohibits the smoking of all other tobacco
   products.
- 3 (2) A tobacco specialty retail store in existence on the 4 effective date of this section May 1, 2010 that meets all of the 5 requirements of this section is exempt from the smoking prohibition 6 of section 12603 and may allow smoking on its premises. To qualify 7 for the exemption under this section, the person who owns or 8 operates a tobacco specialty retail store shall file an affidavit 9 with the department on or before the expiration of 30 days after 10 the effective date of this section May 1, 2010 and on January 31 of 11 each year after the effective date of this section. May 1, 2010. 12 The affidavit shall must be signed by the owner or operator of the tobacco specialty retail store and shall must certify that the 13 14 tobacco specialty retail store was in existence on the effective 15 date of this section May 1, 2010 and that it meets all of the

  19 specialty retail store generated 75% or more of its total gross
  20 annual income from the on-site sale of tobacco products and smoking

- (b) For each calendar year after the calendar year in which the first affidavit is filed under this subsection, the tobacco specialty retail store generated 75% or more of its total gross annual income from the on-site sale of tobacco products and smoking paraphernalia.
- (c) The tobacco specialty retail store is located on premises
  that are physically separated from any areas of the same or
  adjacent establishments in which smoking is prohibited under this

- 1 part or part 129 and where smoke does not infiltrate into those
- 2 nonsmoking areas. As used in this subdivision, "physically
- 3 separated" means an area that is enclosed on all sides by any
- 4 combination of solid walls, windows, or doors that extend from the
- 5 floor to ceiling.
- 6 (d) The tobacco specialty retail store prohibits entry to a
- 7 person under the age of 18-21 during the time the tobacco specialty
- 8 retail store is open for business.
- 9 (3) The department may request additional information from a
- 10 cigar bar or tobacco specialty retail store to verify that the
- 11 cigar bar or tobacco specialty retail store meets the requirements
- 12 of this section. A cigar bar or tobacco specialty retail store
- 13 shall comply with requests from the department under this section.
- 14 (4) Except as otherwise provided in this subsection, a cigar
- 15 bar or tobacco specialty retail store that does not meet the
- 16 requirements of this section or violates this section is not exempt
- 17 from the smoking prohibition of section 12603 and shall immediately
- 18 prohibit smoking on its premises. A cigar bar or tobacco specialty
- 19 retail store that meets all of the requirements of this section
- 20 other than filing the affidavit as required under subsection (1) or
- 21 (2), retains its exemption and may continue to allow smoking during
- 22 the period beginning on the date the affidavit is due and ending on
- 23 the expiration of 21 days after that date. However, if the
- 24 affidavit remains unfiled after the 21-day grace period, the cigar
- 25 bar or tobacco specialty retail store is not exempt from the
- 26 smoking prohibition of section 12603 and shall immediately prohibit
- 27 smoking on its premises. A cigar bar or tobacco specialty retail
- 28 store that loses its exemption under this subsection is not exempt
- 29 from the smoking prohibition of section 12603, shall immediately

- 1 prohibit smoking on its premises, and may only again qualify for
- 2 the exemption under this section by filing an affidavit and meeting
- 3 all of the requirements of subsection (1) or (2), as applicable.
- 4 Enacting section 1. This amendatory act does not take effect
